Presented by Yugoslavia

At the request of the delegation of Yugoslavia, the secretariat transmits herewith a list of products¹ in respect of which the Government of Yugoslavia is in a position to consider offering concessions in the context of the trade negotiations among developing countries.

The text of the letter accompanying the list of products is reproduced below.

Further to the global offer presented by my Government in the context of the trade negotiations among developing countries (document TN(LDC)N/6 of 26 November 1970), I have the honour to forward to you herewith a list of the products in respect of which, taking into account the number and the character of the bilateral consultations held to date, the Government of the Socialist Federal Republic of Yugoslavia is contemplating granting concessions to the other countries participating in these trade negotiations.

I should add that this list is only preliminary and that it could be the subject of revisions or additions in the light of reactions and requests received subsequently.
