##### ARGENTINA

EXPLANATORY NOTES

1. Type of restrictions:

P: Temporary suspension of imports

By Decree No. 2118 of 30 June 1972, the Argentine Government ordered the temporary suspension, for a period of one year, of imports of goods which, because of their nature or intended utilization, were not essential for the country's economic development.

By Act No. 19,242 of 17 September 1971, the Government extended this measure on a general and temporary basis, until 31 October 1971, to all imports.

Act No. 19,326, which came into force on 1 November 1971, limited the suspension to purchases made abroad by the State. This measure may be abrogated by the Executive when circumstances permit.

Under Decree No. 2867, of 15 May 1972, the temporary suspension imposed under Decree No. 2118/71, which was to have lapsed on 30 June 1972, was extended for a further year and certain goods were added to the list set forth in that Decree.

The Decree of 15 May 1972 - which is not applicable to products that have been the subject of negotiations within the Latin American Free Trade Association (LAFTA) - further provides that in cases where the measure affects products required for industrial development, or raw materials or intermediate products intended for the production of exports, the undertakings or sectors concerned may request the Ministry of Industry and Mining to reconsider the matter.

For their part, the Ministry of Industry and Mining, the Ministry of Trade and the Ministry of Finance may propose to the Executive, by means of joint resolutions, whatever amendments they may consider necessary in cases where the measures taken would affect products needed to meet domestic consumption requirements.
