- (ii) France, indication of the date-limit for consumption or the date of manufacture has been obligatory since 1 October 1973;
- (iii) Italy, the ingredients have to be indicated in Italian. The net weight (peso nettissimo) also has to be indicated;
- (iv) Netherlands, description of the product has to be given in Dutch;
- (v) United Kingdom, the labelling regulations are strict. Indication of the date of manufacture has been obligatory since 1 January 1975.
