Submission by Sri Lanka, Bangladesh, Colombia
Cuba, Egypt, India, Nigeria, Pakistan.

The following contains an initial list of tropical products of export interest to the submitting countries. The list is addressed to the eleven developed countries covered by the existing background material (which includes the EEC taken as one of them). The submitting countries intend to seek the fullest trade liberalization of tariff and all non-tariff measures affecting exports of these products, including in their semi-processed and processed forms in the framework of negotiations on tropical products. The listing of products is provided according to the Harmonized System code numbers, provisionally identified for the tropical products included therein. The submitting countries reserve their right to revise this list, and to add or withdraw any products before or during the negotiations.
