

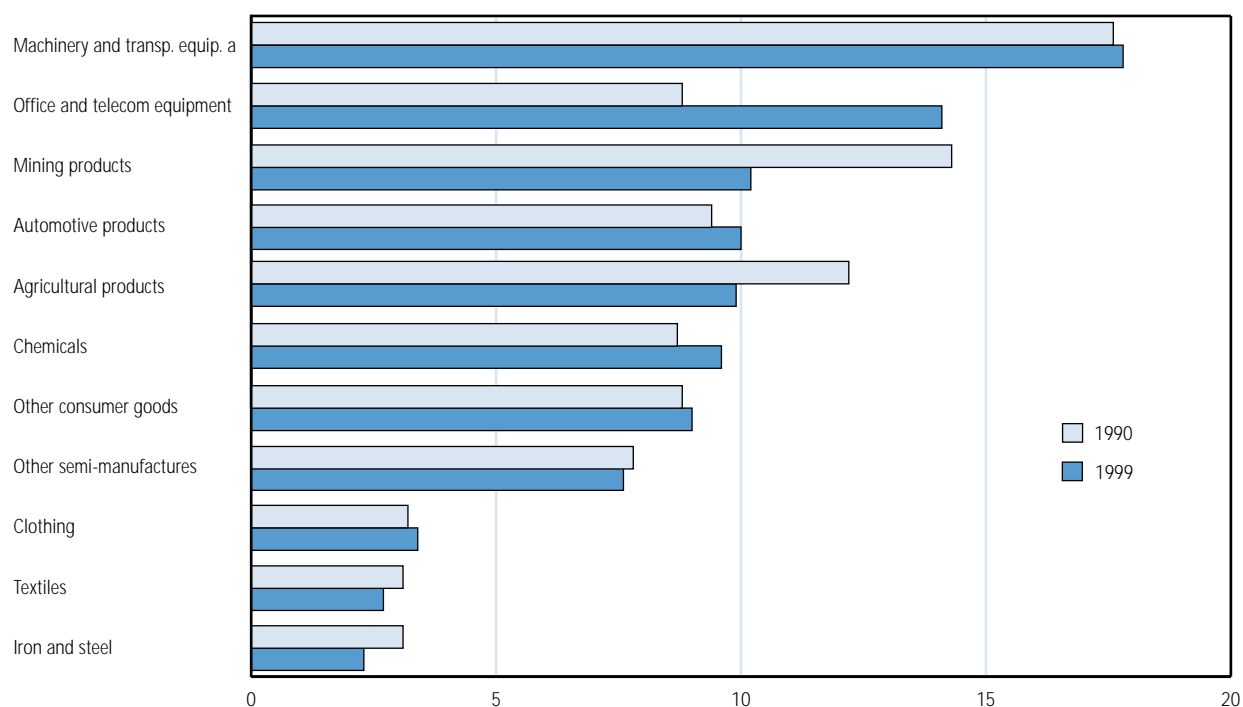

(Percentage)

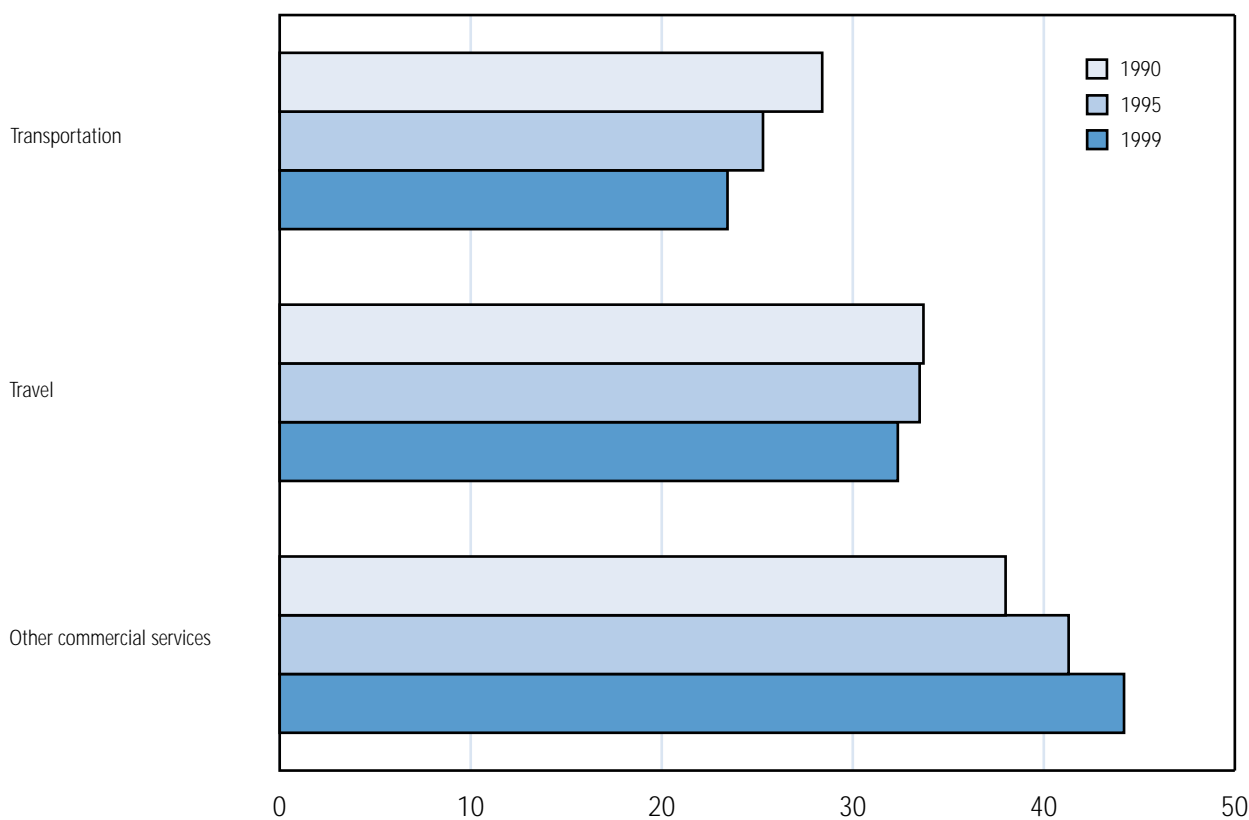

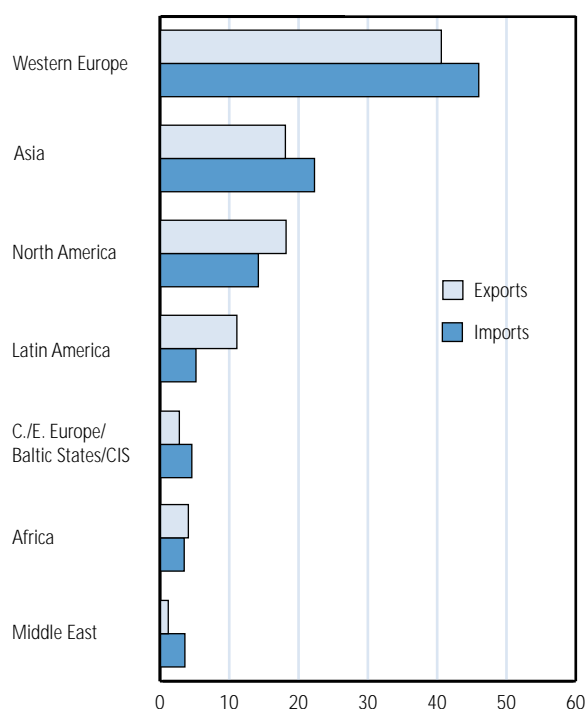

(Percentage)

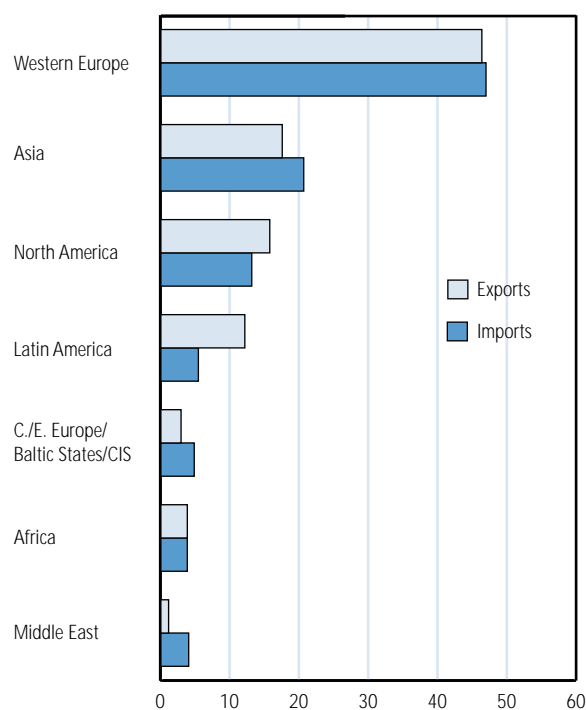

(Percentage)

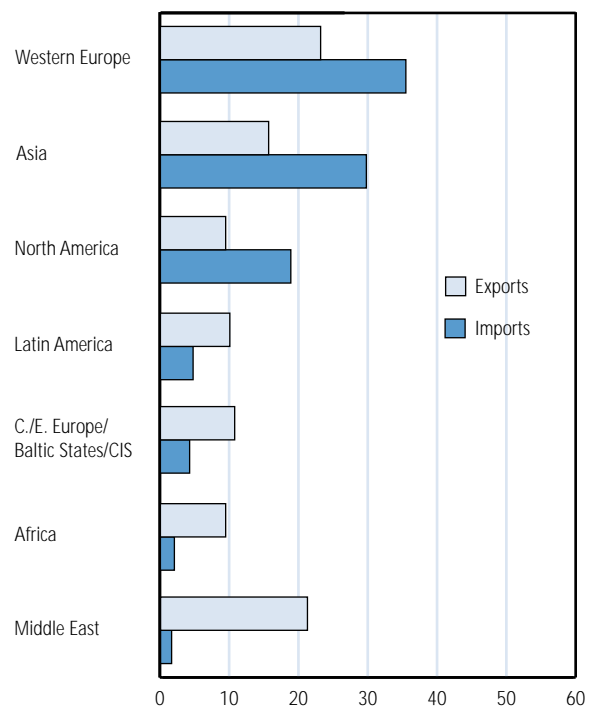

(Percentage)

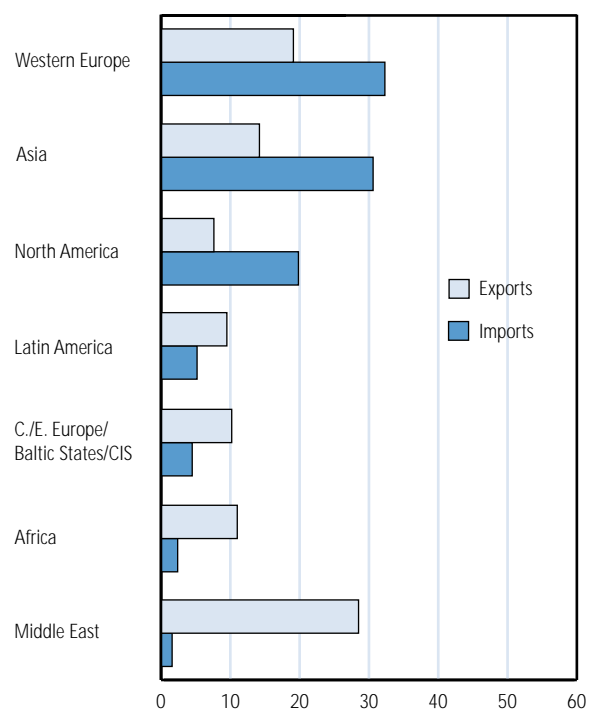

(Percentage)

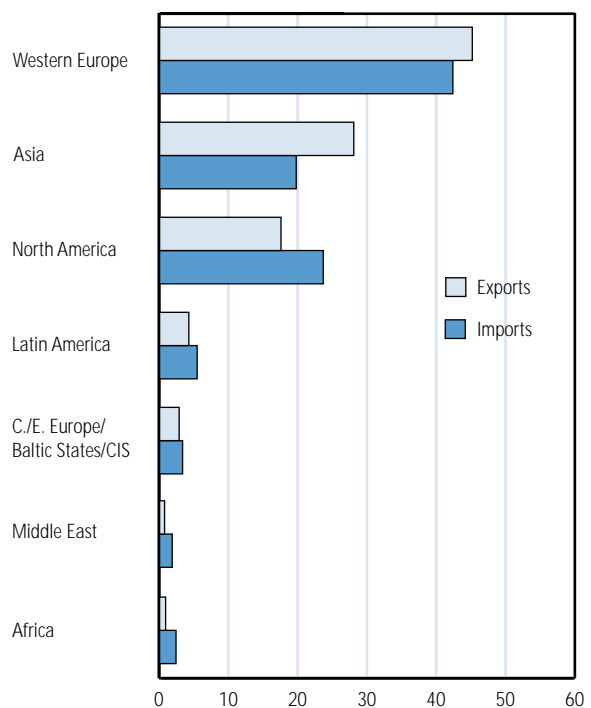

(Percentage)

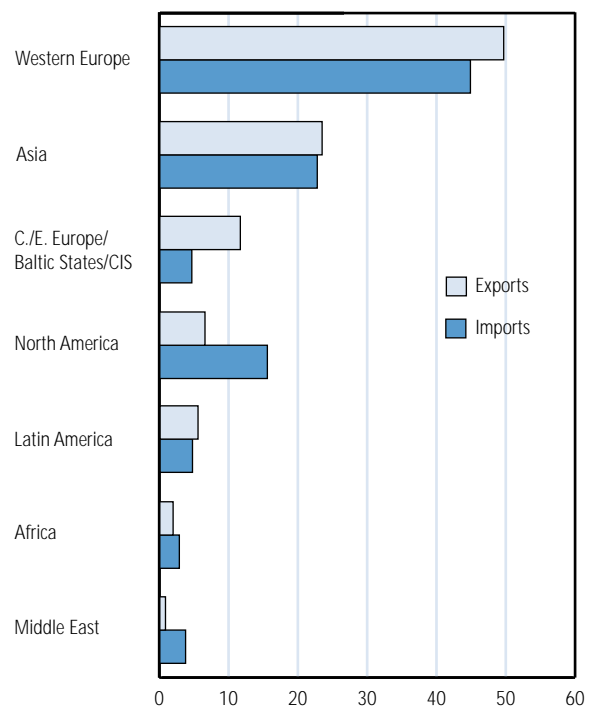

(Percentage)

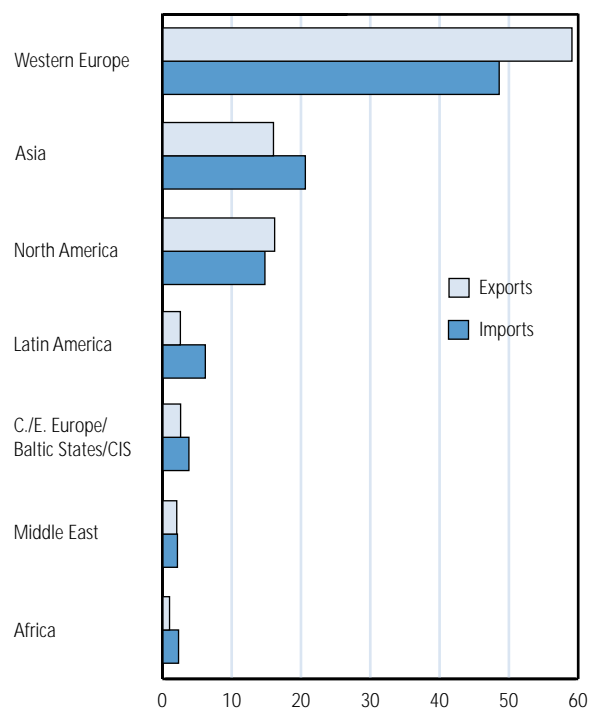

(Percentage)

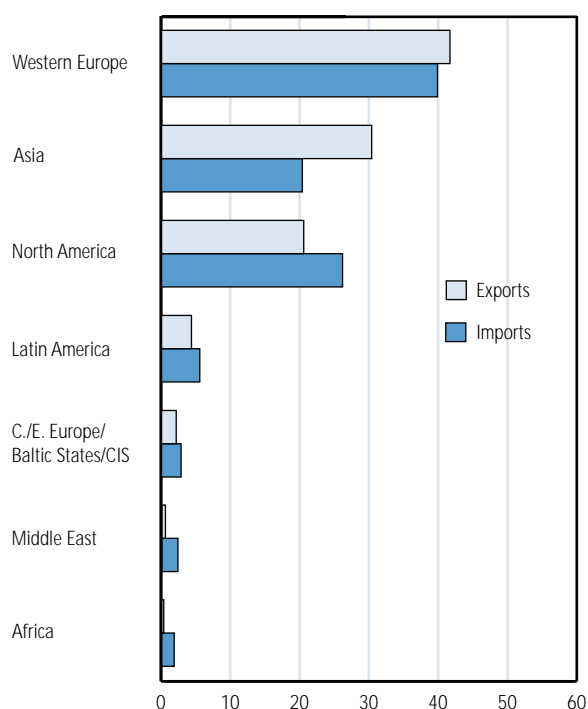

(Percentage)

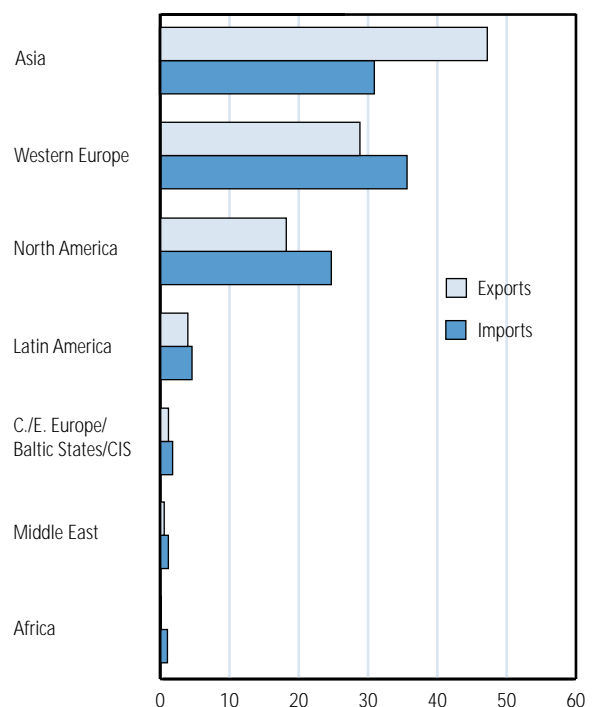

(Percentage)

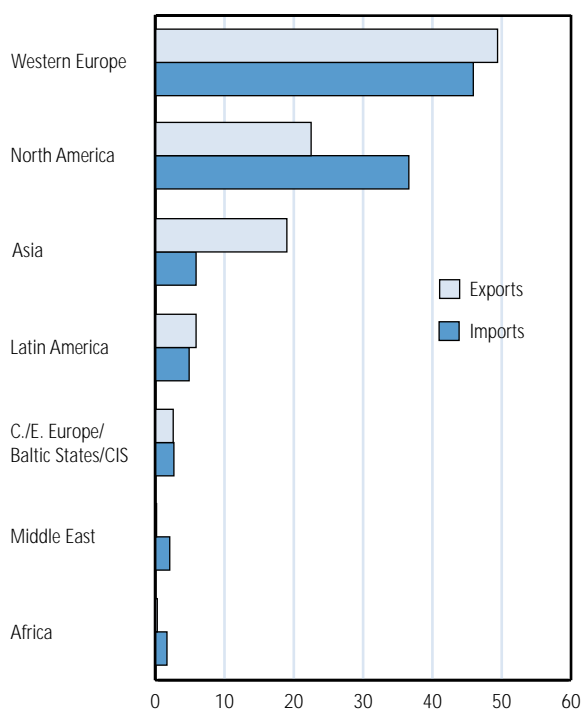

(Percentage)

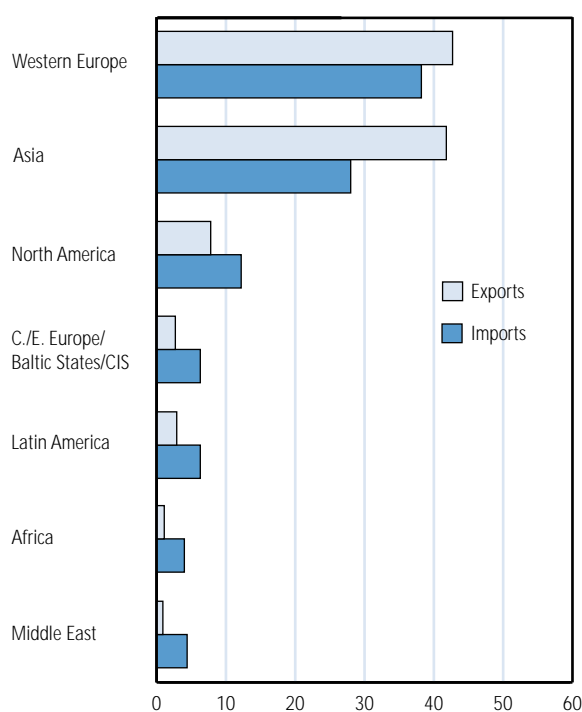

(Percentage)

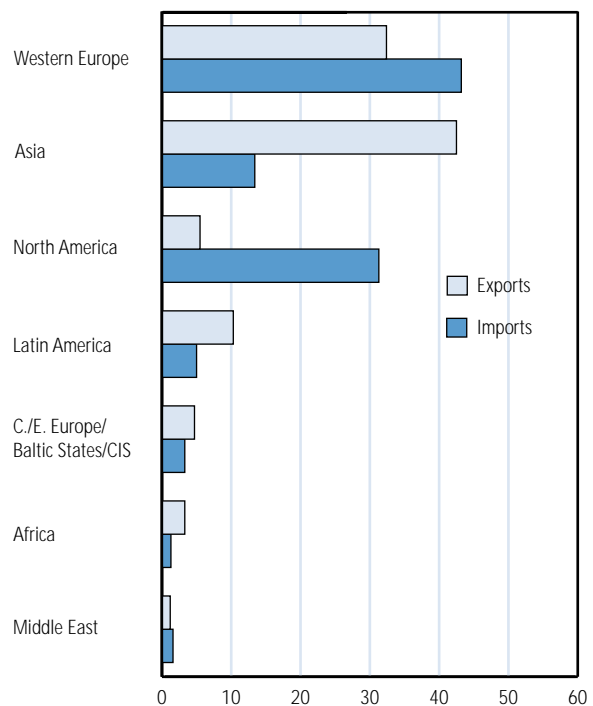

(Billion dollars and percentage)

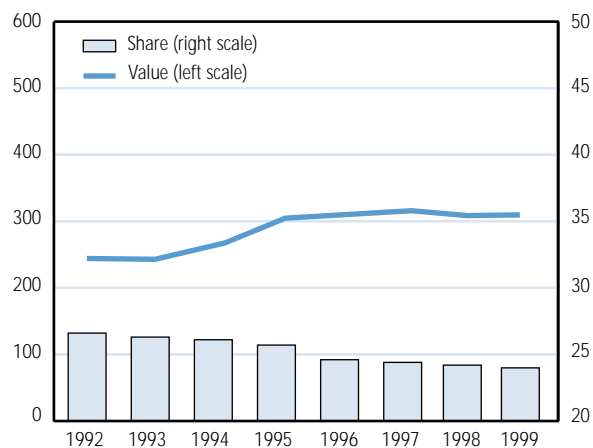

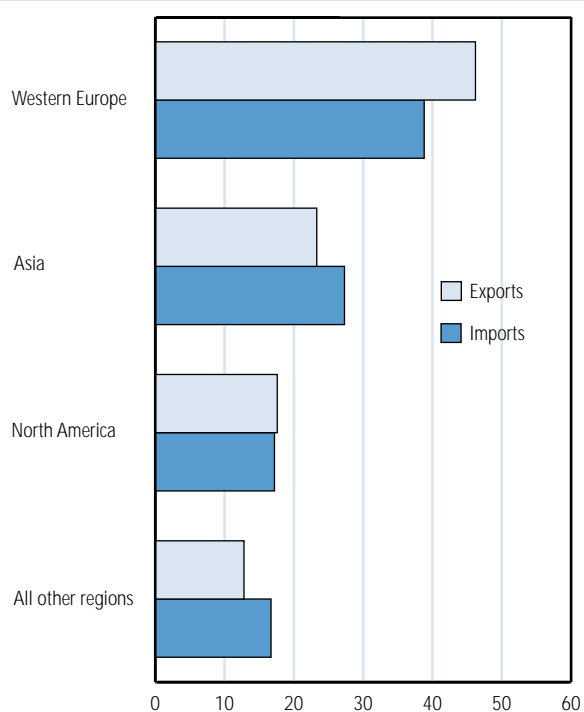

(Billion dollars and percentage)

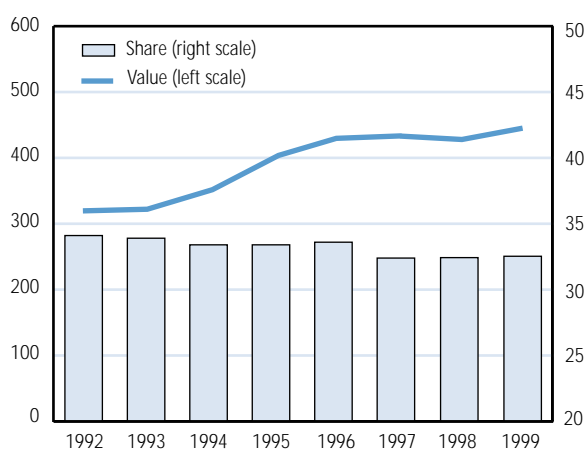

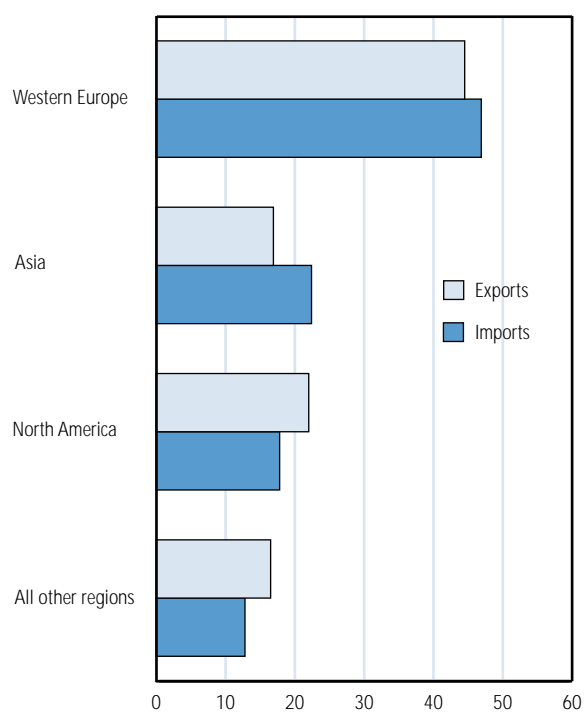

(Billion dollars and percentage)

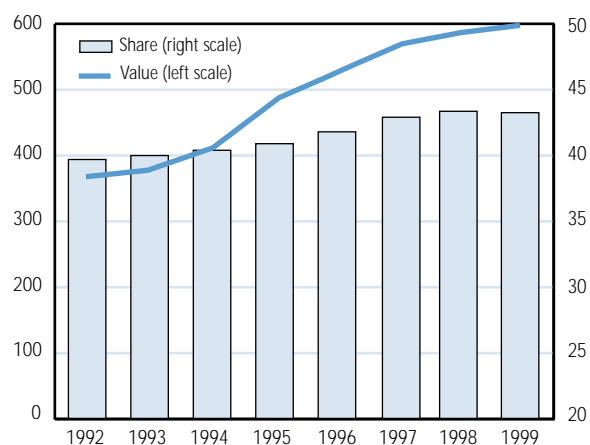

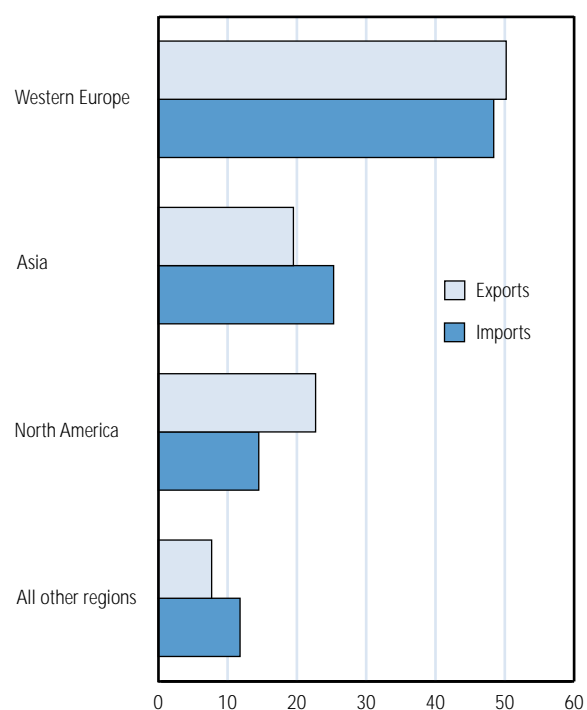
