All actions identified in respect of the Russian Federation for 2015 and thereafter operate at the level of the Eurasian Economic Union, i.e., also in respect of Armenia, Kyrgyz Republic, Kazakhstan (which became a WTO Member on 30 November 2015), and Belarus.
