Excellency:

I have the honor to refer to paragraph IV (iv) of the "Memorandum on Tariff Negotiations to be Held in Geneva Commencing II April 1949" (GATT/CP.2/26). Pursuant to that paragraph I enclose, under instructions from my Government, two copies of a list of the specific tariff concessions which it will request from the Salvadoran Government in these negotiations. As the Government of El Salvador is doubtless aware, it is now planned to hold these negotiations at Annecy, France, instead of Geneva as originally contemplated.

My Government wishes to reserve the right to discuss in these negotiations any other charges, restrictions, or regulations affecting the importation into, or the sale or distribution within, El Salvador, of products covered by the attached list.

In accordance with the aforementioned paragraph IV (iv), my Government is also transmitting forty copies of the enclosed list and of this note to Mr. Eric Wyndham-White, Executive Secretary, Interim Commission for the International Trade Organization, for transmission to the other Governments which will participate in the negotiations at Annecy.

Accept, Excellency, the assurances of my most distinguished consideration.
