


The Delegation of Austria and the Delegation of Israel hereby inform the Executive Secretary that they have today completed their bilateral negotiations.

Mr. Chairman,

I have the honour to acknowledge receipt of your letter of today which reads as follows:

"With reference to the understanding reached between our two delegations, I have the honour to confirm that the concession for tariff item number 08.02 D - Grapefruit contained in the attached list will be amended to 25.-- Austrian Schilling per 100 kg if the competent Israeli authorities definitely establish by 31st of March 1962, at the latest, that the Austrian four-wheel-drive motor vehicle "Puch-Haflinger" falls under Israeli tariff item number 87.02 (b)(1) and is therefore dutiable at 40 % ad valorem.

I am grateful to you, Mr. Chairman, for your offer of undertaking yourself steps with the competent Israeli authorities for a speedy decision."

I herewith confirm my agreement.

Please accept, Mr. Chairman, the assurance of my high consideration.
