NOTES TO SCHEDULE XXXIX - MALAYSIA

1. Concessions listed in this Schedule are conditional to the implementation of concessions by the developed countries.
2. In the case where one or several of the MTN participants should suspend or delay the implementation or staging of their concession in respect of products which Malaysia has an export interest, Malaysia reserves the right to take any action as it deems necessary to restore the balance.
3. The concessions set out in this Schedule are granted on the understanding that the provisions of paragraph 3 of the Geneva (1979) Protocol to the General Agreement on Tariffs & Trade are applicable to all the concessions negotiated by Malaysia in the Multi-lateral Trade Negotiations.
