World Tariff Profiles 2017

World Tariff Profiles 2017 provides comprehensive information on the tariffs and non-tariff measures imposed by over 170 countries and customs territories. Cross-country comparison tables are followed by one-page profiles for each economy, with a detailed breakdown of tariffs by product and the tariffs imposed by major trading partners. This is followed by a section on the use of non-tariff measures, which are becoming increasingly important in international trade.

The special topic in this year's edition is "export diversification", which analyses to what extent economies have diversified their exports over time.

Trade Profiles 2017 provides a series of key indicators on trade in goods and services for 196 economies, highlighting the major exports and imports for each economy as well as their main trading partners. For each profile, the data is presented in a handy two-page format, providing a concise overview of global trade. For merchandise trade, exports and imports are broken down by main commodity groups and by major trading partners. Top exports and imports are listed for agricultural products and non-agricultural products. For trade in commercial services, data is provided for transport, travel, other commercial services and goods-related services. Statistics on intellectual property are also provided.
