DECREE No 239

**ON COMPULSORY CONFORMITY ASSESSMENT OF
PRODUCTS AND SERVICES IN THE REPUBLIC OF
ARMENIA**

adopted by the President of
the Republic of Armenia
on May 12, 2000, Yerevan

According to the Articles 7 and 17 of the Law of the Republic of Armenia "On the Conformity Assessment of the Products and Services to the Normative Requirements" the Government of the Republic of Armenia decides:

1. To establish :
 - a) the lists of the products and services subject to the compulsory conformity assessment in the Republic of Armenia (enclosed);
 - b) the procedure of paying fee for the works on the compulsory conformity assessment in the Republic of Armenia (enclosed).
2. To make the following amendments into the procedure of the import into the customs territory of the Republic of Armenia of the products subject to the compulsory certification in the Republic of Armenia, established by the Decree No15 "On the Compulsory Certification of the Products and Services in the Republic of Armenia" adopted by the Government of the Republic of Armenia on January 16, 1998:
 - a) to establish the following wording of the paragraph 1 of the Regulation:
"1. the present Regulation shall be efficient as regards the products subject to the compulsory assessment, and imported into the customs territory of the Republic of Armenia by the legal persons, enterprises without the status of the legal person, sole entrepreneurs (hereinafter "economic entity"), as well as the natural persons".
 - b) to establish the following wording of the paragraph 3 (d) of the Regulation:
"d) on those goods imported by the economic entities and the natural persons, the kind quantities (based on measurement units) of which do not exceed those established by the customs legislation of the Republic of Armenia for goods imported free of customs duty as an accompanying baggage of the citizens".
3. To recognize as invalid:

- a) the paragraphs 1 (a), (c), (d) and 3, 4, 5 of the Decree No15 of the Government of Armenia “On the Compulsory Certification of the Products and Services in the Republic of Armenia” of January 16, 1998.
 - b) May 14, 1998 Decree of the Government of the Republic of Armenia No 289 “On Making Amendments in the Decree of the Government of the Republic of Armenia No15 of January 16, 1998”.
 - c) July 30, 1998 Decree of the Government of the Republic of Armenia No 476 “On Making Additions in the Decree of the Government of the Republic of Armenia No15 of January 16, 1998”.
 - d) May 22, 1999 Decree of the Government of the Republic of Armenia No 341 “On Inserting Additions in the Decree of the Government of the Republic of Armenia No15 of January 16, 1998”.
4. The present Decree shall enter into force after two months since its promulgation.

REGULATION

on Fee for the Compulsory Conformity Assessment Works in the Republic of Armenia

1. The fee for the compulsory conformity assessment works shall be paid by the applicants.
2. The compulsory conformity assessment works as regards the products aiming at the beneficiary aid shall be reimbursed on the account of the state budget of the Republic of Armenia via the governmental order.
3. The fee for the compulsory conformity assessment works carried out by the certification bodies shall be paid according to the procedure of price calculations for the compulsory conformity assessment works approved by the Ministry of Finances and Economy of the Republic of Armenia.
4. The fee for the certification testing conducted by the testing laboratories shall be paid according to the tariffs established by the testing laboratories.
