Cabinet of Ministers of the Republic of Georgia Resolution # 744 November 30, 1995 Tbilisi

On Further Liberalization of Export and Import Activities in the Republic of Georgia

Cabinet of Ministers if the RoG notifies, that economical reforms, recently taking place in the Republic takes more and more complex character and is reflected in every sphere of economy. To implement these activities and reach financial-economic stabilization in the Republic mainly depends on gaining Rehabilitation Credit. The negotiation is taking place among the representatives of International Monetary Fund and World Bank. One of the conditions to receive the credit foresees the improvement State Regulation system of Foreign Trade. It should be mainly expressed in step-by-step (gradual) replacement of economic levers of administrative mechanism of export-import regulation.

In order to execute measures for liberalization of export-import activities defined under the Resolution #102, dated from 23 February, 1995 of the CoM of the RoG and Recommendations from the International Financial Organizations, CoM of the RoG, resolves to:

- 1. be considered invalid:
- Resolution #177, dated from March 25, 1994, of the CoM of the RoG "on the obligatory registration of foreign-economic treaties/agreements in the Republic of Georgia."
- Appendix #4 to the Resolution # 35, dated from January, 1995 of the CoM of the RoG, "on improvement of state regulation of goods/jobs, services/ export-import activities".
- Appendix to the Resolution #475, dated from 10 august, 1995 of the CoM of the RoG "on liberalization of export-import activities in the Republic of Georgia".
- 2. approve the appendixes ## 1-6 of the hereby resolution, instead of the invalid Resolutions and appendixes.

The amendments to the above mentioned appendixes can only be made by the CoM of the RoG, after submission of the Ministry of Economy.

3. establish, that the rule on obligatory registration of documents confirming foreigneconomic treaties/contracts, agreements (hereinafter "contracts") shall be extended to all the legal persons of the RoG, notwithstanding the form of property and shall be in force before receiving the second trench of credit allotted for implementing restructuring.

Only export and import contracts (including barters) foreseeing delivery goods (services) out of the republic and vice versa, enlisted in appendix #4 and #5 and approved by the hereby resolution, subject to obligatory registration.

4. place a duty on the Committee of Foreign Economic relationship of the RoG to issue licenses on export and import and produce registration of contracts.

Export and import licenses shall be issued in accord with the Resolution #475 dated from 10 august and Resolution # 355, dated from 23 January, 1995 of the CoM of the RoG and registration of contracts shall be conducted in conformity with the appendix #3 of the hereby resolution.

- 5. impose responsibilities on the ministries and departments to establish and approve rugulations(rules) on making agreements and to issue export and import licenses in conformity with the appendix # 5 of the Resolution #35, dated from January 23, 1995 and appendix #2 of the hereby Resolution, dated from January 23, 1995 of the CoM of the RoG. Export and import licenses shall be issued in conformity with the Ministries of Environment Protection, Health Care, Agriculture and Food Industry, Internal Affairs, Finance and Culture, Forestry Department, Department of Geology.
- 6. not subject to compulsory registration contracts, on the basis of which single export licenses are issued before the enactment of the hereby resolution.
- 7. place a duty on the Customs Department of the RoG to restrict export-import of goods enlisted in the appendix 5 of the Resolution # 35, dated from January 23, 1993 and in the appendix #2 of the hereby resolution, without appropriate official licenses and contract registration cards.
- 8. disseminate the hereby Resolution together with the appendixes through Mass media of the Republic of Georgia.

#### Regulation

On

#### Obligatory Registration Rules of Export and Import Contracts

1. Every legal person of the Republic, despite the form of property, subject to obligatory registration of contracts at the State Committee of Foreign economic Relationship of the Republic of Georgia.

Registration is obligatory only for those contracts (including barter contracts) foreseeing export and import of goods included in the list approved under the resolution of the CoM of the RoG.

Amendments to the approved lists can be made only by the CoM of the RoG, by the submission of the Ministry of Economy.

2. Contacts are registered on the basis of application attached by the original of contract to registered, its copy (the original copy of contract is returned to the applicant after consideration) and bank reference specifying existence of bank account.

Registration of contract is notified by the officially registered card. Receiving this card, applicant must present the receipt on payment of registration service fee.

- 3. Applicant pays 50 GEL for registration one contract. 30% of the amount received as registration fee is transferred to the State Budget, and 70% on the account of the Committee of Foreign Economic Relationship of the RoG.
- 4. According to the existing legislation of the RoG, applicant carries responsibility on correctness of the information and fairness of the documents submitted.
- 5. Registration Service considers submitted contracts not later than within 10 calendar days after submission.
- 6. Registration of contracts means to award registration number and record into the special register, every page of the contract is numbered and witnessed by the seal of the Committee and signed by a person in charge.

Customs registration of goods is produced only after submitting registration card, in case its export and import is subject to obligatory registration.

Registration card must be ascertained by the seal of Committee of Foreign Economic Relationship and signed by the Committee officer in charge.

7. Every documentation submitted for contract registration are preserved in the Committee of Foreign Economic Relationship of the RoG during two years.
