

#### **Article 184. Violation of Intellectual Property Rights**

1. Illegal use of the objects of copyright or related rights and also the illegal use of an invention, a useful model or an industrial design, the disclosure without the author's or applicant's consent of the essence of a scientific discovery, an invention, a useful model or industrial design prior to official publication of the information thereof and likewise the appropriation of the authorship or compulsion to co-authorship if these deeds are committed with the purpose to derive a profit and caused serious injury, -

a penalty shall be imposed in an amount ranging from one hundred to five hundred monthly evaluation indices, or in the amount of one salary, or any other income obtained by the convicted person during a period ranging from one to five months, or recruitment to public works for a period ranging from one hundred and eighty to two hundred and forty hours, or by imprisonment for a period of up to two years.

2. The deeds stipulated in par. 1 of this article committed repeatedly or by a group of persons upon the preliminary conspiracy or by an organized group, -

a penalty shall be imposed in an amount from five hundred to eight hundred monthly evaluation indices or in an amount of one salary or any other income of the convicted person obtained for the period from five to nine months or by arrest for the period from four to six months or by deprivation for a period up to five years with confiscation of the property or without it.

#### **Article 199. Illegal Use of the Trade Mark**

1. The illegal use of somebody else's trade mark, service mark, firm name, name of the place of origin of goods or similar designations for the like goods and services if this deed is committed more than once or caused serious injury, -

a penalty shall be imposed in an amount from two hundred to five hundred monthly evaluation indices or in an amount of one salary or any other income of the convicted person obtained for the period from two to five months or by recruitment to public works for the period from one hundred and eighty to two hundred and forty hours or by the arrest for the period up to six months or by corrective labor for the period up to two years.

2. Illegal use of a warning mark in respect of a trade mark or the name of the place of origin of goods not registered in the Republic of Kazakhstan if this deed is committed more than once or has caused serious injury, -

a penalty shall be imposed in an amount from one hundred to two hundred monthly evaluation indices or in an amount of one salary or any other income of the convicted person obtained for the period up to two months or by recruitment to public works for the period from one hundred and twenty to one hundred and eighty hours or by the arrest for the period up to three months or by corrective labor for the period up to one year.

#### **Article 200. Illegal Obtaining and Disclosure of the Information Containing Commercial or Banking Secret**

1. Collection of information constituting a commercial or banking secret by theft of documents, bribes or threats to persons possessing the commercial or banking secret or their relatives, interception in the communication networks, illegal intrusion in a computer system or network, use of special technical means or any other illegal method with the purpose of disclosure or illegal use of this information, -

a penalty shall be imposed in an amount from one hundred to two hundred monthly evaluation indices or in an amount of one salary or any other income of the convicted person obtained for the period up to two months or by corrective labor for the period up to two years or by the arrest for the period up to six months or by deprivation up to one year period.

2. Illegal disclosure or use of the information composing commercial or banking secret without the consent of its owner by a person was entrusted therewith it as the official duty or work committed for mercenary or any other personal interests and which caused serious injury, -

shall be penalized in an amount from two hundred to five hundred monthly evaluation indices or in an amount of one salary or any other income of the convicted person obtained for the period from two to five months or by the arrest for the period from four to six months or by the corrective labor for the period from one year up to two years or by deprivation for the period up to three years with a penalty in an amount up to one hundred monthly evaluation indices or in an amount of the wage or any other income of the convicted person obtained for the period up to one month or without it.
