

**The Resolution of the Government of the Republic of Kazakhstan N 669 « On Adoption of the Customs Charges, Fees and Payments Levied by the Customs Bodies » dated July 8, 2003**

Pursuant to the Articles 294-297, 299 of the Customs Code of the Republic of Kazakhstan the Government of the Republic of Kazakhstan decrees:

1. to approve the given rates of the customs duties, fees and payments levied by the customs bodies.
2. to declare several resolutions of the Government of the Republic of Kazakhstan invalid according to the appendix.
3. the present Resolution comes into force since the date of its official publication.

**The rates of the customs duties, fees and payments levied by the customs bodies**
