

**ORDER OF THE GOVERNMENT OF THE REPUBLIC OF
KAZAKHSTAN**
No. 793 of July 16 2014

**On Approval of Rules on Determining the Country of Origin of Goods,
Registration, Certification and Issuing of a Certificate of Origin and the
Repeal of Certain Resolutions of the Government of the Republic of
Kazakhstan**

In accordance with subparagraphs 11), 12) of Article 6 of the Law of the Republic of Kazakhstan of 9 November 2004 "On Technical Regulation", subparagraph 7) of Article 14 of the Law of the Republic of Kazakhstan of 4 July 2013 "On National Chamber of Entrepreneurs of the Republic of Kazakhstan" the Government of the Republic of Kazakhstan DECIDES :

1. To determine the National Chamber of Entrepreneurs of Republic of Kazakhstan as an organization authorized to issue certificates of origin of goods for domestic circulation.
2. To approve the attached Rules on determining the country of origin of goods, registration, certification and issuing a certificate of origin of goods.
3. To repeal certain resolutions of the Government of the Republic of Kazakhstan in accordance with the Appendix.
4. This Resolution shall come into force from July 12, 2014 and shall be officially published.

Rules on Determining the Country of Origin of Goods, Registration,
Certification and Issuing of a Certificate of Origin

1. General Provisions

1. These Rules on determining the country of origin of goods, registration, certification and issuance of a certificate of origin (hereinafter - Rules) are developed in accordance with subparagraphs 11), 12) of Article 6 of the Law of the

Republic of Kazakhstan of 9 November 2004 "On Technical Regulation" and subparagraph 7) of Article 14 of the Law of the Republic of Kazakhstan of 4 July 4 2013 "On the National Chamber of Entrepreneurs of the Republic of Kazakhstan" and establish the procedure for determining the country of origin of goods, preparation and issuance of the certificate of assessment of origin of goods and registration, certification and issuance of the certificate of origin of goods produced or sufficiently processed goods in accordance with the criteria of sufficient processing of goods in the territory of the Republic of Kazakhstan.

2. These Rules shall be applied to:

- 1) the authorized body;
- 2) the authorized organization;
- 3) expert organizations;
- 4) expert auditors to determine the country of origin;
- 5) natural or legal persons interested in obtaining of a certificate of origin.

3. In this Rules the following definitions shall be used:

1) ad valorem share - percentage share of the cost of the used materials or added value reaches a fixed percentage of the price "ex-works" of the delivered goods;

2) re - export of - export of goods imported from abroad without their processing;

3) cumulative principle - one of the principles for determining the country of origin, according to which the origin of the goods as a result of sequential processing of goods in the member states of the Agreement on the Free Trade Area of 15 April 1994 (hereinafter - the Agreement) is determined by the country of manufacture of the final product ;

4) the applicant - a natural or legal person interested in obtaining of a certificate of origin;

5) expert organization - a legal entity which is having an expert auditor in its staff to determine the country of origin of goods, is working on the examination of the origin of the goods;

6) mass produced goods - goods, production of which is repeated in separate batches for a long time;

7) commodity nomenclature of foreign economic activity (hereinafter - HS) - classifier of goods, which includes commodity groups, headings, subheading, sub subheading as a digital sign or group of digits (codes). An integral part of the commodity nomenclature of foreign economic activity is the explanations for headings at any level of classification, as well as the basic rules of interpretation of the commodity nomenclature of foreign economic activity;

8) the share of local content in goods - the percentage of the cost of the used local materials and cost producer of goods for processing of goods within the territory of the Republic of Kazakhstan, in the final cost of the goods;

9) criteria for sufficient processing of goods - one of the principles for determining the country of origin, in accordance with which the product if its production involves two or more countries is considered as originated from the country where it had been substantially processed last time sufficient to give the commodity its characteristic properties;

10) certificate of origin - a document certifying the country of origin and issued in accordance with the legislation of this state or the state of export, if the State of export certificate issued on the basis of information received from the country of origin;

11) country of origin of goods - the country in which the goods were completely produced or sufficiently processed;

12) Goods - property sold in the territory of the Republic of Kazakhstan or moved across the border of the Republic of Kazakhstan, including electrical, thermal and other types of energy, as well as vehicles, except for vehicles used for the international carriage of passengers and goods;

13) expert auditor to determine the country of origin - a specialist certified in the manner prescribed by the authority;

14) a unique product number - number of the product that is applied to each unit of product is the unchanged that lasts for life / date specified for this type of product, having a structure in accordance with the industry standard;

15) price on an "ex-works" - the price to be paid to the manufacturer, the company that produces the latest processing, on an "ex works", excluding any internal taxes that are paid or may be paid when exporting manufactured goods;

16) authorized body - the state body exercising the state regulation in the field of technical regulation;

17) authorized organization - the National Chamber of Entrepreneurs of the Republic of Kazakhstan, carrying out registration, certification and issuance of a certificate of origin, and also authorized the issuance of a certificate of origin for domestic circulation;

18) classification of products by economic activity - Classification of Products, which establishes the classification and coding of products by economic activity;

19) export - export of domestic or previously imported from abroad and subjected to processing of goods for their implementation in the foreign market.

2. Determination of the country of origin, registration, certification and issuance of a certificate of origin goods for goods exported, re-exported from the Republic of Kazakhstan

4. To determine the country of origin it must be established that the goods are:

1) wholly Kazakh origin;

2) Kazakh origin, taking into account the criterion of sufficient processing of goods;

3) foreign origin.

5. Goods wholly produced in the Republic of Kazakhstan, are:

1) the minerals extracted from the interior of the country, in its territorial waters (seas) or on its continental shelf;

2) products of the plant grown or gathered in this country;

3) live animals born and (or) raised in that country;

4) products obtained in the country from animals raised therein;

5) products received as a result of hunting and fishing trade in this country;

6) products of sea fishing trade and other products of the sea trade received by the vessel of this country or leased (chartered) it;

7) products obtained aboard a factory ship of the country exclusively from products referred to in paragraph 6) of this paragraph;

8) products obtained from the seabed or subsoil from the sea outside the territorial waters (sea) of the country, provided that the country has exclusive rights to development of such seabed or marine depth;

9) waste and scrap (secondary raw materials) derived from manufacturing or other processing operations, and used articles, collected in that country and fit only for the recovery of raw materials;

10) products of high technologies obtained in the open space on space ships belonging to this country or rented (chartered) by it;

11) goods produced in the country exclusively from products referred to in subparagraphs 1), 2), 3), 4), 5) 6) 7) 8) 9) 10) of this paragraph.6. If two and more countries participate in production of the goods, the country of source of the goods the country in which the last transactions on conversion of the goods, answering to criteria of sufficient conversion of the goods were performed is considered.

7. The criteria for sufficient processing of goods for giving it the status of originating in the Republic of Kazakhstan are:

1) change of the commodity code according to the Commodity nomenclature of foreign economic activity at level of any of the first four digits, resulted conversion of the goods;

2) the performance of industrial or technological operations sufficient for the country of origin is the country where these operations took place;

3) changes in the value of the goods when the percentage value reaches a fixed share of the price of the final product (ad valorem share rule)

8. The main criterion of sufficient conversion of the goods is change of the commodity code according to the commodity nomenclature of foreign economic activity at level of any of the first four digits, occurred as a result of processing of goods, except for goods included in the list of conditions, industrial and technological operations necessary for giving the status of product origin when used in the manufacture of goods from third countries.

In this list as one of the conditions included ad valorem share rule, both independently and in conjunction with other criteria of sufficient processing of goods.

To assess the criterion of sufficient processing of goods may apply cumulative principle, according to which the origin of the goods as a result of sequential processing of goods in the member states of the Agreement is determined by the country of manufacture of the final product.

If the production of final goods in one of the States Parties to the Agreement on granting preferences using raw materials originating from other States Parties to the Agreement, confirmed by a certificate of origin, and subjected to further processing phase in other States parties to the Agreement, the country of origin such goods shall be the country where the last time he was subjected to processing.

In the absence of a certificate of origin of raw materials or the final determination of the country of origin of goods is established by paragraph 7 of these Rules.

To determine the country of origin of goods produced and exported from the Republic of Kazakhstan in the Commonwealth of Independent States and the European Community and the United States, Canada, Japan, Turkey, Australia, New Zealand, Switzerland and Liechtenstein, Norway under the Generalized System of Preferences, and in the country for which proof of origin of goods is carried out certificate form "Original", the list of conditions, production and technological operations listed in the Agreement on Rules of origin of goods in the Commonwealth of Independent States, approved by the Government of the Republic of Kazakhstan dated December 30, 2010 for number 1478, and Regulations European Economic Community № 2454/93.

The origin of the goods produced and exported from the Republic of Kazakhstan to the countries which have signed free trade agreements, with the exception of the Commonwealth of Independent States, is determined on the basis of these international treaties in force for the Republic of Kazakhstan.

9. The conditions which are not meeting the criteria for sufficient processing of goods for giving it the status of originating in the Republic of Kazakhstan, are:

1) transactions on ensuring safety of the goods during their storage or transportation;

- 2) transactions on preparation of goods for sale and transportation (breaking into smaller lots, organization of shipments, sorting, repacking);
- 3) washing, cleaning, removal of dust, oxide coating, oil and other substances;
- 4) ironing or pressing of textiles (all kinds of fibers and yarns, woven fabrics of all kinds of fibers and yarns and products made of them);
- 5) operations painting or varnishing;
- 6) peeling, partial or total bleaching, polishing and grinding cereals and rice;
- 7) the operation of coloring sugar or sugar lump formation;
- 8) peeling, cutting and extraction of seeds of fruits, vegetables and nuts;
- 9) sharpening, simple grinding or simple cutting;
- 10) sieving through a sieve or a sieve sorting, classification, screening, selection (including the preparation of sets of products);
- 11) spill, packing in cans, bottles, bags, boxes and other simple packaging operations;
- 12) simple assembly operations or dismantling of goods in installments;
- 13) separating the products into components, which does not significantly differ from the original components of the received goods;
- 14) mixing of goods (components), which does not lead to a significant difference between the obtained product from the original components;
- 15) slaughtering, butchering (sorting) of meat;
- 16) a combination of two or more of the above operations.

10. If the rule of the ad valorem share is applied, calculation of the ad valorem share in production of the goods is made:

- 1) for imported goods - on the customs value of the goods when they are imported into the country, where the production of the final product, or if the origin of the imported goods is unknown - according to the documented price of their first sale in the territory of the country where the production of the final product ;
- 2) for the final product - the price of the plant (warehouse) of the seller, not including the cost of loading, customs declaration and export of goods from the country of export (price on an "ex-works").

11. In determining the country of origin of goods in unassembled or disassembled state, delivered in several batches, if for production or transport conditions they can not be shipped in one shipment, as well as in cases where the consignment is broken down into several lots by mistake or wrong address shall be considered to request of the declarant as a single product.

The provisions of this paragraph shall apply subject to the following conditions:

1) The prior notification of the customs authority of the importing country on the breakdown of the dismantled or non-assembled commodities into several lots with an indication of the reasons, the application detailed specification for each lot with indication of codes of commodities under the nomenclature of foreign economic activity, value and country of origin of the goods included in each batch, as well as notification of broken goods in several lots by mistake or wrong address - if the documentary evidence of the fallacy of a breakdown of the goods;

2) delivery of all consignments from one country one exporter (supplier); import and clearance of all shipments via the same customs;

3) delivery of all consignments within a period not exceeding six months from the date of acceptance of the customs declaration.

12. In order to determine the origin of the country of origin of goods used for their production of heat and electricity, machinery, equipment and tools are not taken into account.

Devices, accessories, spare parts and tools for use with machines, equipment, devices or vehicles considered as originating from the same country as the machines, equipment, vehicles or vehicles if these devices, accessories, spare parts and tools imported and sold as a set with the above machines, equipment, devices or vehicles and in an amount usually comes with these devices.

13. Works associated with the expertise to determine the country of origin, carried out on a contractual basis on the basis of an application filed by the applicant in the expert organization, and submitted by the applicant on the list of documents referred to in paragraph 16 of this Rules.

14. Examination of Origin expert auditors carried out to determine the country of origin of goods within two working days from the date of filing of the application, and with a full package of documents confirming the origin of the goods.

15. Examination of origin include:

1) examination of the documents confirming the origin of the goods, on a list approved by the authority;

2) identification of the goods by external signs, marking (name, type, species, packaging, grade, manufacturer), if necessary, to travel to the location of the goods;

3) examination of the process of production of goods in order to establish a criterion of sufficient processing of goods and certain value-added goods.

16. According to Annex 2 to these Rules for the examination of the origin of the goods, as well as the re-export of goods, together with the application are presented documents proving the origin of the goods on the list approved by the competent authority.

With multiple deliveries of goods under a single contract allowed to issue the examination certificate to the contract at the first batch of shipment for one year, including the goods of mass production.

In the examination certificate sent by the first consignment of goods specified contractual party or annual release of the goods.

When changing production technology and components in this product, as well as the country providing materials the applicant within five working days, inform the expert organization to determine the country of origin of these changes in order to obtain a new certificate of examination of the origin and certificate of origin.

17. If necessary, additional research expert organization asks:

- 1) originals and copies of permits, licenses, documents certifying the origin of the raw materials and components;
- 2) test report issued by an accredited test laboratories (centers), if not possible to identify the goods without laboratory tests and studies.

The original documents are returned to the applicant within one working day after their identification with copies.

18. According to the results of examination the expert organization provides examination certificate of origin in accordance with Annex 3 to these Rules, composed of expert auditors to determine the country of origin, that the product is:

- 1) Kazakhstan origin, taking into account the criterion of sufficient processing of goods;
- 2) foreign origin.

19. Conducts review and sign the expert opinion of expert auditors to determine the country of origin, received a qualification certificate and entered in the register of expert auditors to determine the country of origin.

20. The applicant self-selects the expert organization. Register of expert auditors to determine the country of origin and the list of expert organizations posted on the website of the authority.

21. When re-export documents submitted additionally authorized organization, confirming the import of goods into the Republic of Kazakhstan (copy of the certificate of origin, customs declaration and shipping documents).

Registration, certification and issuance of certificate of origin

22. Before placing a certificate of origin authorized person authorized organization shall issue an opinion about the design of a certificate of origin. To do this, the analysis submitted by the applicant documents confirming the origin of the goods, and the analysis of the examination of the origin of the goods for its proper execution.

23. Registration, license and certificate of origin are carried out on the following forms:

- 1) Certificate form "ST-1" - for goods exported from the Republic of Kazakhstan in the Commonwealth of Independent States;
- 2) The certificate form "ST-2" - for goods exported from the Republic of Kazakhstan in the country, which are committed and the free trade agreement, with the exception of the Commonwealth of Independent States;
- 3) The certificate form "A" - for goods exported to the Member States of the European Community and the United States, Canada, Japan, Turkey, Australia, New Zealand, Switzerland and Liechtenstein, Norway under the Generalized System of Preferences;
- 4) Certificate form "Original" - in English or Russian languages (determines the applicant) for goods exported to countries not referred to in subparagraphs 1), 2) and 3) of this paragraph.

24. Certificate of origin issued, shall be certified and issued within one working day on the basis of:

- 1) Application person or entity to issue a certificate of origin, in accordance with Annex 4 to these Rules;
- 2) of the examination of the origin of the goods;
- 3) documents confirming the origin of the goods, on a list approved by the authority.

Certificate of origin of goods wholly produced in the Republic of Kazakhstan, provided for in paragraph 5 of these Rules shall be issued on the basis of the documents referred to in subparagraphs 1) and 3) of this paragraph.

25. When goods are exported from the territory of the Republic of Kazakhstan certificate of origin is issued for each consignment is sent simultaneously, which is carried out by one or more vehicles to the same consignee from the same shipper.

26. Certificate of origin issued on letterhead with the degree of protection: the first instance - the script, the second and the third copy - copy. The original and one copy of the certificate shall be issued to the applicant, and the second copy is kept in an authorized organization that issued the certificate of origin.

Authorized organization keeps records of use, storage and issue of the forms of the certificate of origin in accordance with the requirements of these Rules.

27. Certificate of origin issued, shall be certified and issued by an authorized organization.

With multiple deliveries of goods under a single contract allowed to issue certificates of origin for each consignment is sent simultaneously by a copy of the examination, the original of which was issued for the whole consignment contract for goods or serial production and exporter presented at the first shipment.

The application for a certificate of origin the applicant personally confirms that outgoing shipments of goods is not subjected to changes in production technology and components, as well as country-materials supplier to this product.

28. The certificate of origin is as follows:

- 1) twelve months from the date of issue for the form "ST-1";
- 2) twelve months from the date of issue for the shape of "Original";
- 3) ten months from the date of issue for the form "A".

29. The certificate of origin of the goods is considered void if in it there are erasures, the blots, not certified correctings, are absent necessary signatures and (or) seals.

In case of change of the data containing in the certificate of origin of the goods, the new certificate is issued only after return by the applicant of earlier issued certificate which is cancelled and hemmed as reasons in case of issue of the new certificate of origin of the goods, and also availability of the necessary documents confirming these changes.

30. The drawn-up certificates are issued to the applicant under the list in the magazine of registration of the issued certificates of origin of the goods.

31. Transfer of certificates of origin of the goods to other persons is not allowed.

32. Repetitions of certificates of origin of the goods and documents based on which they were issued, are stored in the authorized organization at least three years from the date of issue of the certificate of origin of the goods.

33. In case of re-export of the goods within the states agreement parties issue of zamenny certificates in the presence of the repetition of the certificate of the ST-1 form of the country of source of the goods is possible.

In case of re-export of the goods within the states agreement parties made in their territories and delivered on customs areas of the states agreement parties before entry into force of Rules of determination of the country of source of the goods from September 24, 1993, approved by the decision of Council of heads of governments of the Commonwealth of Independent States, issue of the certificate of origin of the goods of the ST-1 form is possible. Issue of the certificate is possible under condition of submission of supporting documents about the manufacturer of the goods (the name with indication of the republic of the Union of the Soviet Socialist Republics and the postal address) and years of production of the goods.

3. Determination of the country of origin of goods for internal circulation

34. In order to determine the country of origin must be established that the goods:

- 1) All of Kazakh origin;

2) Kazakhstan origin, taking into account the criterion of sufficient processing of goods.

35. The definition of goods considered wholly produced in the Republic of Kazakhstan, is made in accordance with paragraph 5 of these Rules.

36. The criteria for sufficient processing of goods of Kazakhstan origin for domestic circulation are:

1) criterion in subparagraph 1) of paragraph 7 of these Rules;

2) the specific conditions of production and technological operations necessary for giving the status of product origin for use in the manufacture of goods from third countries listed in Annex 9 to these Rules;

3) changes in the value of the goods when the proportion of local content in the product price is not less than 30 percent of finished goods under the terms of prices "ex-works".

37. The main criterion of sufficient processing of goods is to change the product code on the commodity nomenclature of foreign economic activity at any of the first four digits, occurred as a result of processing of goods, except for goods included in the list of conditions, industrial and technological operations necessary for giving the status of product origin when used in the manufacture of goods from third countries.

In this list as one of the conditions included ad valorem share rule, both independently and in conjunction with other criteria of sufficient processing of goods.

Annex 9 of the said Rules established a list of conditions, industrial and technological operations necessary for giving the status of product origin, in respect of particular goods to determine the country of origin of goods produced in special economic zones and free warehouses of the Republic of Kazakhstan, intended for further treatment in Kazakhstan as well as produced or sufficiently processed in accordance with the criteria of sufficient processing of goods in the territory of the Republic of Kazakhstan and implemented on the territory of the Republic of Kazakhstan.

In case of discrepancy criteria for sufficient processing of goods specified in subparagraphs 1) and 2) of paragraph 36 of these Rules, the criterion of sufficient processing of goods specified in subparagraph 3) of paragraph 36 of these Rules.

38. The conditions that do not meet the criteria of sufficient processing of goods, set out in paragraph 9 of these Rules.

39. If the rule applies to ad valorem percentage, the calculation of ad valorem share in the production of goods is made in accordance with paragraph 10 of these Rules.

Calculation of ad valorem share in the production of goods is made by the formula in accordance with Annex 1 to these Rules.

40. Determination of the country of origin of goods supplied unassembled or disassembled state, is made in accordance with paragraph 11 of this Rules.

41. Features of determining the country of origin of goods for domestic circulation provided to meet the requirements of paragraph 12 of these Rules.

On the product completely Kazakhstan origin, the proportion of local content is one hundred percent. The calculation of the proportion of local content packaging, inseparable from this product, not made.

42. Examination by determination of the country of source of the goods is carried out on the contractual basis based on the request submitted the applicant to the expert organization, and the documents provided by the applicant according to the list specified in Item of 45 these rules.

43. Examination of the parentage of the goods is performed by the expert-auditor by determination of the country of source of the goods within two working days from the moment of representation and registration of the request with the complete document package, confirming the parentage of the goods.

44. Examination of the parentage of the goods includes:

1) examination of the documents confirming the parentage of the goods, according to Item of 45 these rules;

2) identification of the goods on external signs, marking (the name, type, packaging, the class, manufacturer) with departure on the location of production;

3) examination of engineering procedure in case of production of the goods for the purpose of establishment of criterion of sufficient conversion of the goods and determination of value added of the goods.

45. According to appendix 5 to these Rules on carrying out examination of the parentage of the goods together with the request the following documents are shown:

1) the documents confirming legal position of the applicant (for the physical persons engaging in business activity without education of the legal entity, - the passport, the identity certificate, the patent or the certificate of the individual entrepreneur);

2) the original and the repetition of the documents confirming the parentage of the goods (the agreement with the producer of the goods or on acquisition of the goods, delivery notes, invoices, documents on transportation of the goods);

3) original and repetition of the license by sight activities;

4) the original and the repetition of documents for determination of criterion of sufficient conversion of the goods (cost of raw materials and the components used in production of the goods, delivery agreements of raw materials and/or the invoice, and/or delivery notes, the fabrication documentation with appendix of the list of regulating technical documents according to which the goods, calculation of cost of the goods taking into account cost of used raw materials or the component of the foreign origin are made);

5) the original and the repetition of the warehouse reference on availability and goods quantity in the warehouse with indication of the address of the warehouse;

6) the original and the repetition of the power of attorney on representation of interests of the applicant;

7) for fruit-and-vegetable products: the original and the repetition of the reference confirmation of local executive body of the corresponding territorial unit of the Republic of Kazakhstan about cultivation of the declared lot of products in the specified territory and the agreement with the producer of products, the agreement on acquisition of the goods with obligatory submission of the original or the notarized repetition of the agreement with the producer of the goods.

Originals of documents return to the applicant within one working day after their identification with repetitions.

46. In case of carrying out examination of the parentage of the goods of serial production delivery notes, invoices, documents on transportation of the goods, and also the warehouse reference are not required.

47. In case of need the expert organization requests carrying out additional researches:

1) originals and repetitions of permissions, licenses, the documents certifying the parentage of raw materials, materials, accessories;

2) the test report issued by accredited test laboratories (centers) if identification of the goods without laboratory experiments and researches is impossible.

Originals of documents return to the applicant within one working day after their identification with repetitions.

48. By results of examination the expert organization certifies and issues the appraisal certificate about the parentage of the goods, according to appendix 6 to the these rules, constituted by the expert-auditor by determination of the country of source of the goods, that the goods are:

1) completely Kazakhstan origin;

2) the Kazakhstan origin taking into account criterion of sufficient conversion of the goods.

49. In case of carrying out examination of the parentage of the goods of serial production effective period of the appraisal certificate about the parentage of the goods of serial production constitutes 1 year. Thus in the appraisal certificate about the parentage of the goods in column 10 the annual amount of the goods of serial production is specified.

For the companies performing serial production of the goods more than three years, in case of submission of the documents specified in Item of 45 these rules, proving the invariance of the production technology, the country supplier of raw materials (materials), and also costs of raw materials and components the next three years, effective period of the appraisal certificate about the parentage of the goods of serial production are constituted by three years. Thus in the appraisal

certificate about the parentage of the goods in column 10 the three-year amount of the goods of serial production is specified.

In cases of changes of the production technology of the goods, the country supplier of raw materials (materials), and also cost of raw materials and components, the applicant within five working days informs the expert organization on these changes for the purpose of receipt of the new appraisal certificate about the parentage of the goods and the certificate of origin of the goods for the internal address.

50. The expert opinion the expert-auditor by determination of the country of source of the goods, the received competence certificate and brought in the register of experts-auditors by determination of the country of source of the goods examines and signs.

51. In case of establishment of the parentage of the goods made from the goods (raw materials, materials, products) completely Kazakhstan parentage, in the appraisal certificate about the parentage of the goods it is necessary to reflect:

- 1) engineering procedure of production of these goods (regulating document, technological instructions);
- 2) suppliers of raw materials, materials and the components used in case of production of the goods;
- 3) availability (the name, number) documents on payment of the bought raw materials and components.

Registration, certification and issuance of certificate of origin for domestic circulation

52. Certificate of origin form «CT-KZ» is issued, shall be certified and issued to the authorized organization on the letterhead of the form, in accordance with Appendix 7 to these Rules for the goods:

- 1) sufficiently processed in accordance with the criteria of sufficient processing of goods and exported from the special economic zones and free warehouses to the rest of the territory of the Republic of Kazakhstan;
- 2) produced or sufficiently processed in accordance with the criteria of sufficient processing of goods in the territory of the Republic of Kazakhstan and implemented on the territory of the Republic of Kazakhstan.

53. When importing goods from the territory of special economic zones and free warehouses to remaining part of the territory of the Republic of Kazakhstan and (or) sale of goods in the territory of the Republic of Kazakhstan certificate of origin form «CT-KZ» is made for the supply of goods or batch production and issued by the manufacturer or authorized person.

Goods produced in the territory of the free warehouse and sold owner free warehouse on the territory of the Republic of Kazakhstan, an integral part of the certificate form "ST-KZ" is a bill containing a unique product number, which is

issued by the manufacturer for each lot of imported goods and be submitted only in the case of a request tax or customs authority.

54. At the mass production of goods certificate of origin form "ST-KZ» issued to the applicant, are the producers of serial production, for the duration of the examination of the origin of the goods and the amount of the goods specified in the examination certificate of origin. An integral part of the certificate form "ST-KZ» is a bill containing a unique product number, which is issued by the manufacturer for each imported consignment serial production and be submitted only in the case of a request of the tax or customs authority.

55. Certificate of origin form «CT-KZ» is issued, shall be certified and issued on the basis of:

- 1) statements in accordance with Appendix 8 to these Rules;
- 2) of the examination of the origin of the goods;
- 3) The documents submitted by the applicant for examination, in accordance with paragraph 45 of these Rules;
- 4) an inventory of the documents attached.

56. Certificate of origin form «CT-KZ» is filled in accordance with the procedure set out in paragraph 60 of these Rules, shall be certified by an authorized person authorized organization.

57. Authorized body keeps records of use, storage and issue of the forms of the certificate of origin form «CT-KZ» in accordance with the requirements of these Rules.

58. Certificate of origin form «CT-KZ» issued on the letterhead with the degree of protection: the first instance - the script, the second and the third copy - copy. The original and one copy of the certificate shall be issued to the applicant, the second copy is kept in the authorized organization.

At the request of the applicant organization authorized to issue the required number of copies of the certificate upon presentation of the original certificate of origin. On the front side of copies in boxes blank "For official use" or "more information" is recorded: "true copy", date of issue up to the authorized person's signature seal of the authorized organization.

59. The empty space in the form of a certificate of completed graphs «CT-KZ» - graphs 6, 7, 8, 9, 10; crossed out by hand (the sign «Z») in order to avoid making additional entries after his identity.

60. Certificate of origin is not valid if it contains erasures, blots, uncertified corrections, lacks the necessary signatures and (or) printing. Corrections and (or) amendments to the certificate of origin shall be made by crossing out incorrect information and overprinting adjusted data, then I assure signature of the person

authorized to certify the certificate of origin, and sealed by the authorized organization.

If you change the data contained in the graphs of the certificate, the new certificate is issued only after the return of the applicant previously issued certificate that is canceled and filed as a justification for the issuance of new, as well as the necessary documents confirming these changes. Column 5 certificate form «CT-KZ» the note "issued instead of a certificate" with the number and date of revoked certificate (certificate issued in exchange revoked certificate is assigned a new registration number).

61. Copies of the certificate of origin form «CT-KZ» and documents on the basis of which they were issued, are stored in the authorized organization for three years.

62. The certificate of origin form «CT-KZ» is twelve or thirty-six months from the date of issue, depending on the period of validity of the examination of the goods.

63. Certificate form «CT-KZ», in accordance with Appendix 7 to these Rules shall be filled in the state or Russian languages, graphs certificate shall contain the following information about the product to which it is issued:

1) Column 1 - "Product Manufacturer (name and postal address)" - the name of a natural or legal person who is the producer of the product according to the documents confirming the legal status of the manufacturer of the goods:

for a legal entity - according to a notarized copy of the certificate * or a certificate of state registration (re-registration) of the legal entity;

for individuals - according to a notarized copy of an identity document and a notarized copy of the certificate of state registration as an individual entrepreneur.

When filling out the graphs indicate the mailing address of the manufacturer, according to the document, confirming the actual location of the manufacturer of the goods.

2) Column 2 "Receiver of the goods (name and postal address)" - the name of a natural or legal person who is the recipient of the goods according to the documents confirming the legal status of the recipient of the goods:

for a legal entity - according to a notarized copy of the certificate * or a certificate of state registration (re-registration) of the legal entity;

Note: * The certificate of state (accounting) registration (re-registration) of the legal entity (branch, representative office), issued prior to the enactment of the Law of the Republic of Kazakhstan dated December 24, 2012 "On Amendments and Additions to Certain Legislative Acts of the Republic of Kazakhstan on state

registration legal entities and registration of branches and representative offices, "is valid until the termination of the legal entity;

for individuals - according to a notarized copy of an identity document and a notarized copy of the certificate of state registration as an individual entrepreneur.

When filling out the graphs indicate the mailing address of the recipient of the goods, according to the document, confirming the actual location of the recipient of the goods.

Count "Recipient of goods" is populated only if the applicant is not the manufacturer of the product, and authorized by the person representing the interests of the producer of goods by proxy, or the person to whom this product was sold by the manufacturer, in column 5 "For official use" states the above-mentioned agreement for the acquisition of goods between a manufacturer and a recipient of the goods.

In the case of export of goods from the territory of special economic zones and free warehouses Republic of Kazakhstan to the rest of the Republic of Kazakhstan, column 2 "Receiver goods" is filled with similarly only in the event of an authorized person (a mediator).

3) Column 3 - "The purpose of obtaining a certificate of origin" stated goal of obtaining a certificate of origin;

4) Count 4 - registration number of the certificate of origin; the country that issued the certificate ("Republic of Kazakhstan");

5) Column 5 - "For official use". Entered service marks state regulatory agencies, as well as the following entries: "Duplicate", "Issued instead of certificate", "Outstanding for mass production. The certificate of origin is twelve months from the date of issuance, "" Outstanding for mass production. The certificate of origin is thirty-six months from the date of issue. "In the case of a recipient of the goods specified in the contract of purchase of a product between the recipient of the goods and producer goods. In the case of renewal of a certificate shall include all certificate numbers, on the basis of which it was redesigned;

6) Count 6 - "Number" indicates the serial number of the product;

7) Column 7 - "Number and type of packaging" specified number of places and type of packaging goods (party);

8) Column 8 - "Description" - the commercial name of the product and other information that can help make an unambiguous identification of the goods.

When filling out the graphs indicate the code of commodities under the nomenclature of foreign economic activity and classifier of products by economic activity;

9) Column 9 - "The criterion of origin" shall include the following criteria of origin:

P - goods wholly produced in the Republic of Kazakhstan;

D - goods subjected to sufficient processing, indicating the first four digits of the code (heading) of the commodity nomenclature of foreign economic activity of the final product. When filling the column indicates the percentage share of local content in the product. The calculation of the proportion of local content in the production of goods is made by the formula in accordance with Annex 10 to these Rules.

If a certificate stating goods classified in various headings of the commodity nomenclature of foreign economic activity and have different criteria of origin, in column 9 gives the criteria of origin for all differentially declared goods;

10) Count 10 - "The number of goods."

The mass of gross / net (kg) and / or other quantitative characteristics of the goods in accordance with the HS. The discrepancy between the actual value of the goods as specified in the certificate shall not exceed 5%.

When drawing up the form «CT-KZ» product serial production of columns 2, 7, 10 are not filled;

11) Count 11 - "Certification" contains the name of the authorized organization, address, stamp, date of license data specified in the certificate and signature, name and initials of the person authorized to assure the certificate;

12) Column 12 - "Declaration by the applicant" shall include the name of the country of origin, place and date of the declaration of the country of origin, name and initials of the authorized person of the applicant, the applicant's signature and seal.

4. Issue of the certificate of origin of the goods subsequently (retrospectively)

Certificate of origin issued in exceptional cases after the export of goods, export and sale of goods bonded warehouse and special economic zones in the rest of the territory of the Republic of Kazakhstan, provided that the certificate has not been issued at the time of export, as well as the export of goods produced in the free warehouses and special economic zones, to be implemented in the Republic of Kazakhstan due to accidental errors or omissions special circumstances for technical reasons.

65. The notified body shall issue a certificate of origin later, that is (in retrospect) only after verifying that the information contained in the statement of the applicant, the same with the information contained in the relevant documents (documents provided by paragraphs 16 and 45 of these Rules, as well as confirmation of the actual shipment of goods (customs declaration marked the customs authority of the Republic of Kazakhstan "Issue resolved"), and a certificate of origin was not issued when this product was exported or sold with a free warehouse or special economic zones in the rest of the territory of the Republic of Kazakhstan.

66. Certificate of origin issued subsequently (retrospectively) shall contain in box 5 of the certificate of origin form "ST-1" and «CT-KZ» entry: "Outstanding later."66. The certificate of origin of the goods issued subsequently (retrospektivno), shall contain entry in column 5 of the certificate of origin of the goods of the ST-1 and CT-KZ forms: "It is issued subsequently".

5. Issue of the duplicate of the certificate of origin of the goods

67. In case of loss or damage to the certificate of origin, the applicant applies in writing to the authorized organization that issued the certificate of origin, a statement on the issue of a duplicate certificate. Registration number issued by the duplicate registration number corresponds to the original. Column 4 of the certificate form «CT-KZ» entry is "Duplicate" («Duplicate») and specify the registration number and date of issue of the original. In column 12 of the certificate of origin form «CT-KZ» indicates the date of issue of a duplicate.

68. A duplicate of the certificate is valid until the expiration of the term for which the original was issued.

6. Grounds for refusal to issue the certificate of origin

69. Authorized body refuses to issue the applicant a certificate of origin and the reasons for refusal in the following cases:

1) submission of improperly issued the certificate of examination of the origin of the goods and (or);

2) failure to submit documents proving the origin of the goods, according to the list approved by the competent authority in the field of technical regulation and maintenance of unity of measurements;

3) failure to submit documents proving the origin of the goods, according to the list referred to in paragraph 45 of these Rules.

70. The term of the issuance of a certificate of origin, a duplicate certificate of origin or the written reasoned decision to refuse to issue it can not exceed one working day, and in the cases provided for in paragraph 5 of these Rules, - two

working days from the date of the registration application to the authorized organization.

*** These criteria of sufficient conversion of the goods are applied to the goods of line items 8702, 8704, 8705, made only within implementation of large-scale investment projects. Thus the large-scale investment project is understood as the project on creation or development of production capacities for release of modern agents of the road transport and the automobile components, performed by the legal entity investing in fixed capital at least 0,5 billion tenge on start date of production of the goods. It is necessary to confirm amount of investments with the audit report.

**** These criteria of sufficient conversion of the goods are applied to the goods of line items 8802 12 000 0, made only within implementation of large-scale investment projects. Thus the large-scale investment project is understood as the project on creation or development of production capacities for production of the helicopters, performed by the legal entity investing in fixed capital at least 0,5 billion tenge on start date of production of the goods. It is necessary to confirm amount of investments with the audit report.

Note 1:

1.1. In the first two columns of these criteria of sufficient conversion of the goods data on the product received as a result of conversion of raw materials or materials are specified. In the first column of criteria of sufficient conversion of the goods the product code on TN foreign trade activities TS, is given in the second - the product description according to the code specified in the first column. For each specific product described in the first two columns, the condition, the production or technological operations determining its parentage, (further - conditions and transactions) are specified in the third column.

The goods in criteria of sufficient conversion of the goods are determined only by the commodity code by TN foreign trade activities TS, the description of goods is given only as a matter of convenience usings.

If to the commodity code on TN foreign trade activities TS precedes the pretext "from", it specifies that conditions and transactions in the third column are applied only to the goods which are classified in this goods item and are specified

in the second column. In this case it is necessary to be guided also by the description of goods.

1.2. If numbers of several goods items are provided in the first column or number of group and at the same time with it in the second column there is the generalized product description, the corresponding conditions and the transactions specified in the third column, are applied to all products classified according to TN foreign trade activities TS in goods items, specified in the first column, or to any of the goods items specified in the first column.

1.3. If concerning the part of the goods classified in the same goods item, one conditions and transactions are applied, and concerning another (others) the part (parts) other conditions and transactions are applied, in the second column there is the corresponding number of paragraphs, specific descriptions of the goods are provided in each of which, and respectively in the third column conditions and the transactions, falling into are specified to the goods which descriptions are provided in this or that paragraph of the second column.

Note 2:

2.1. The term "production" means accomplishment of any kinds of production or technological operations, including assembly or any special transactions. Thus it is necessary to mean provisions of the note 3.4.

2.2. The term "material" means any ingredients, raw materials, components, parts, etc., used for production of the product.

2.3. The term "product" means the made product even if it intends for further use in other production operations.

2.4. The term "goods" means both materials, and products.

2.5. The term "the state - the agreement party" means the state - the agreement party about creation of the free trade area from April 15, 1994 and the Protocol on modification and amendments in this Agreement from April 2, 1999.

2.6. The term "the third countries" means the states which are not agreement parties about creation of the free trade area from April 15, 1994 and the Protocol on modification and amendments in this Agreement from April 2, 1999.

Note 3:

3.1. Conditions and the transactions specified in the third column of these criteria of sufficient conversion of the goods, shall be performed only concerning used for production of the product of the materials which are not occurring from the territory of the states agreement parties (further - materials of the foreign origin). The restrictions determined by conditions and transactions in the third column, also extend only concerning used for production of the product of materials of the foreign origin.

3.2. If by conditions and transactions it is determined that in production of the product materials of any goods items can be used, it means that the materials classified in the same goods item, as the product, also can be used under condition

of keeping of special restrictions which can be determined by conditions and transactions.

3.3. If the product made of materials of the foreign origin, acquires the status of the events from the state agreement party where its conversion owing to change of the goods item or owing to the special condition falling into to the nem or transaction according to criteria is performed, and then is used as the material for production of other product, the condition and the transactions applied concerning the product in case of which production it is used, to it are not applied.

3.4. If concerning this or that product accomplishment of criteria of sufficient conversion of the goods is reached (if the rule of the ad valorem share) as a result of carrying out the transactions which are not answering to criteria of sufficient conversion of the goods is applied, this product will not be considered as the events from that country where these transactions took place.

3.5. Object of application of conditions and transactions is this or that product determined as independent object of classification according to rules of classification of the goods on TN foreign trade activities TS. In case of determination of the parentage of sets of the products, classified as such owing to the third ground rule of interpreting of TN foreign trade activities TS, the object of application of conditions and transactions surveys each separate element which is a part of the set.

Respectively:

the product consisting of group of elements or gathered from the series of parts and classified according to provisions TN foreign trade activities TS as the single goods, as a whole is surveyed as object of application of conditions and transactions;

if the batch consists of the identical products classified in the same goods item of TN foreign trade activities TS, each product shall be surveyed separately for the purposes of application of conditions and transactions;

if owing to the fifth ground rule of interpreting of TN foreign trade activities TS packaging is classified together with the products which were in it, packaging shall be surveyed as the component of the goods in case of determination of the parentage of these goods.

3.6. The product consisting of group of elements or gathered from the series of parts and classified according to rules of classification of the goods on TN foreign trade activities TS as the single goods, shall be surveyed as satisfying to conditions and transactions if all its components satisfy to such conditions and transactions.

If the part of components of this product satisfies, and the part does not satisfy to conditions and transactions or has the goods item identical with the finished stock, this product will be considered to satisfying conditions and transactions if cost of the components, not satisfying to conditions and transactions or with the goods item identical with the end product, does not exceed 15 % of the price of ex-works of the end product.

This rule can be applied in all cases, except for those goods for which in criteria other condition is specified.

Note 4:

4.1. Conditions and the transactions given in the third column of these criteria of sufficient conversion of the goods, establish the minimum amount of accomplishment of production or technological operations. Accomplishment of the established production or technological operations in smaller amount does not determine the parentage of the product.

4.2. If conditions and the transactions given in criteria of sufficient conversion of the goods, it is determined that the product can be made of more than one material, it means that one or more material can be used. Thus it is not obligatory, that all materials were used.

However, if within one condition or transaction there is any restriction established concerning one material, and at the same time with it there are other restrictions established concerning other materials, these restrictions are applied only concerning those materials which were really used in case of production of the product.

4.3. If conditions and the transactions given in the list, it is determined that the product shall be made of the certain material, it means that this condition is not the obstacle for use of other materials which owing to their nature cannot violate the situation of this condition or transaction. (For example: if conditions and transactions use of small crops or their derivatives special makes a reservation, it does not interfere with use of inorganic salts, chemical and other additives which are not made from small crops).

SLC - the share of local content in the price of end products, %;

Cost of foreign materials - cost of raw materials and materials of the foreign origin;

Cost of finished product. - cost of finished product at the price "ex-works".
