## **Notification**

### **on goods subject to automatic and non-automatic import or export licensing**

- Pursuant to the Prime Minister's Decree on the Organization and Activities of the Ministry of Industry and Commerce No. 522/PM, dated 23 December 2011;
- Pursuant to Government's Decree on the Import and Export of Goods No. 114/GoL, dated 6 April 2011;
- Pursuant to Prime Minister's Decree on the Goods Import Licensing Procedures No. 180/PM, dated 07 July 2009; and
- Refer to the collaboration with relevant Ministries; and
- In order to provide trade information to facilitate importer and exporter.

### **The Minister of Industry and Commerce hereby issues the following notification:**

1. Goods subject to automatic and non-automatic import or export licensing are as following:
  - Goods subject to automatic import licensing listed in annex A.I;
  - Goods subject to non-automatic import licensing listed in annex A.II;
  - Goods subject to automatic export licensing listed in annex B.I; and
  - Goods subject to non-automatic export licensing listed in annex B.II.
2. The import or export of those goods which are not listed in the annexes of this Notification may be cleared directly with the Customs; except for goods which are directly governed by treaties to which Lao PDR is a party, goods subject to the sanitary and phyto-sanitary measures or technical regulations, which shall comply with relevant regulations prior to customs clearance.
3. This Notification is effective on the date of signature and replaces Notification No. 0826/MoIC.DIMEX, dated 03 May 2011.
