

Pursuant to article 2 paragraph 2 of the Law on Quality Control of the Agricultural and Food Products in the Foreign Trade (Official Gazette of the Republic of Macedonia no. 5/98) and article 46, paragraph 3 of the Law on the Government of the Republic of Macedonia (Official Gazette of SRM no. 38/90 and Official Gazette of RM no. 63/94), the Government of the Republic of Macedonia, on the session held on October 26, 1998, passed the following

**DECISION**  
**ON DETERMINING AGRICULTURAL AND FOOD PRODUCTS**  
**AND THEIR PROCESSINGS THAT ARE SUBJECT TO QUALITY**  
**CONTROL IN THE FOREIGN TRADE**

1. The following agricultural and food products and their processings (hereinafter: products) shall be subject to quality control in the foreign trade:

**A. Products that are imported**

1. meat of cattle for slaughtering, poultry and game (chilled and frozen);
2. interior organs, fat tissues and other parts of the cattle for slaughtering, poultry and game that serve for nutrition (chilled, frozen, salted, brined);
3. meat products from cattle for slaughtering, poultry and game (salted, brined, cured, smoked, thermally processed, etc.);
4. fish, crustaceans, mussels and snails (chilled and frozen);
5. fish, crustaceans, mussels and snail products (cured, salted, smoked, thermally processed, frozen, etc.);
6. milk and dairy products;
7. rennet and milk cultures;
8. ice-cream and ice-cream powder;
9. eggs and egg products;
10. citrus fruit and citrus fruit products;
11. continental fruit and continental fruit products;
12. watermelons and melons and their products;
13. vegetable and vegetable products;
14. mushrooms and mushroom products;
15. pectic preparation;
16. peanuts and peanut products;
17. coffee (raw, fried, coffee extracts), coffee surrogates, etc.;
18. tea;
19. spices;
20. mustard;
21. sodium glutamate;
22. cooking salt and brining salt;
23. soup concentrates;
24. baking yeast, baking powder and pudding powder, etc.;
25. dietetic products;
26. additives and other additional ingredients for the food industry;
27. cereals for human nutrition (not peeled and peeled);
28. milling products of cereals for human nutrition;
29. pasta and similar products;
30. biscuits and similar products;

31. fats and vegetable oils and their products;
32. mayonnaise and products similar to mayonnaise;
33. raw materials of vegetable origin for production of fats and oils;
34. sugar and starch and their products;
35. other saccharides and their products;
36. raw materials for production of sugar and starch;
37. honey and honey products;
38. cacao, cocoa products, chocolate and products similar to chocolate, candy products, chewing gums, etc.;
39. grape and grape products;
40. wine and wine products;
41. enological means;
42. alcohol beverages (natural rakia, spirits, liqueurs and other alcohol beverages);
43. beer;
44. soft drinks;
45. raw materials and semi-products for production of alcohol and soft beverages;
46. raw materials and semi-products for production of beer;
47. denatured alcohol and raw materials for its production;
48. vinegar and acetic acid;
49. fodder (feeding mixtures, sub-mixtures and fodder mixtures) and fodder additives;
50. tobacco in leaf and cut tobacco, and
51. pets food.

#### **B. Products that are exported**

1. lamb (chilled and frozen);
2. meat cans, preserved vegetable and fruit;
3. wine;
4. tobacco in leaf and cut tobacco, and
5. sour cheery.

2. On the day this Decision becomes effective the Decision on Determining Agricultural and Food Products and their Processings that are Subject to Quality Control in the Foreign Trade (Official Paper of SFRY no. 55/79 and 61/80) shall cease to be effective.

3. This Decision shall become effective on the eight day following the date of its publishing in the Official Gazette of the Republic of Macedonia.
