

FEDERAL LAW  
NO. 106-FZ OF MAY 31, 1999  
ON THE PLOTS OF SUBSOIL THE RIGHT TO USE WHICH MAY BE GRANTED  
ON THE CONDITIONS OF THE SHARING OF THE PRODUCTS (THE LUGINETSKOYE,  
FYODOROVSKOYE AND OTHER OIL AND GAS-CONDENSATE FIELDS)

This Federal Law shall determine the plots of subsoil, including deposits of mineral resources (hereinafter, the objects), the right to use which may be granted on the conditions of the sharing of the products of the sharing of the products in accordance with the provisions of the Federal Law on the Agreements for the Sharing of Products.

Article 1. To refer the Luginetskoye oil and gas-condensate field situated on the territory of the Tomsk Region to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 2. To refer the Fyodorovskoye oil and gas-condensate field situated on the territory of the Khanty-Mansi Autonomous Area to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 3. To refer the Permo-Carbonic pool of the Usinskoye oil field situated on the territory of the Republic of Komi to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 4. To refer the Udmurt bidding plot of subsoil, including 12 oil fields (Byginskoye, Vostochno-Postolskoye, Zabegalovskoye, Korobovskoye, Oblastnovskoye, Tukmachovskoye, Chernovskoye, Chuboiszkoye, and Yuskinskoye), situated on the territory of the Udmurt Republic to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 5. To refer the Zimneye, Pikhtovoye, Severo - Demyanskoye, Urnenskoye and Ust-Tegusskoye oil fields, and the Tanyagsky, Keumsky, Komariny, Lumkoisky, Nelymsky, Tamargino - Severo - Bolotny, Sredne-Demyansky, Tyumsky, Shalimovsky and Yaroksky prospective plots included in the Uvatsky project and situated on the territory of the Tyumen Region, to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 6. To refer the Salymkaya group of oil fields (Vadelypskoye, Verkhne-Salymkoye and Zapadno-Salymkoye) situated on the territory of the Khanty-Mansi Autonomous Area to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 7. To refer the plots of subsoil, situated on the territory of the Republic of Komi, of Block 15 and the Yuzhno-Lyzhskoye and Severo-Kozhvinskoye oil fields located outside the limits of the said block, to the objects the right to use which may be granted on the conditions of the sharing of the products.

Article 8. To refer the Yurubchensky block of the Yurubcheno-Tokhomskoye oil and gas-condensate field situated on the conditions of the sharing of the products.

Article 9. The objects mentioned in Article 1 to 8 of this Federal Law shall be referred to the list of the plots of subsoil, including the deposits of mineral resources in whose respect as from the day of the entry into force of this Federal Law there may be conducted talks and concluded agreements for the search, prospecting and production of mineral raw materials on the conditions of the sharing of the products.

In the interests of the economic security of the Russian Federation the talks and the conclusion of agreements for the search, prospecting and production of mineral raw materials on the conditions of the sharing of the products with respect to the plots of subsoil mentioned in Articles 1 to 3 and 5 to 8 of this Federal Law, by a joint decision of the Government of the Russian Federation and the body of the executive power of the relevant entity of the Russian Federation, shall be carried out with the juridical persons that are the users of the indicated plots of subsoil without conducting any biddings or auctions. The transfer of the rights and duties under the agreements for the search, prospecting and production of mineral raw materials on the conditions of the sharing of the products to third parties without the consent of the state shall not be permissible.

Article 10. This Federal Law shall enter into force as from the day of its official publication.
