## DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 866 OF JULY 30, 1999

## ON THE ENSURING OF THE DELIVERIES OF CERTAIN TYPES OF OIL PRODUCTS TO CONSUMERS OF THE RUSSIAN FEDERATION

For the purpose of effecting guaranteed deliveries to consumers of the Russian Federation of certain types of oil products ensuring the normal activity of the population and the functioning of the branches of economy of the Russian Federation, and creating the conditions for the energy safety of the state, the Government of the Russian Federation resolves:

- 1. In accordance with the proposal of oil companies, the Ministry of Fuel and Power of the Russian Federation in agreement with the Ministry of Economics of the Russian Federation shall temporary from August 1, 1999 to December 1, 1999 establish before the 15th day of a current month to oil-refining organizations of the Russian Federation the balance tasks for the deliveries to consumers of the Russian Federation of certain types of oil products according to the Annex as a per cent of the total volume of their manufacture for all the owners of the oil products.
- 2. The Ministry of Fuel and Power of the Russian Federation and the Interdepartmental Commission for the Regulation of the Issues Connected with the Use of the System of the Main Oil and Oil-Products Pipelines and terminals at the Seaports for the Exportation of Oil and Oil Products beyond the limits of the customs territory of the Russian Federation, shall every month adjust the schedules of the transportation of oil by the system of the main oil pipelines with regard to the fulfilment by the oil refining organizations of the balance tasks established in accordance with Item 1 of this Decision.
- 3. To establish that as from August 1, 1999 to December 31, 1999 the clearance of the export of oil products by the customs bodies shall be effected upon the submission by the oil refining organizations in accordance with the form established by the Ministry of Fuel and Power of the Russian Federation in agreement with the State Customs Committee of the Russian Federation, of resource certificates confirming the presence with the organizations carrying out the export, of oil products in volumes sufficient for the clearance of the export with regard to the balance tasks established in accordance with Item 1 to this Decision.
