

**DECISION  
OF THE GOVERNMENT OF THE RUSSIAN FEDERATION  
NO. 1033 OF SEPTEMBER 8, 1994  
ON SOME MEASURES TO DEVELOP THE NAKHODKA FREE ECONOMIC ZONE**

In order to ensure the comprehensive socio-economic development of the Nakhodka Free Economic Zone and the Primoriye Territory as a whole, to attract foreign investments in the economy of Russia and to develop the trade and economic ties with the countries of the Asian and Pacific region, the Government of the Russian Federation resolves:

*Concerning some measures for promoting the investment activity in the free economic zone Nakhodka see [Decree](#) of the President of the Russian Federation No. 345 of March 9, 1996*

**1.** The Ministry of Finance of the Russian Federation shall be instructed to grant, up to the year 2000, to the administrations of the city of Nakhodka and the Partizan District of the Primoriye Territory budget credits on a contractual basis in order to develop the priority projects of the infrastructure of the Nakhodka Free Economic Zone.

**2.** The Ministry of Economics, the State Customs Committee, the Ministry of Foreign Economic Relations and the Ministry of Finance of the Russian Federation shall be obliged to consider, in the statutory manner, the proposals of the administrations of the Primoriye Territory, the city of Nakhodka and the Partizan District of this Territory on setting up free customs zones and industrial complexes in the territory of the city of Nakhodka and the Partizan District of the Primoriye Territory.

**3.** To accept the proposal made by the administration of the Primoriye Territory and agreed upon with the Ministry of Economics, the Ministry of Defense, the Ministry of Transport and the State Customs Committee of the Russian Federation on conferring the status of joint basing to the Zolotaya Dolina airfield.

By agreement with the federal executive bodies, the administrations of the Primoriye Territory, the city of Nakhodka and the Partizan District of this Territory shall be obliged to build and put into operation the freight and passenger terminals, office premises for control services in the Zolotaya Dolina airfield, and other projects needed for its functioning.

**4.** The Ministry of Communication of the Russian Federation shall be obliged to consider, within a month, the proposals of the administrations of the city of Nakhodka and the Partizan District of Primoriye Territory regarding the provision of these city and district with modern means of communication.

**5.** The State Committee for State Property Management, the Ministry of Transport, the Fishing Committee and the State Committee of the Russian Federation for Antimonopoly Policy and Support for New Economic Structures shall be obliged to consider the proposals of the administration of the Primoriye Territory on the creation of a single maritime administration of the ports of the city of Nakhodka on the basis of the sea administrations of the trade and fishing ports.
