DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 720 OF NOVEMBER 29, 2003 ON THE TARIFF REGULATION OF THE IMPORT OF RAW SUGAR AND WHITE SUGAR IN 2004

This Decision shall enter into force as of January 1, 2004, except Items 2 and 3 entering into force from the day of its official publication

The Government of the Russian Federation resolves:

- **1.** To amend the <u>Customs Tariff</u> of the Russian Federation, approved by <u>Decision</u> of the Government of the Russian Federation No. 830 of November 30, 2001 on the Customs Tariff of the Russian Federation and the Commodity Classification to Be Applied in Foreign Economic Activity (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 2001, No. 50, item 4735; 2002, No. 29, item 2967), as follows:
- a) to eliminate from the Commodity Classification of Foreign Economic Activity of the Russian Federation the subheadings according to Annex No. 1;
- b) to include in the Commodity Classification of Foreign Economic Activity of the Russian Federation the subheadings according to Annex No. 2;
 - c) to approve the annexed <u>rates</u> of the import customs duties on raw sugar and white sugar.
- 2. The Ministry of Economic Development and Trade of the Russian Federation shall ensure the conduct of a monitoring of the prices of raw sugar at the New York Commodity and Raw-Materials Exchange for the purpose of determining its average monthly price.

To establish that the average monthly price shall be calculated each month as the arithmetic-mean of the prices of raw sugar at the New York Commodity and Raw-Materials Exchange under the current contract for all days of the tenders (as on the moment of the closure of the tenders).

- **3.** The Ministry of Economic Development and Trade of the Russian Federation shall each month, before the 15th day submit to the State Customs Committee of the Russian Federation the data on the average monthly price of raw sugar at the New York Commodity and Raw-Materials Exchange for the preceding month and publish them in the mass media.
- **4.** The State Customs Committee of the Russian Federation shall, in the customs clearance of the goods indicated in <u>Annex No. 2</u> to this Decision and imported in accordance with the customs regime of <u>release for internal consumption</u>, collect the import customs duties proceeding from the data submitted by the Ministry of Economic Development and Trade of the Russian Federation on the average monthly price of raw sugar at the New York Commodity and Raw-Materials Exchange from the first day of the month following of the submission of such data.
- **5.** This Decision shall enter into force as of January 1, 2004, except <u>Items 2</u> and $\underline{3}$ entering into force from the day of its <u>official publication</u>.
