DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 758 OF JULY 1, 1994 ON MEASURES TO IMPROVE THE STATE REGULATION OF EXPORT OF GOODS AND SERVICES

(with the Additions and Amendments of December 31, 1994,
October 12 and 13, November 5, December 15, 1995,
March 16 and 21, December 27, 1996, January 11, 1999, February 22, 2000, November 30, 2001)

On the realization of measures to improve the state regulation of the export of goods and services see Order of the State Customs Committee of Russia No. 353 of July 11, 1994

In pursuance of the <u>Decree</u> of the President of the Russian Federation No. 1007 of May 23, 1994 on the Revocation of the Quota Allocation and Licensing of Deliveries of Goods and Services for Export (Collected Acts of the President and the Government of the Russian Federation, No. 5, 1994, item 397), the Government of the Russian Federation resolves:

1. The Ministry of Foreign Economic Relations of Russia, the Ministry of Economics of the Russian Federation and the interested ministries and departments of the Russian Federation shall be instructed not to allocate in quotas and license the deliveries of goods for export as of July 1, 1994, with the exception of deliveries of goods as per <u>Appendix No. 1.</u>

<u>Decree</u> of the President of the Russian Federation No. 1552 of November 16, 1996 recognized as abolished <u>Item 1</u> of the above mentioned Decree which had established that beginning from June 1, 1994 the quota distribution and licensing of the deliveries of goods and services for export shall be effected only with regard to the goods and services exported in keeping with the international commitments of the Russian Federation

Concerning the Procedure for the Quota Allocation and Licensing of Delivery of Goods for Export in Accordance with the International Obligations of the Russian Federation see Letter of the Ministry of Foreign Economic Relations of the Russian Federation, the Ministry of Economics of the Russian Federation and the State Customs Committee of the Russian Federation, the Russian Committee for Metallurgy and the Russian Committee for Chemical and Petrochemical Industry No.01-20/3124 of December 19 and 21, 1994 and of March 3 and 15, 1995

2. To establish that a special order of export shall be retained in respect of goods indicated in Appendix No. 2 in accordance with legislation already in force.

<u>Decision</u> of the Government of the Russian Federation No. 1110 of November 5, 1995 recognized Item 3 of this Decision as abolished

3. To establish that strategic primary goods shall be exported as of July 1, 1994 by enterprises and organizations registered by the Ministry of Foreign Economic Relations of Russia for these purposes in the statutory manner.

<u>Decree</u> of the President of the Russian Federation No. 245 of March 6, 1995 established that from March 25, 1995 export of strategically important raw material goods shall be carried out without registration of exporting organizations in the Ministry of External Economic Relations of Russia

The Ministry of Foreign Economic Relations of Russia shall be obliged to specify, before October 1, 1994, the list of enterprises and organizations registered as exporters of strategical primary goods, proceeding from the efficacy of their foreign economic activity and bearing in mind the reduction of the number of these enterprises and organizations.

Item 4 of the present Decision was recognized as abolished according to <u>Decision</u> of Government of the Russian Federation No. 300 of March 21, 1996

4. To introduce the registration of contracts for the export of strategic primary goods (Appendix No. 3) for the purpose of state control over their export.

The Ministry of Foreign Economic Relations of Russia, the Ministry of Economics of the Russian Federation, the State Customs Committee of Russia, the Ministry of Justice of the Russian Federation and other interested ministries and departments of the Russian Federation shall be obliged to design and approve the procedure for the registration of contracts for the export of said goods within one month.

To establish that this procedure for the registration of contracts shall be applicable to the export of said goods by all the transactor units in the territory of the Russian Federation, regardless of the forms of property, or the identity and place of registration, except for the cases provided for by the legislation of the Russian Federation, and also by the international agreements of the Russian Federation.

The State Customs Committee of Russia shall be obliged to clear goods referred to in Appendix No. 3 only under the registered contracts.

Item 5 of the present Decision was recognized as abolished according to <u>Decision</u> of Government of the Russian Federation No. 300 of March 21, 1996

5. The Ministry of Foreign Economic Relations of Russia, the State Customs Committee of Russia and the Ministry of Finance of the Russian Federation shall be obliged to analyze the efficacy of the registration of export contracts according to the results of their work in the third quarter of 1994 and to introduce the respective amendments and addenda to the present normative documents, in conformity with which foreign currency and export control is being exercised today.

To recommend that the Central Bank of the Russian Federation take part in this work.

<u>Decision</u> of the Government of the Russian Federation No. 479 of April 1, 1996 abolished, as from April 1, 1996, the export customs duties on all goods, with the exception of oil and gas condensate

6. To retain, in 1994, the customs facilities with regard to the collection of customs duties from goods exported to the foreign countries, former members of the USSR, in keeping with intergovernmental agreements.

<u>Decision</u> of the Government of the Russian Federation No. 1009 of October 13, 1995 recognized Item 7 of this Decision as abolished

- 7. The Ministry of Finance of the Russian Federation, the Ministry of Economics of the Russian Federation, the Ministry of Foreign Economic Relations of Russia and the State Customs Committee of Russia shall be instructed to submit to the Government of the Russian Federation their proposals on the appropriation of some receipts by the federal budget from export customs duties to the subjects of the Russian Federation for the purpose of creating equal economic conditions for all the subjects of the Russian Federation.
- **8.** The Ministry of Foreign Economic Relations of Russia, the Ministry of Finance of the Russian Federation, the Ministry of Economics of the Russian Federation, the State Customs Committee of Russia, the Ministry of Justice of the Russian Federation, and other interested ministries and departments shall be instructed to submit to the Government of the Russian Federation their proposals on the introduction of amendments to the decisions of the Government of the Russian Federation and on the recognition as invalid of some of its decisions in connection with the adoption of the present Decision.
