ON ENDORSING THE REGULATIONS ON SETTING THE RATE OF THE FEE FOR SETTING, RESETTING AND EXTENDING THE EFFECTIVE TERM OF LICENSES FOR THE EXPORT AND IMPORT OF GOODS (WORKS, SERVICES), BARTER DEAL CERTIFICATES AND PASSPORTS

## Regulations

on Setting the Rate of the Fee for Setting, Resetting and Extending the Effective Term of Licences for the Export and Import of Goods (Works, Services),
Barter Deal Certificates and Passports
(Endorsed by Order of the Ministry of Trade of the Russian Federation, No. 363, of August 6, 1999)

- 1. The present Regulations have been eLabourated in compliance with <a href="Item 15">Item 15</a> of the Regulations on the Procedure for Licencing the Export and Import of Goods (Works, Services) in the Russian Federation endorsed by <a href="Decision">Decision</a> of the Government of the Russian Federation No. 1299 of October 31, 1996 on the Procedure for Holding Tenders and Auctions for the Sale of Quotas when Quantitative Limitations and the Licencing of Import and Export of Goods (Works, Services) Are Instituted in the Russian Federation (Sobranie Zakonodatelstva Rossiskoy Federatsii, item 5249, No. 46, November 11, 1996), <a href="Item 5">Item 5</a> of Decision of the Government of the Russian Federation No. 1300 of October 31, 1996 on the Measures of State Regulation of Foreign Trade Barter Deals (Collection of the Legislation of the Russian Federation, item 5250, No. 46, November 11, 1996) and <a href="Item 2">Item 2</a> of Order of the Council of Ministers the Government of the Russian Federation No. 693-r of April 22, 1993 (Sobranie Aktov Prezidenta i Pravitelstva Rossiiskoi Federatsii, item 1588, No. 17, April 26, 1996).
- **2.** The rate of fee payable for making, remaking and extending the effective term of one-off licences for the export and import of goods (works, services) as well as barter deal passports is hereby set at 30 times the <u>minimum wage rate</u>, for general licences at 150 times the minimum wage rate, and for certificates at 15 times the minimum wage rate.
  - **3.** The following shall be submitted to the Ministry of Trade of the Russian Federation:
- an application for the setting or resetting or extending the effective term of a licence for the export or import of goods (works, services), <u>barter deal certificate and passport</u>;
- a copy of the payment order for the remittance of a respective amount to the current account of the Ministry of Trade of the Russian Federation and the other documents as provided in the legislation of the Russian Federation.
  - 4. The monies received for the consideration of the documents for the setting, resetting and
