ON AMENDING ORDER OF THE STATE CUSTOMS COMMITTEE
OF RUSSIA NO. 258 OF APRIL 26, 1996
(IN THE WORDING OF ORDER OF THE
STATE CUSTOMS COMMITTEE OF RUSSIA NO. 43 OF JANUARY 31, 1997)
(with the Amendments and Additions of March 10, 2000)

In execution of Decisions of the Government of the Russian Federation [No. 1333 of December 4, 1999](#) on Partial Amendment of the Rates of Import Customs Duties, Approved by Decision of the Government of the Russian Federation, No. 1560 of December 27, 1996 and [No. 1334](#) on Partial Amendment of the Rates of Import Customs Duties, Approved by Decision of the Government of the Russian Federation No. 1560 of December 27, 1996 ([published](#) in Rossiyskaya gazeta of December 8, 1999) I hereby order:

[Order](#) of the State Customs Committee of the Russian Federation No. 176 of March 10, 2000 abolished Item 1 of this Order as of April 1, 2000

~~1. That [Annex 1](#) to Order of the State Customs Committee of Russia No. 258 of April 26, 1996 (in the wording of [Annex 5](#) to Order of the State Customs Committee of Russia No. 43 of January 31, 1997) shall be amended according to the [Annexes](#).~~

2. The application from December 8, 1999 of the rates of import customs duties, with respect to the goods indicated, as in [Annex 1](#) to this Order.

~~3. The application from December 8, 1999 till June 7, 2000 inclusive the of rates of the import customs duties, with respect to the goods indicated, as in [Annex 2](#) to this Order.~~

4. The recalculation of the amounts of the charged and/or made customs payments in accordance with this Order with respect to the goods submitted for the customs clearance as from December 8, 1999.

The amounts of the excessively exacted and/or made customs payments shall, upon application of the person that paid them, be returned in accordance with the established procedure in the currency of the payment from the accounts of the customs houses or, upon application of the payer, be set off in account of future payments.

The unpaid amounts of import customs duties shall, in accordance with this Order, be exacted from juridical persons indisputably and from the others, judicially.

The numbering of the items is given in conformity with the source

4. The Press Service of the State Customs Committee of Russia (V.A.Yemelyanov) shall ensure the coverage of the provisions of this Order in the mass media.

5. The heads of the regional customs departments and the heads of the custom houses to ensure the bringing of the provisions of this Order to the notice of all the persons concerned.

6. Control over the execution of this Order shall be exercised by the Deputy Chairman of the State Customs Committee of Russia, A.A.Kaulbars.
