

**DECREE OF THE PRESIDENT OF THE RUSSIAN FEDERATION NO. 1203 OF NOVEMBER 30, 1995 ON THE APPROVAL OF THE LIST OF DATA REFERRED TO THE STATE SECRETS (with the Amendments and Additions of January 24, 1998, June 6, September 10, 2001, May 29, 2002, March 3, 2005, February 11, 2006, December 24, 2007, April 8, 2008)**

In accordance with Article 4 of the Law of the Russian Federation on the State Secret, I resolve:

1. To approve the appended List of data referring to the state secrets.
2. The government of the Russian Federation shall organize the work of bringing the current normative acts into conformity with the list of data referring to the state secrets.
3. The present Decree shall enter into force since the day of its signing.

**The Notes:** 1. The List of information, referred to the state secret, contains information in the military area, in the area of economy, science

and technology, of foreign policy and economy, and of intelligence, the counter-intelligence and operative-search activity, the dissemination of which may inflict damage upon the security of the Russian Federation, and also the names of the government bodies and organisations endowed with powers for the disposal of this information.

2. Each state body and each organisation indicated in the present list shall be invested with the powers of disposing the data of the branch (departmental) belonging within the limits of their jurisdiction, and also the data of other holders of information of the corresponding thematic direction upon their proposal;

3. The following concepts are used in the present List:

**military hardware** - the technical facilities intended for the combat, technical and rear provisions for the troops' activity, as well as the equipment and apparatuses for exerting control over and for testing these facilities, the component parts of these facilities and the completing units;

**military objects** - the combat positions of the troops, military formations and stationary command posts, the military scientific-research organizations, testing grounds, communication points, store-houses, complexes or individual buildings, and the other military-purpose structures;

**troops** - the Armed Forces of the Russian Federation and the other troops and military formations, as well as special formations created for the wartime, which are stipulated in Federal Law No. 61-FZ of May 31, 1966 on the Defence, and the special-purpose communication subdivisions;

**armaments** - the means intended for inflicting defeat upon the enemy manpower, hardware, installations and other objects, and the component parts and completing units of these means;

**dislocation of an object** - the aggregate of information on the object's location on the land surface or underground, including the geographical, geocentrical or rectangular coordinates, linear and angular values, as well as its orientation on the landmarks in the locality;

**infrastructure of the Russian Federation's economy** - the branches of the economy of the Russian Federation, whose functioning is aimed at providing for the defence capability and the security of the state;

**objects of the administrative management** - the objects of mobilizational importance, intended for the placement and providing for the activity of the corresponding management body in the period of mobilization and in the wartime, which are created in advance by decision on the heads of the federal state power bodies, of the state power bodies of the subjects of the Russian Federation, of local self-government bodies and of organizations;

**objects of the nuclear complex** - the installations equipped with nuclear reactors, including atomic power plants, ships and the other floating facilities, space and flying apparatuses and the other transportation and transportable facilities or installations with industrial, experimental and research nuclear reactors, or with critical or subcritical nuclear stands; the

installations, testing grounds, facilities and devices with nuclear charges; and the other installations containing nuclear materials, as well as installations for the output, utilization, processing and transportation of nuclear fuel and nuclear materials;

**regime objects** - the objects, in which the works are carried out with the use of information comprising the state secret, and for whose functioning special security measures are established.

4. In Items 32-35, 37 and 44 of the present List, the government bodies and organisations are pointed out, whose heads are endowed with powers for referring information to the state secret.

5. In Items 38-40 of the present List are indicated the strategical kinds of raw and other materials and of fuel, the list (the lists) of which is (are) compiled in the framework of their competence and by mutual consent by the government bodies and organisations endowed with powers for the disposal of information, referred to the state secret.

6. In the present List:

- when information is enumerated with the conjunction "and", or with a comma and the conjunction "and" before the last category of information, all information in aggregate shall be referred to the state secret;

- when information is enumerated with a comma or with the conjunction "or", to the state secret shall be referred every piece of information, taken separately;

- information, enumerated after the conjunction "as well as", shall be seen as new information, distinct from the previous information, which is referred to the state secret as taken separately.
