

**DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION
NO. 197 OF MARCH 31, 2007 ON THE INTRODUCTION OF
AMENDMENTS TO SOME DECISIONS OF THE GOVERNMENT OF THE
RUSSIAN FEDERATION ON THE FUNCTIONING OF THE SINGLE
STATE AUTOMATED INFORMATION SYSTEM OF ACCOUNTING THE
VOLUME OF THE PRODUCTION AND SALE OF ETHYL ALCOHOL,
ALCOHOLIC DRINKS AND SPIRIT-CONTAINING PRODUCTS**

The Government of the Russian Federation resolves:

1. To add Subitem 5.3.6 to Item 5 in the Statute of the Federal Tax Service, approved by Decision of the Government of the Russian Federation No. 506 of September 30, 2004 (Sobraniye Zakonodatelstva Rossiyskoy Federatsii No. 40, 2004, item 3961; No. 8, 2005, item 654; No. 48, 2005, item 5042; No. 23, 2006, item 2510; No. 24, 2005, item 2602; No. 33, 2005, item 3638; No. 52, 2005, item 5587):

"**5.3.6.** the functions of the state customer of the works of elaborating and modernising the softwares of the single state automated information system of accounting the volume of the production and sale of ethyl alcohol, alcoholic drinks and spirit-containing products";

2. Item 2 in Decision of the Government of the Russian Federation No. 873 of December 31, 2005 on the Requirements for the Technical Means of the Fixation and the Transfer of Information About the Volume of the Production and Sale of Alcoholic Drinks (Sobraniye Zakonodatelstva Rossiyskoy Federatsii No. 5, 2006, item 541) shall be worded as follows:

"2. To lay down that the softwares of the single state automated information system of accounting of the volume of the production and the sale of ethyl alcohol, alcoholic drinks and spirit-containing products (hereinafter referred to softwares and the single information system accordingly), set in the technical means of fixation and the transfer of information about the volume of the production and the sale alcoholic drinks to the single information system, which include the remedies of information preventing the distortion and the falsification of fixed and transferred information about the volume of the production and the sale of alcoholic drinks, and created in accordance with the technical assignments endorsed by the Federal Tax Service by agreement with the Federal Customs Service and the Federal Security Service of the Russian Federation".

3. Item 2 in Decision of the Government of the Russian Federation No. 253 of April 28, 2006 on the Requirements for the Technical Means of the Fixation and Transfer of Information About the Volume of the Production and the Sale of Ethyl Alcohol and Spirit-containing Products (Sobraniye Zakonodatelstva Rossiyskoy Federatsii No. 19, Item 2079) shall be worded as follows:

"2. To lay down that the softwares of the single state automated information system of accounting the volume of the production and the sale

of ethyl alcohol, alcoholic drinks and spirit-containing products (hereinafter referred to as softwares and the single information system accordingly) installed in the technical means of fixation and the transfer of information about the volume of the production and sale of ethyl alcohol and spirit-containing products (hereinafter referred to as technical means), which include the remedies of information preventing distortions and falsification of the fixed and transferred information about the volume of production and the sale of ethyl alcohol and spirit-containing products and which are set up in accordance with the technical assignments, approved by the Federal Tax Service by agreement with the Federal Customs Service and the Federal Security Service of the Russian Federation."

4. The third paragraph of Item 2 in Decision of the Government of the Russian Federation No. 522 of August 25, 2006 on the Functioning of the Single State Automated Information System of Accounting of the Volume of the Production and Sale of Ethyl Alcohol, Alcoholic Drinks and Spirit-containing Products (Sobraniye Zakonodatelstva Rossiyskoy Federatsii No. 36, 2006, item 3830) shall be worded as follows:

"the softwares of the single information system installed in the technical means of the single information system, which are used by tax and customs bodies for the fixation and the transfer of information about the production and sale of ethyl alcohol, alcoholic and spirit-containing products and the functioning of the single information systems and which are created in accordance with the technical assignments approved by the Federal Tax Service by agreement with the Federal Customs Service and the Federal Security Service of the Russian Federation.
