

DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 626 OF OCTOBER 14, 2003 ON THE EXEMPTION FROM THE CUSTOMS DUTY OF CERTAIN GOODS (EQUIPMENT, INCLUDING ACCESSORIES AND SPARE PARTS THEREOF) (with the Amendments and Additions of August 7, 2004, March 29, April 6, December 28, 2005, September 16, 26, November 27, December 30, 2006)

In accordance with the Federal Law on Amending and Supplementing Article 35 of the Law of the Russian Federation on the Customs Tariff (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 2003, No. 28, item 2893) the Government of the Russian Federation resolves:

1. To approve the annexed:

list of goods (equipment, including accessories and spare parts thereof) that have been (are) imported into the customs territory of the Russian Federation under agreements (arrangements, contracts) whose financing had been opened before August 1, 1998 inclusive and has been carried out from the tied credits of the governments of foreign states, banks and firms attached under the guarantees of the Government of the Russian Federation;

list of organisations and agreements (arrangements, contracts) concluded by them for the delivery of goods (equipment, including accessories and spare parts thereof) whose financing had been opened before August 1, 1998 inclusive and has been carried out from the tied credits of the governments of foreign states, banks and firms attached under the guarantees of the Government of the Russian Federation.

2. To establish that the customs duties not paid as on the moment of the entry into force of the Federal Law on Amending and Supplementing Article 35 of the Law of the Russian Federation on the Customs Tariff which are covered by the effect of this Decision, and also the penalties and fines in connection with the nonpayment of the said customs duties, shall not be paid and shall not be exacted.

3. To establish that the return of the earlier paid customs duties with respect to the goods imported into the customs territories of the Russian Federation which are covered by the effect of this Decision, and also the penalties and fines in connection with their tardy payment, shall not be carried out.
