

**DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION  
NO. 466 OF JULY 23, 2007 ON THE INTRODUCTION OF  
AMENDMENTS TO THE LIST OF THE CODES OF FOODSTUFFS IN  
ACCORDANCE WITH THE ALL-RUSSIA CLASSIFIER OF THE  
PRODUCTS ASSESSED BY THE VALUE-ADDED TAX AT THE TAX  
RATE OF TENS PERCENT DURING THE REALISATION, APPROVED  
BY DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION  
NO. 908 OF DECEMBER 31, 2004**

The Government of the Russian Federation resolves:

1. To endorse the appended amendments to be introduced to the list of the codes of foodstuffs in keeping with the All-Russia Classifier of Products Assessed by the value-added tax at the tax rate of 10 per cent during sale, approved by Decision of the Government of the Russian Federation No. 908 of December 31, 2004 on the Approval of the Lists of Codes of the Foodstuffs and Goods for Children Assessed by the value-added tax at the tax rate of 10 per cent (Sobraniye Zakonodatelstva Rossiyskoy Federatsii No. 3, 2005, item 196; No. 13, 2002, item 1180; No. 10, 2006, item 1106).

2. The present Decision shall come into force upon the expiry of one month since the day of its official publication, but not earlier than the first of the next tax period for the value-added tax.
