DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 854 OF NOVEMBER 6, 1992 ON THE LICENSING AND ALLOCATION OF EXPORTS AND IMPORTS OF GOODS (WORK, SERVICES) IN THE RUSSIAN FEDERATION (with the Amendments and Additions of March 30, August 13, November 2, 1993, and January 24, April 15, December 31, 1994, March 16, July 1, October 31, December 27, 30, 1996, May 27, 1997, February 2, 1998, February 22, 2000, November 30, 2001, May 23, 2002, November 27, 2006)

With a view to exercising state control over foreign economic activities in the Russian Federation, as provided for by the Russian Federation Law on Deliveries of Products and Goods for State Needs, improving the single mechanism of regulation of foreign economic activities on the territory of the Russian Federation and safeguarding the implementation of international treaties of the Russian Federation, the Government of the Russian Federation hereby resolves:

1. To establish as of January 1, 1993, in the Russian Federation, a single procedure for licensing and allocating exports and imports of goods (work, services), including supplies to members of the Commonwealth of Independent States, Azerbaijan, Georgia, Latvia, Estonia and Lithuania.

The procedure established by this Decision for licensing and allocating exports and imports of goods shall apply to all subjects of economic activity in the Russian Federation, irrespective of forms of ownership, affiliation or place of registration, excluding cases stipulated by Russian Federation law, as well as by the international treaties of the Russian Federation.

To approve:

the list of goods exported under license in the amount of set quotas as per Appendix 2;

the list of specific goods (work, services) exported under license as per Appendix 3;

the list of specific goods (work, services) exported under license as per Appendix 4;

the list of goods exported and imported as specified by the President of the Russian Federation and the Government of the Russian Federation as per Appendix 5.

- 2. To entrust the Ministry of the Russian Federation for Nuclear Energy with the task of submitting, before November 15 1992, in conjunction with the Federal Service of Russia for Supervision over Nuclear and Radiation Safety, the Ministry for Foreign Economic Relations of the Russian Federation, and other interested ministries and departments, to the Government of the Russian Federation the procedure for exporting and importing fissionable materials, technology, equipment, power plants, special nonfissionable materials and sources of radioactive radiation and isotope products.
- 3. To entrust the Committee of the Russian Federation on Precious Metals and Precious Stones with the task of submitting, before December 1 1992, in conjunction with the Ministry of Foreign Economic Relations of the Russian Federation and other interested ministries and departments, to the Government of the Russian Federation, the procedure for exporting and importing goods containing precious metals and stones.
- 4. To entrust the Ministry of Public Health of the Russian Federation with the task of submitting , before December 15 1992, in conjunction with the Ministry of Internal Affairs of the Russian Federation, the Ministry of Security of the Russian Federation, the Ministry for Foreign Economic Relations of the Russian Federation, and other interested ministries and departments, to the Government of the Russian Federation, the procedure for exporting and importing narcotic, psychotropic drugs and poisons.
- 5. Restrictions on imports and exports of goods (work, services) not included in Appendix 2 to this Decision shall be imposed by the Government of the Russian Federation on their submission by the Ministry of Foreign Economic Relations of the Russian Federation and the Ministry of the Economy of the Russian Federation.

To authorize the Ministry of the Economy of the Russian Federation, in conjunction with the Ministry of Foreign Economic Relations of the Russian Federation, to exclude, on account of the economic situation, individual items from the list of goods provided for in Appendix 2 to this Decision.

6. To entrust the Ministry of the Economy of the Russian Federation with the task of establishing, before November 1 1992, in agreement with the Ministry of Foreign Economic Relations of the Russian Federation and other interested ministries and departments of the Russian Federation, quotas for export of goods in 1993 listed in Appendix 2 to this Decision.

The established export quotas shall be presented before November 25, 1992, by the respective ministries and departments of the Russian Federation, to producers and the supreme state authorities of constituent republics of the Russian Federation, territories, regions, autonomous entities and the cities of Moscow and St. Petersburg.

- 7. To establish that export and import licenses for the goods (work, services) indicated in Appendices 2 to 5 to this Decision shall be issued by the Ministry of Foreign Economic Relations of the Russian Federation.
 - 8. Abolished.
- 9. To entrust the Ministry of Foreign Economic Relations of the Russian Federation with the task of maintaining a single federal data bank on issued licenses and providing appropriate information to the

Ministry of the Economy of the Russian Federation, the State Customs Committee of the Russian Federation and interested ministries and departments of the Russian Federation.

The Ministry of Foreign Economic Relations of the Russian Federation shall be entrusted with the task of submitting proposals within a month, in conjunction with the Ministry of Finance of the Russian Federation, for consideration by the Supreme Soviet of the Russian Federation on the establishment and size of the fee to be charged for the issue of licences and execution of certificates, bearing in mind that the sums charged should compensate budgetary outlays expended by the Ministry of Foreign Economic Relations of the Russian Federation to maintain the automatic management systems for the republican data base on issued licenses and certificates, acquire computer technology and means of communication, lease communication channels, building and premises, develop and acquire software and set material incentives for personnel.

- 10. To establish that goods included in Appendix 2 to this Decision may in the event of agreements on international partnership in production or raw materials processed on a reciprocal basis, be exported from the Russian Federation without quantitative restrictions, in accordance with the procedure established by the Ministry of Foreign Economic Relations of the Russian Federation, the State Customs Committee of the Russian Federation and interested ministries and departments of the Russian Federation.
 - 11. Abolished.
- 12. The State Customs Committee of the Russian Federation shall supervise the export from and import into the Russian Federation of licensable goods.
- 13. Forwarding enterprises, institutions and individual owners of transport vehicles shall not accept goods for shipment beyond the boundaries of the Russian Federation if they lack the requisite transportation documents and a Russian Federation customs agency's release.

The Ministry of Internal Affairs of the Russian Federation and the Ministry of Security of the Russian Federation shall be entrusted with the task of selectively insecting transport vehicles to control and prevent the export from the Russian Federation of goods without a Russian Federation customs agency's release.

Entities and persons transporting cargoes beyond the boundaries of the Russian Federation without the requisite customs agency's release shall incur responsibility in accordance with existing legislation.

- 14. All breaches of the established procedure for exports and imports of goods (work, services) shall incur responsibility provided for by existing legislation of the Russian Federation.
- 15. The Ministry of Justice of the Russian Federation shall be entrusted with the task of submitting, in agreement with the Ministry of Foreign Economic Relations of the Russian Federation, the Ministry of Internal Affairs of the Russian Federation, the Ministry of Security of the Russian Federation and the State Customs Committee of the Russian Federation proposals to the Government of the Russian Federation for establishing criminal and administrative responsibility for violations of the procedure established by this Decision for licensing and allocating exports and imports of goods (work, services) on the territory of the Russian Federation.
- 16. The Ministry of Justice of the Russian Federation shall be entrusted with the task of submitting, within a month, to the Government of the Russian Federation a list of regulatory acts which will no longer be valid following the adoption of this Decision by the Government of the Russian Federation.
