

**DECREE OF THE PRESIDENT OF THE RUSSIAN FEDERATION NO.  
1274 OF SEPTEMBER 24, 2007 ISSUES OF THE STRUCTURE OF THE  
FEDERAL BODIES OF EXECUTIVE POWER (with the Amendments  
and Additions of October 11, December 6, 2007, March 20, 2008)**

For the purpose of perfecting the structure of the federal bodies of executive power, in accordance with Article 112 of the Constitution of the Russian Federation and Federal Constitutional Law No. 2-FKZ of December 17, 1997 on the Government of the Russian Federation, I hereby decree as follows:

1. To transfer to the Ministry of Regional Development of the Russian Federation the functions of giving state support from the means of the Investment Fund of the Russian Federation, of approving the federal targeted programmes and departmental targeted programmes in the part concerning the comprehensive territorial development, and also the functions of exercising the rights of the state customer) (state customer-coordinator) of federal targeted programmes connected with the economic development of the entities of the Russian Federation and municipal formations.

To establish that the Ministry of Regional Development of the Russian Federation shall carry out the elaboration and coordination with the Ministry of Finance of the Russian Federation and with other interested federal bodies of executive power the methodologies for the allocation of means of state support to entities of the Russian Federation and municipal formations and shall submit them to the Government of the Russian Federation for approval.

To assign to the Ministry of Regional Development of the Russian Federation the coordination of the activity of the state corporation the "Fund for Promoting the Reforming of the Housing and Communal Services".

2. To transfer to the Ministry of Justice of the Russian Federation the functions of the normative ensuring of keeping the State Real Estate Cadastre.

To establish that the Federal Agency of Real Estate Cadastre shall be under the jurisdiction of the Ministry of Justice of the Russian Federation.

3. The Military-Industrial Commission under the Government of the Russian Federation shall perform the functions of the mobilisational preparation of the economy of the Russian Federation and the formation of the state defence orders.

4. To establish that state committees shall form part of the federal bodies of executive power along with federal ministries, services and agencies.

A state committee shall be a federal body of executive power which, in the sphere of activity established for it, shall perform the functions of the elaboration of state policy and normative-legal regulation, control and

supervision, the rendering of state services and management of state property, if this is stipulated by the regulations on the said federal body of executive power.

The head of a state committee shall submit to the Government of the Russian Federation draft normative acts of the Government of the Russian Federation on issues relegated to the authority of the Government of the Russian Federation, present proposals for the formation of a draft federal budget in the part concerning the sphere of the activity of the state committee, and shall also enjoy the other rights of a federal minister stipulated by decrees of the president of the Russian Federation and decisions of the government of the Russian Federation.

**5.** To transform the Federal Agency on Fisheries into a State Committee of the Russian Federation on Fisheries transferring to it the functions of the Ministry of Agriculture of the Russian Federation in the sphere of fisheries, production activity on the vessels of the fishery fleet, the study, preservation, reproduction and use of the aquatic biological resources, and also the functions of the Federal Service for Veterinary and Phytosanitary Supervision in the sphere of control and supervision over the aquatic biological resources and their habitat.

To reserve with the State Committee of the Russian Federation on Fisheries the functions of the rendering of state services, the management of state property in the sphere of fishery activity and the other functions of the transformed Federal Agency on Fisheries.

To establish that the leadership of the activity of the State Committee of the Russian Federation on Fisheries shall be exercised by the Government of the Russian Federation.

**6.** To form a State Committee of the Russian Federation for Issues of Young People assigning to it the functions of determining the state youth policy, creation, interaction with social organisations and movements representing the interests of young people, conditions for ensuring a healthy way of life, going in for sports, moral and patriotic education, realisation by young people of their professional possibilities, and also of coordination of activity in the given sphere of the bodies of executive power of the entities of the Russian Federation.

To establish that the leadership of the activity of the State Committee of the Russian Federation for Issues of Young People shall be exercised by the Government of the Russian Federation.

**7.** To establish that the leadership of the activity of the Federal Service on Financial Monitoring shall be exercised by the Government of the Russian Federation.

**8.** To approve the annexed Structure of the Federal Bodies of Executive Power.

**9.** To establish that the federal bodies of executive power to which there have been transferred the functions of the transformed federal bodies of executive power shall be the legal successors in their obligations,

including those which have arisen as a result of execution of court decisions.

**10.** To establish that the Chairman of the Government of the Russian Federation shall have five Deputy Chairmen of the Government of the Russian Federation, including two First Deputies, the Deputy Chairman of the Government of the Russian Federation - Head of the Apparatus of the Government of the Russian Federation, and also a Deputy Chairman of the Government of the Russian Federation - Minister of Finance of the Russian Federation.

**11.** The Government of the Russian Federation shall:  
ensure the conduct of the reorganisational arrangements in accordance with this Decree;  
determine the federal bodies of executive power which must accept the obligations and property, not transferred within the established time period, of the transformed federal bodies of executive power;  
specify the functions of the federal bodies of executive power taking into account the distribution of the functions in accordance with this Decree;  
submit proposals for amending certain acts of the President of the Russian Federation in accordance with this Decree;  
bring its acts into conformity with this Decree.
