

**FEDERAL LAW NO. 222-FZ OF JULY 24, 2007 ON AMENDING THE  
FEDERAL LAW ON THE DELIVERY OF PRODUCTS FOR FEDERAL  
STATE NEEDS AND ARTICLE 12 OF THE FEDERAL LAW ON  
WEAPONS**

**Adopted by the State Duma on July 4, 2007**

**Approved by the Federation Council on July 11, 2007**

**Article 1**

To amend Federal Law No. 60-FZ of December 13, 1994 on the Delivery of Products for Federal State Needs (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 1994, No. 34, item 3540; 1995, No. 26, item 2397; 1997, No. 12, item 1381; 1999, No. 19, item 2302; 2004, No. 35, item 3607; 2006, No. 6, item 636) as follows:

1) the preamble shall be set forth in the following wording:

"This Federal Law established the general legal and economic principles of and the procedure for the formation and execution on a contractual basis of orders for the purchase and delivery of goods, works, services (hereinafter, products) for federal state needs by organisations irrespective of the form of ownership and also the bases of ensuring the guarding of products delivered under a state contract, of objects intended for extracting, processing, transporting and storing such products and other property necessary for fulfilling state contracts.";

2) Article 4.1 shall be added reading as follows:

**Article 4.1.** Ensuring the Guarding of Products Delivered Under a State Contract, of Objects Intended for Extracting, Processing, Transporting and Storing Such Products and Other Property Necessary for Fulfilling State Contracts

1. Having obtained the relevant licence at the bodies of internal affairs, strategic enterprises, strategic joint-stock companies and their affiliated companies owning and operating gas mains and an organisation owning the Uniform Gas-Supply System (hereinafter, also strategic organisations) can acquire civilian and service weapons in accordance with Federal Law No.150-FZ of December 13, 1996 on Weapons (hereinafter, the Federal Law on Weapons) Ensuring the Guarding of Products Delivered Under a State Contract, of Objects Intended for Extracting, Processing, Transporting and Storing Such Products and Other Property Necessary for Fulfilling State Contracts.

2. The lists of objects intended for extracting, processing, transporting and storing products delivered under a state contract and in whose guarding civilian and service weapons and special facilities are used, shall be approved by a strategic organisation in agreement with the Ministry of Internal Affairs of the Russian Federation and the Federal Security Service

of the Russian Federation in the procedure established by the Government of the Russian Federation.

3. The list of posts of workers of strategic organisations who, in the performance of their incumbent duties connected with ensuring the guarding of products delivered under a state contract, of objects intended for extracting, processing, transporting and storing such products and other property necessary for fulfilling state contracts, shall have the right to keep, wear and use civilian and service weapons and special facilities, the list of affiliated companies of strategic enterprises and strategic joint-stock companies whose workers are vested with such a right, and also the kinds, types, models and quantity of the given weapons and special facilities shall be established by the Government of the Russian Federation.

4. The workers mentioned in this Article of strategic organisations shall use civilian and service weapons in the procedure established by Federal Law No. 77-FZ of April 14, 1999 on Departmental Guards.

5. Strategic organisations must acquire civilian and service weapons and special facilities, record, keep and issue them in the procedure established for legal entities with special statutory tasks by the Federal Law on Weapons and by other normative legal acts of the Russian Federation."

## **Article 2**

To amend Article 12 of Federal Law No. 150-FZ of December 13, 1996 on Weapons (Sobraniye Zakonodatelstva Rossiyskoy Federatsii 1996, No. 51, item 5681; 1998 No. 31, item 3834; 2002, No. 26, item 2516; 2003, No. 2, item 167; 2007, No. 1, item 21) as follows:

1) Item one shall be set forth in the following wording:

"Legal entities with special statutory tasks can, in accordance with the normative legal acts of the Government of the Russian Federation, acquire civilian and service weapons from legal entities - suppliers after obtaining the relevant licence at the bodies of internal affairs. The kinds, types, models and quantity of civilian and service weapons that can be acquired by legal entities with special statutory tasks shall be established by the Government of the Russian Federation.";

2) Item three after the words ", and also other legal entities with special statutory tasks, except for private guarding enterprises and security services or organisations," shall be supplemented with the words strategic enterprises, strategic joint-stock companies and their affiliated companies owning and operating gas mains and an organisation owning the Uniform Gas-Supply System," and shall be supplemented with a sentence reading as follows: "In accordance with Federal Law No. 60-FZ of December 13, 1994 on the Delivery of Products for Federal State Needs on the basis of the normative legal acts of the Government of the Russian Federation, the said strategic enterprises, strategic joint-stock companies and their affiliated companies can acquire, in the procedure stipulated by the legislation of the Russian Federation for legal entities with special statutory

tasks, certain types and models of civilian and service weapons and special facilities for the performance of the duties assigned to them by a federal law and connected with ensuring the guarding of products delivered under a state contract, of objects intended for extracting, processing, transporting and storing such products and other property necessary for fulfilling state contracts.
