

**DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION NO. 1300 OF OCTOBER 31,  
1996 ON THE MEASURES FOR STATE REGULATION OF FOREIGN TRADE BARTER  
TRANSACTIONS**

To implement the provisions of the Decree of the President of the Russian Federation No. 1209 of August 18, 1996 on the State Regulation of Foreign Trade Barter Transactions (Collection of Legislation of the Russian Federation, item 4141, No. 35, 1996) and to ensure the protection of the economic interests of the Russian Federation while executing foreign trade barter transactions the Government of the Russian Federation hereby resolves:

1. The State Customs Committee of the Russian Federation jointly with the Ministry of Foreign Economic Relations of the Russian Federation and the Ministry of Finance of the Russian Federation shall approve and put into force on November 1, 1996 the regulations for carrying on control and records of foreign trade barter transactions providing for the goods being moved across the customs border of the Russian Federation.

2. The Ministry of Finance of the Russian Federation jointly with the Ministry of Foreign Economic Relations of the Russian Federation, the State Customs Committee of the Russian Federation and with the approval of the Central Bank of the Russian Federation:

shall approve before November 1, 1996 the regulations on the performance on the territory of the Russian Federation of control and records of foreign trade barter transactions envisaging the performance of work, providing of services and results of intellectual activities expressed in material form;

shall submit to the Government of the Russian Federation before December 15, 1996 proposals for the performance of control and records of foreign trade transactions envisaging the performance of work, providing of services and results of intellectual activities having no material form or the performance of works, providing of services and results of intellectual activities beyond the borders of the Russian Federation.

3. The State Customs Committee of the Russian Federation shall ensure the performance of customs control and customs processing of the goods taken out from the customs territory of the Russian Federation under foreign trade transactions (including barter transactions) proceeding from the fact that the effect of the goods export customs arrangement is completed by the submittal of the goods brought to the customs territory of the Russian Federation for customs processing or by the confirmation of the bringing in of the work, services and results of intellectual activities equivalent in terms of cost to the exported goods or by means of crediting in accordance with the established procedure of the accounts in authorized banks with the foreign currency proceeds from the export of goods if not provided otherwise by the Decree of the President of the Russian Federation No. 1209 of August 18, 1996 and other legislative acts of the Russian Federation.

4. The Ministry of Finance of the Russian Federation shall ensure control of the observance of the requirements set forth in the Decree of the President of the Russian Federation No. 1209 of August 18, 1996 by the foreign trade activities agents which executed or on whose behalf barter transactions were executed whereby work, services and results of intellectual activities are exported.

5. The Ministry of Foreign Economic Relations of the Russian Federation, the State Customs Committee of the Russian Federation, the Ministry of Finance of the Russian Federation with the approval of the Central Bank of the Russian Federation shall approve before November 1, 1996:

procedure for executing and recording the barter transaction passports proceeding from the fact that the barter transaction passports shall be executed at a charge in accordance with the established procedure;

list of the documents confirming the completion of work, providing of services and rights to the results of intellectual activities;

procedure for the issuance of the permits and statements provided in Items 3 and 12 of the Decree of the President of the Russian Federation No. 1209 of August 18, 1996.

6. The State Customs Committee of the Russian Federation jointly with the Ministry of Finance of the Russian Federation and the Ministry of Foreign Economic Relations of the Russian Federation shall ensure the submittal at least once a half a year to the Government of the Russian Federation of analytical materials on the results of the implementation of the present Decision.
