FEDERAL LAW NO. 30-FZ OF MARCH 29, 2008 ON AMENDING CERTAIN LEGISLATIVE ACTS OF THE RUSSIAN FEDERATION

Adopted by the State Duma on March 5, 2008 Approved by the Federation Council on March 19, 2008

Article 1

Item three of Article 7 of Federal Law No. 3-FZ of May 8, 1994 on the Status of a Member of the Federation Council and the Status of a Deputy of the State Duma of the Federal Assembly of the Russian Federation (in the wording of Federal Law No. 133-FZ of July 5, 1999) (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 1994, No. 2, item 74; 1999, No. 28, item 3466; 2001, No. 32, item 3317; 2005, No. 30, item 3104; 2007, No. 1, item 40) after the words "this Federal Law" shall be supplemented with the words ", other federal laws".

Article 2

To amend Federal Law No. 184-FZ of October 6, 1999 on the General Principles of the Organisation of the Legislative (Representative) and Executive Bodies of State Power of the Entities of the Russian Federation (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 1999, No. 42, item 5005; 2003, No. 27, item 2709; 2004, No. 50, item 4950; 2006, No. 1, item 13; No. 31, item 3427; 2007, No. 10, item 1151; No. 43, item 5084) as follows:

- 1) the second sentence of Item 1 of Article 6 shall be set forth in the following wording: "The Constitution (Statute) of an entity of the Russian Federation may grant the right of legislative initiative to other bodies, members of the Federation Council of the Federal Assembly of the Russian Federation who are representatives from the legislative (representative) and executive bodies of state power of the given entity of the Russian Federation, to public associations and also to citizens residing on the territory of the given entity of the Russian Federation.";
- 2) paragraph one of Item 4 of Article 18 shall be supplemented with a sentence reading as follows: "The restrictions established by this Item in the part concerning the filling of state posts of the federal state service shall not be applicable in the cases established by decrees of the President of the Russian Federation.".

Article 3

Subitem (a) of Item 2 of Part 1 of Article 17 of Federal Law No. 79-FZ of July 27, 2004 on the State Civil Service of the Russian Federation (Sobraniye Zakonodatelstva Rossiyskoy Federatsii, 2004, No. 31, item 3215; 2007, No. 10, item 1151) shall be set forth in the following wording:

"a) election or appointment to a state post, except for the cases established by decrees of the President of the Russian Federation;".
