On common list of products, in respect of which mandatory requirements are established in the frame of the Customs Union

In order to implement Article 3 of the Agreement on common principles and rules of technical regulation in the Republic of Belarus, Kazakhstan and the Russian Federation dated 18 November 2010 the Customs Union Commission decided:

1. Adopt a list of products, in respect of which mandatory requirements are established in the frame of the Customs Union
2. Due to the presence in the states - members of the Customs Union of various procedures for state registration of medical devices (medical equipment and medical products) to request that the Parties:
 - Study the possibility of unification of approaches of the Parties in this area;
 - If necessary, to develop a draft appropriate international treaty;
 - On the basis of this work to decide on the reasonability of developing the technical regulation of the Customs Union "On the safety of medical devices."

To suspend development of the appropriate technical regulation of the Customs Union before making a decision on this matter.
