DECREE OF THE PRESIDENT OF THE RUSSIAN FEDERATION NO. 736 OF JUNE 28, 2005 ON AMENDING AND DECLARING INVALIDATED SOME ACTS OF THE PRESIDENT OF THE RSFSR AND THE PRESIDENT OF THE RUSSIAN FEDERATION (with the Amendments and Additions of May 10, 2007)

In connection with the issue of Decrees of the President of the Russian Federation No. 400 of March 25, 2004 on the Administration of the President of the Russian Federation and No. 490 of April 6, 2004 on Endorsing the Regulations on the Administration of the President of the Russian Federation I hereby order as follows:

- **1.** The amendments according to the list in Annex No. 1 shall be made to acts of the President of the Russian Federation.
- **2.** The acts of the President of the RSFSR and of the President of the Russian Federation according to the list in Annex No. 2 shall be declared invalidated.
 - 3. This Decree shall enter into force as of the date of signing it.
