### Animal and Plant Biosecurity (Designation of Biosecurity Points of Entry and Biosecurity Points of Departure) Order, 2012

In exercise of the powers conferred by section 66(1)(a) and (b) of the Animal and Plant Biosecurity Act, 2012, the Minister for Investment, Natural Resources and Industry, on the advice of the Director and after consulting the authorities responsible for postal, immigration and customs services, airports, seaports and the movement of vessels and aircraft in Seychelles, makes the following Order.

1. This Order may be cited as the Animal and Plant Biosecurity (Designation of Biosecurity Points of Entry and Biosecurity Points of Departure) Order, 2012.

Citation

2. In this Order –

Interpretation

"Minister" means the Minister responsible for matters relating to biosecurity.

- **3.** The Minister designates as biosecurity points of entry, at which regulated articles may enter Seychelles –
- Biosecurity points of entry
- (a) the seaports described in Part A of Schedule I;
- (b) the airports described in Part B of Schedule I; and
- (c) the mail exchange described in Part C of Schedule I.
- **4.** The Minister designates as biosecurity points of departure, at which regulated articles may leave Seychelles –

Biosecurity points of departure

- (a) the seaports described in Part A of Schedule II;
- (b) the airports described in Part B of Schedule II; and
- (c) the mail exchange described in Part C of Schedule II.
