DECREE

On Approval of the List of agricultural equipment, exempted from VAT and customs duty while importation to the Republic of Tajikistan

In accordance with article 211 of Tax Code of RT and article 345 of Customs Law, the Government of RT resolves:

1. Approve enclosed list of agricultural equipment, exempted from VAT and customs duty while importation to the Republic of Tajikistan.

2. Declare the Decree of Government of RT dated 30 June, 2004 under #295 “On approval of the list of agricultural equipment and List of spare parts for agricultural equipment, exempted from VAT while importation to the Republic of Tajikistan” as expired.

3. The present decree is enforced since October 1, 2007
