 - Annex 1 Central level entities
 - Annex 2 Sub-central level entities
 - Annex 3 Other entities
- → Coverage of services and construction services in two Annexes
 - Annex 4 Services
 - Annex 5 Construction services
- → Specific thresholds
- → Individual Notes by Annex
- → General Notes to be specified in a different Annex

- → Annex 1 Central authorities
- Main approach: positive list
- → Annex 2 Sub-central authorities
- Positive list
- Catch all clause with generic definition and indicative list
- → Annex 3 Other entities
- Different types of entities covered
- Positive list
- Catch all clause with generic definition and indicative list

Thresholds- General levels

Entities	Goods (SDR)	Services (SDR)	Construction Services (SDR)
Annex 1	130,000	130,000	5,000,000
Annex 2	200,000	200,000	5,000,000
Annex 3	400,000	400,000	5,000,000

Coverage- goods


- → In principle, all goods covered (subject to derogations in Appendix I and in text (Art XXIII of GPA 1994)
- → Suggestion to insert a "goods" annex
- → Positive list of non-sensitive procurement of goods by defence / security entities covered under the Agreement

Coverage- servicesannex 4 and 5


- → Services listing
 - negative list /positive list
 - majority of Parties: explicit reference to Universal List of Services (MTN.GNS/W/120)
- → Construction services
 - most Parties: by reference to UN Provisional CPC, Division 51
 - mix of positive and negative listing
- → Some Parties: linkage to GATS specific commitments

Country specific derogations

Purpose

aim at correcting the perceived imbalances in coverage

Location

in most of the GPA Parties 'General Notes

Examples

US General Note 6: "for construction services of Korea and suppliers of such services the Agreement only applies to procurement of the entities listed in annex 2 and 3 above a threshold of 15 million SDR"

Norway General Note 1 "Norway will not extend the benefits of the Agreement as regards procurement by entities listed in annex 2 to the suppliers and service providers of Canada"

Market access negotiations:

state of play and way forward

Basis for the negotiations

- Mandate: article XXIV.7 b) and c) of the 1994 GPA
- The modalities decision of the GPA Committee dated 16 July 2004 and its addendum dated 21 July 2005
- The decision of the Committee dated from December 2006 which provides that a final agreement on the text is subject to a mutually satisfactory outcome to the coverage negotiations.



Main objectives of the market access negotiations

- → Improve the Agreement
- → Achieve the greatest possible expansion of coverage on the basis of mutual reciprocity
- → Avoid introducing or prolonging discriminatory measures and seek to eliminate current ones

How do we negotiate?

- → Usual WTO process: exchange of requests and offers
- **→**Role of the Committee:
- Stocktaking session
- List of market access-related matters to be negotiated in the Committee as a whole



List of horizontal market-access related matters

→ issues relating to the **substance**

Ex:

- uniform level of coverage of the entities covered by the Agreement
- the treatment of SMEs
- issues relating to the **presentation of the annexes**

Ex: simplification and clarification of the General Notes



State of play and way forward

- → Most of the GPA Parties have tabled an initial request, and an initial/revised offer
- → Negotiations are ongoing
- → Many challenges ahead
- → Ultimate goal: make the future Agreement more attractive for WTO members to join
