Geneva, 29 November 2018

“Cotton” before the Nairobi Decision on Cotton (2015)

5201: Cotton, not carded or combed,

5202: Cotton waste (including yarn waste and garnetted stocks), and

5203: Cotton, carded or combed

As set forth in Annex 1 of the Agreement on Agriculture (“Product coverage”).



Ministerial **Mandate**: Nairobi Decision on Cotton (2015)

Several references to “cotton-related products” - MC10 Decision on Cotton (WT/MIN(15)/46)

Paragraph 1	<i>We welcome the progress made voluntarily by some Members towards providing duty-free and quota-free market access for cotton and cotton-related products originating from LDCs.</i>
Paragraph 4	<i>Developed country Members, and developing country Members declaring themselves in a position to do so, shall grant, to the extent provided for in their respective preferential trade arrangements² in favour of LDCs, as from 1 January 2016, duty-free and quota-free market access for exports by LDCs of relevant cotton-related products included in the list annexed to this Decision and covered by Annex 1 of the Agreement on Agriculture.</i>
Paragraph 5	<i>We agree to review the list annexed to this Decision in the Dedicated Discussions on cotton referred to in paragraph 14 of this Decision...</i>

Chart 3.3: Colombia (COLQ065)

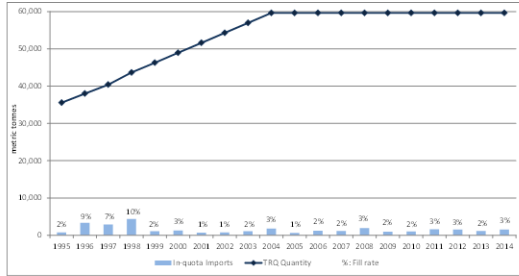
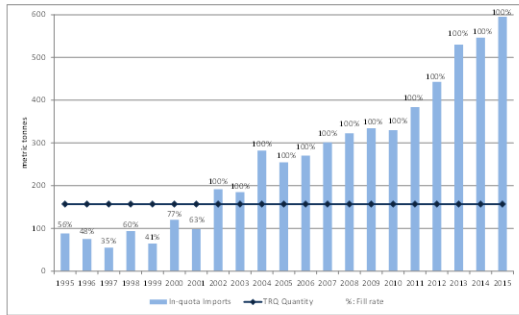


Chart 3.4: Iceland (ISLQ047)

MC10 Decision on Cotton, WT/MIN(15)/46, Nairobi

Paragraph 5:

“We agree to review the list annexed to this Decision in the Dedicated Discussions on cotton referred to in paragraph 14 of this Decision within two years, on the basis of updated trade statistics provided by Members on their imports from LDCs”



Next steps: C4 suggestion of June 2018 (DD)

- What are the products at issue?
- What is the margin for growth?
- At what level of transformation?
- What are the key value-addition elements?
- What products are missing from the Nairobi list, if any?
