## OVERVIEW

The [Aid for Trade Global Review 2019](#) examines the theme of "Supporting Economic Diversification and Empowerment".

Trade has been a catalyst for unparalleled progress in poverty reduction since the WTO came into being in 1995. The 2030 Agenda for Sustainable Development commits us to continue this essential work and to eliminate extreme poverty.

It is against this background, and that of a challenging context for the multilateral trading system, that the Global Review will discuss how Aid for Trade supports economic diversification and empowerment. A particular focus will be placed on eliminating extreme poverty, particularly through the effective participation of micro, small and medium enterprises, women and youth.

The Global Review features discussions in four main formats:

- Plenary Sessions: high-level panels focusing on key Global Review themes;
- Thematic Focus Sessions: interactive panel discussions, including at Ministerial level;
- Side Events: specific and technical insights on a specific issue or theme;
- Development Hubs: informal discussions in a highly interactive format.

Global Review will be informed by the [Aid for Trade at a Glance report](#), published jointly by the World Trade Organization (WTO) and the Organisation for Economic Co-operation and Development (OECD), with contributions from United Nations Industrial Development Organization (UNIDO), United Nations Development Programme (UNDP), the Enhanced Integrated Framework (EIF), the International Trade Centre (ITC), the United Nations Conference on Trade and Development (UNCTAD) and the World Bank Group. Additional analysis and reports will be contributed by regional development banks and other stakeholders.

The Global Review on 3-5 July will be preceded by the following pre-events:

- **Monday 1 July**
  - Buenos Aires Declaration Workshop on "Women in Digital Trade". This joint European Union, ITC and WTO workshop will explore how digital trade can offer more opportunities for women-led businesses. It will examine the current state of women's participation in digital trade and identify opportunities and challenges to boost their participation and share good practice.
- **Tuesday 2 July**
  - ITC Joint Advisory Group (JAG): The ITC JAG meets annually to examine the activities of ITC and to make recommendations to the UNCTAD Trade and Development Board and WTO's General Council on ITC's future work programme.
  - WTO Chairs Programme (WCP) Annual Conference 2019: The WCP meets annually to take stock of the work of the 19 WTO Chairs. It comprises an academic conference that includes presentations and discussions on the theme of the Global Review of Aid for Trade and on recent trade policy developments.
