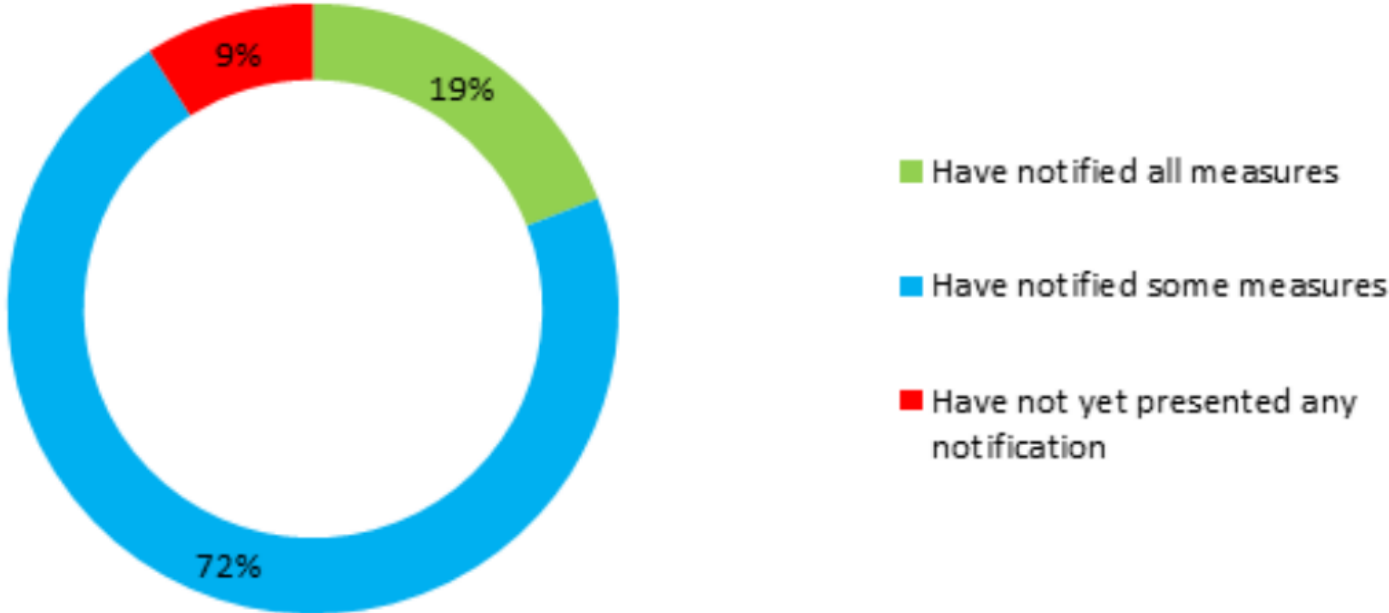

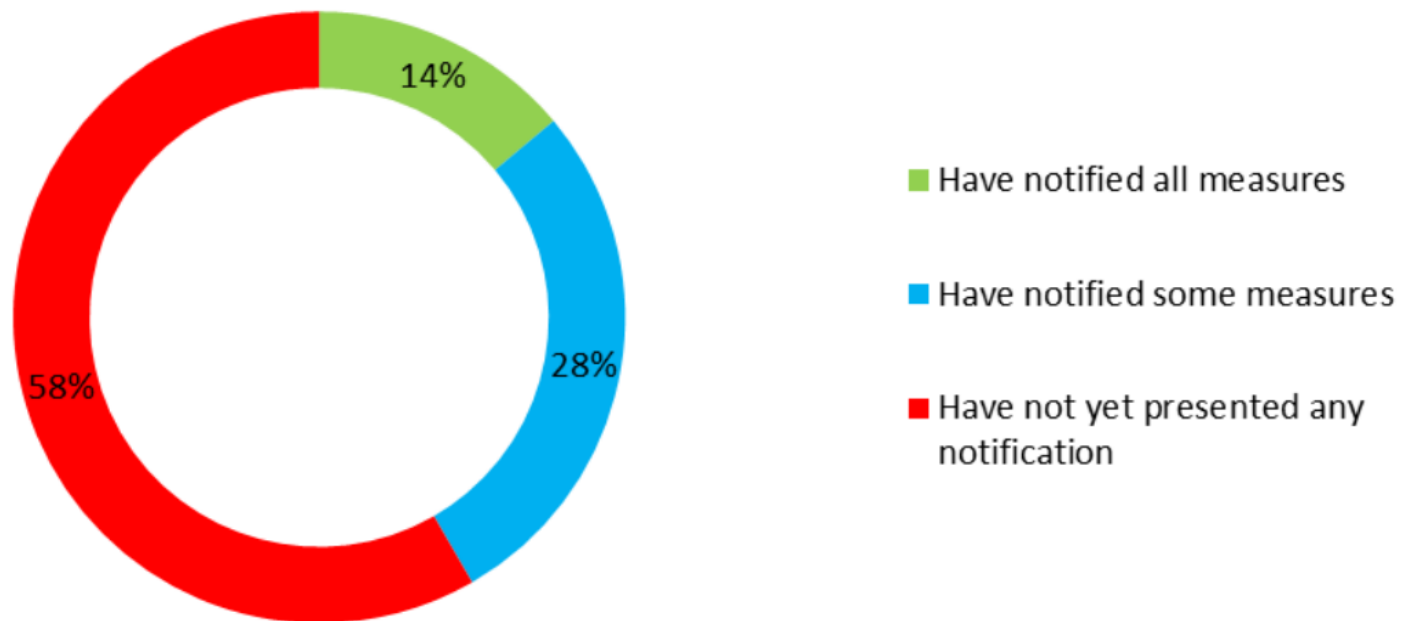

Developing Members: Status of category A, B, C notifications

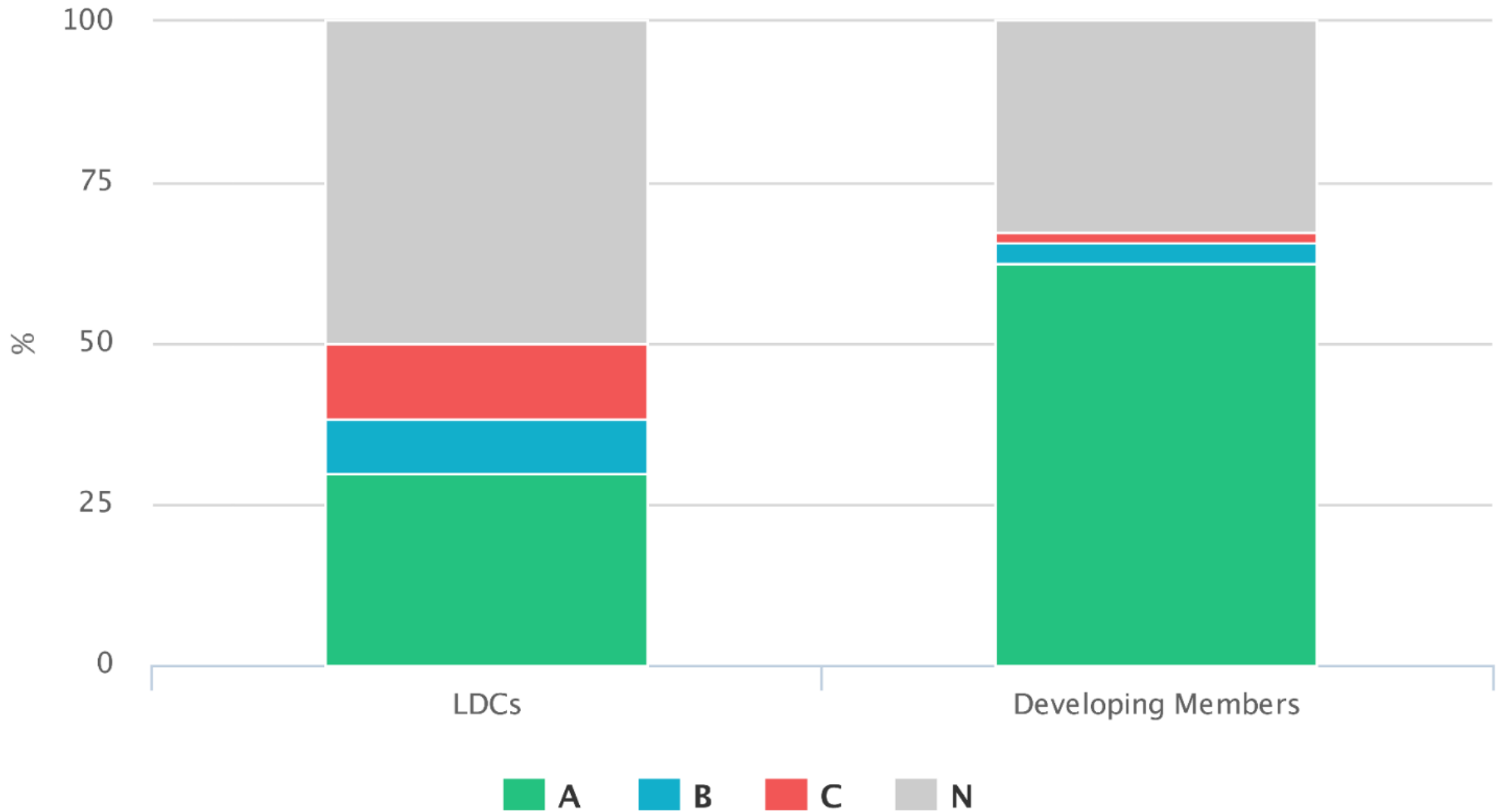


LDCs: Status of A, B, C notifications



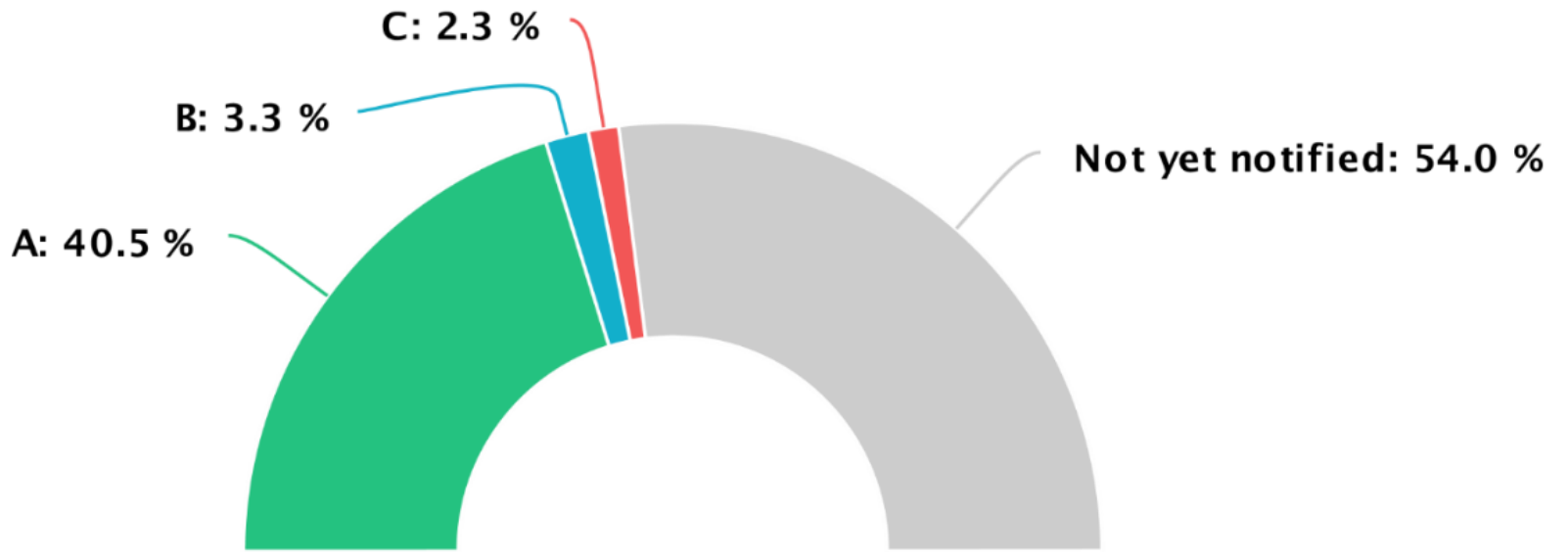
Share of Categories A, B, C by grouping

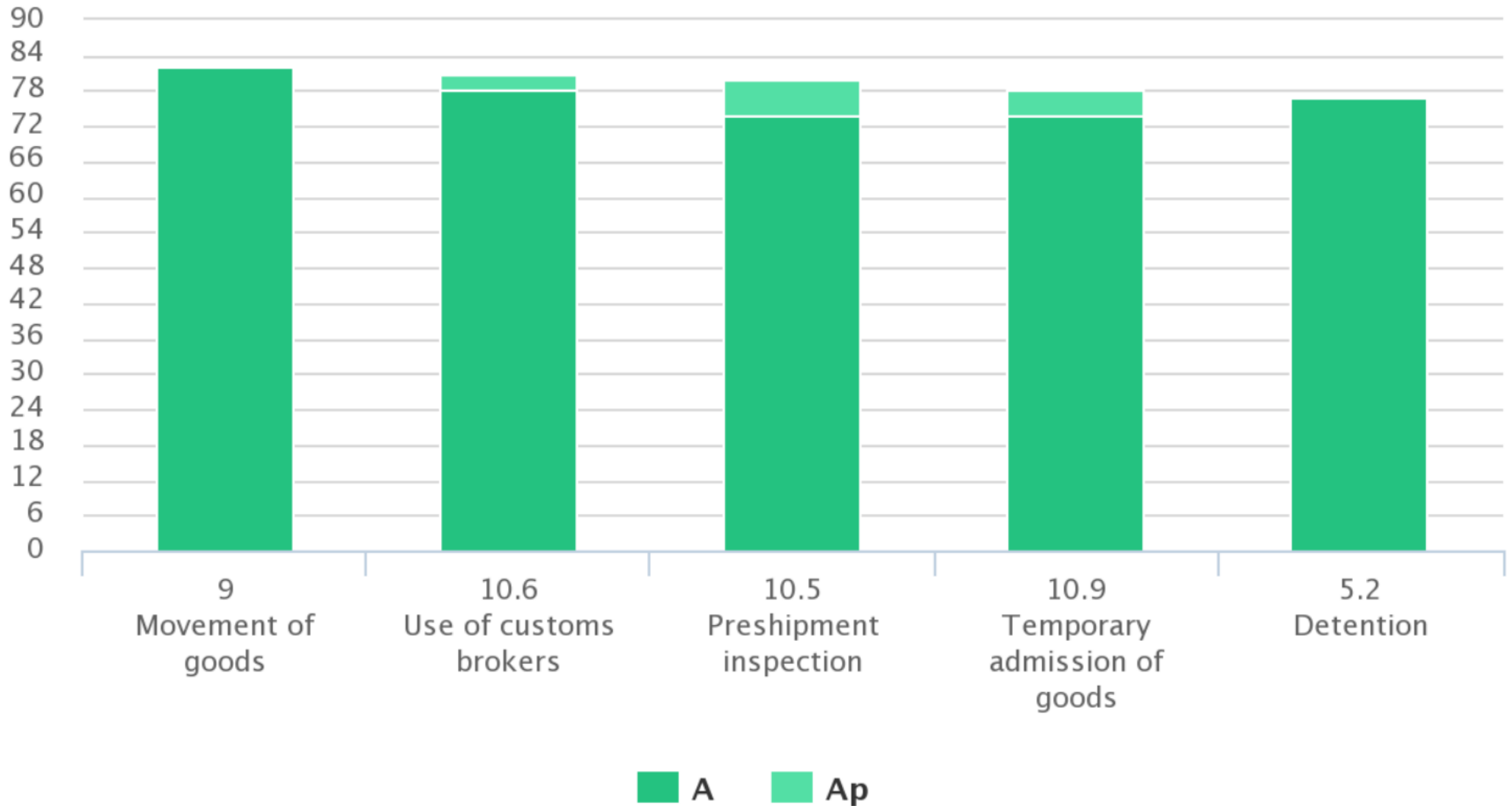

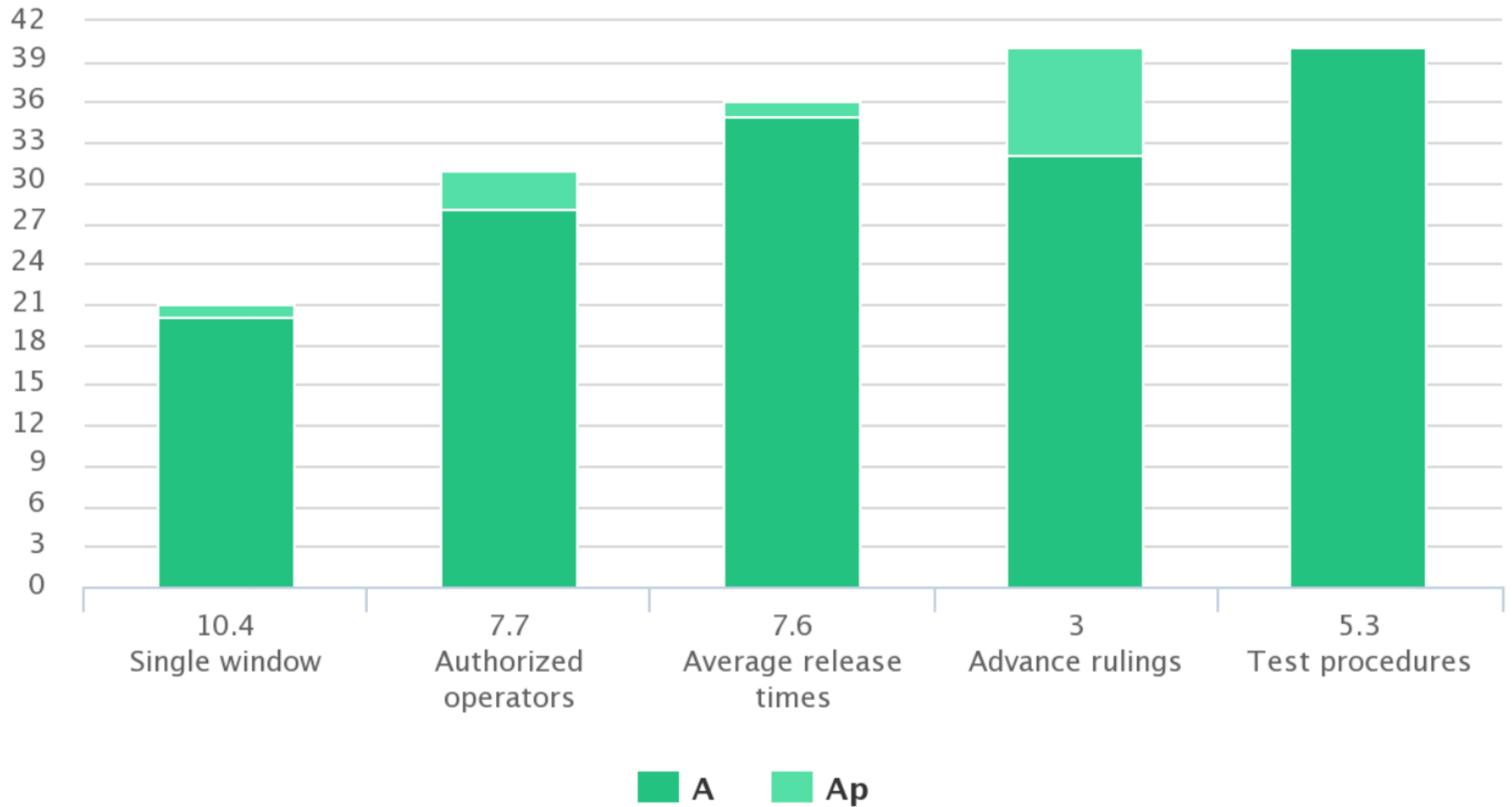
The 5 most notified measures in Category A

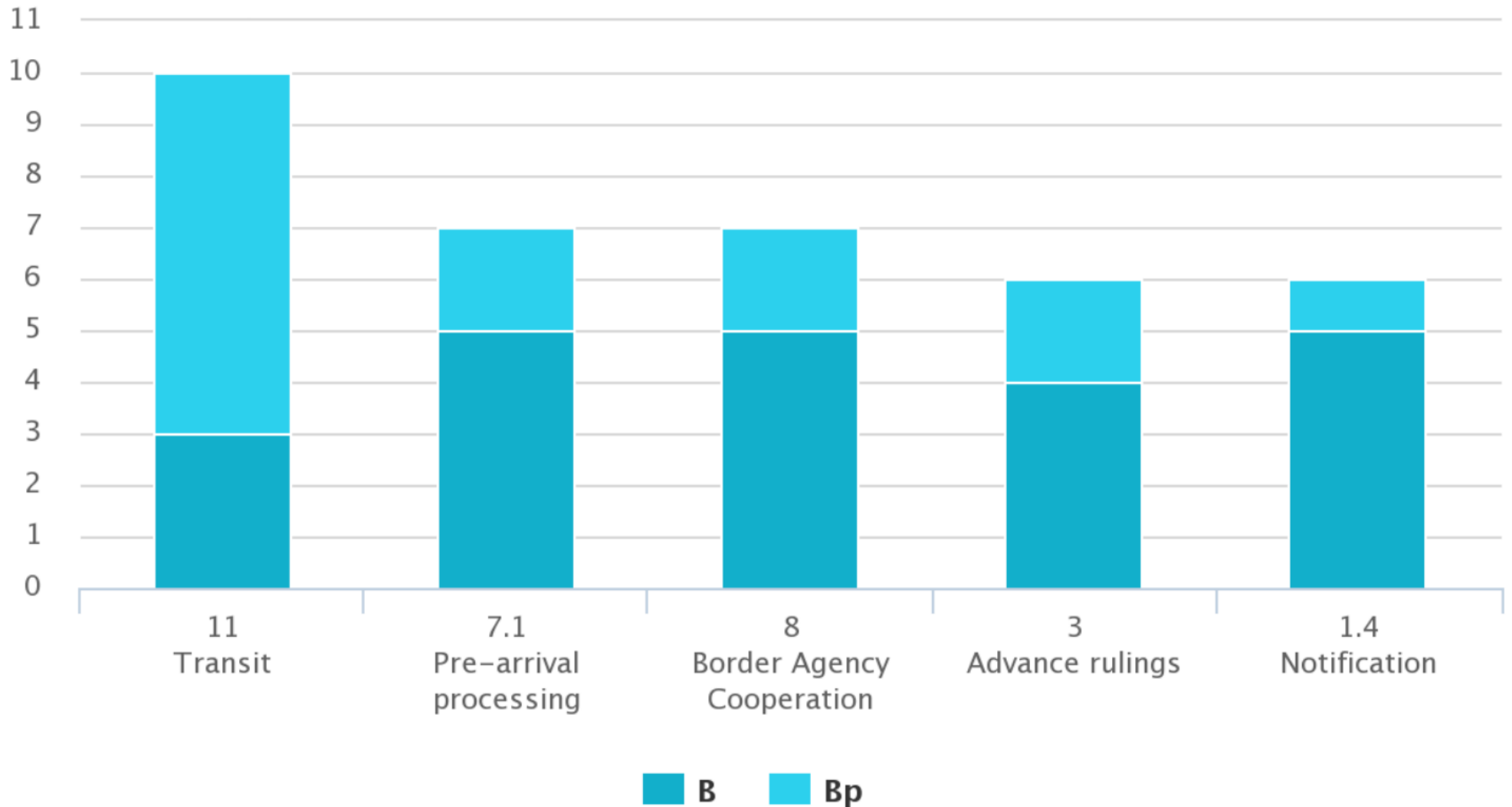

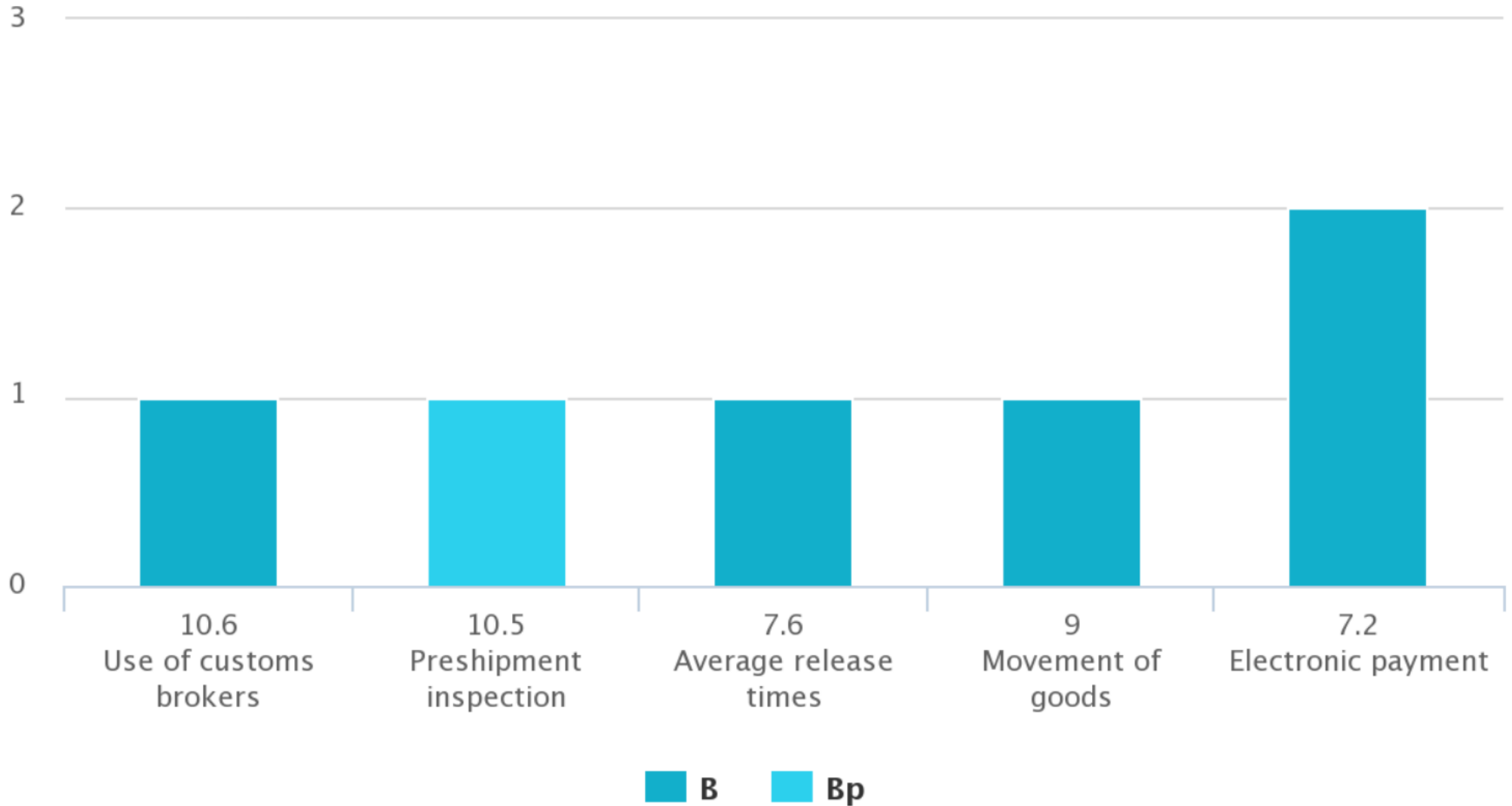
The 5 most notified measures in Category B

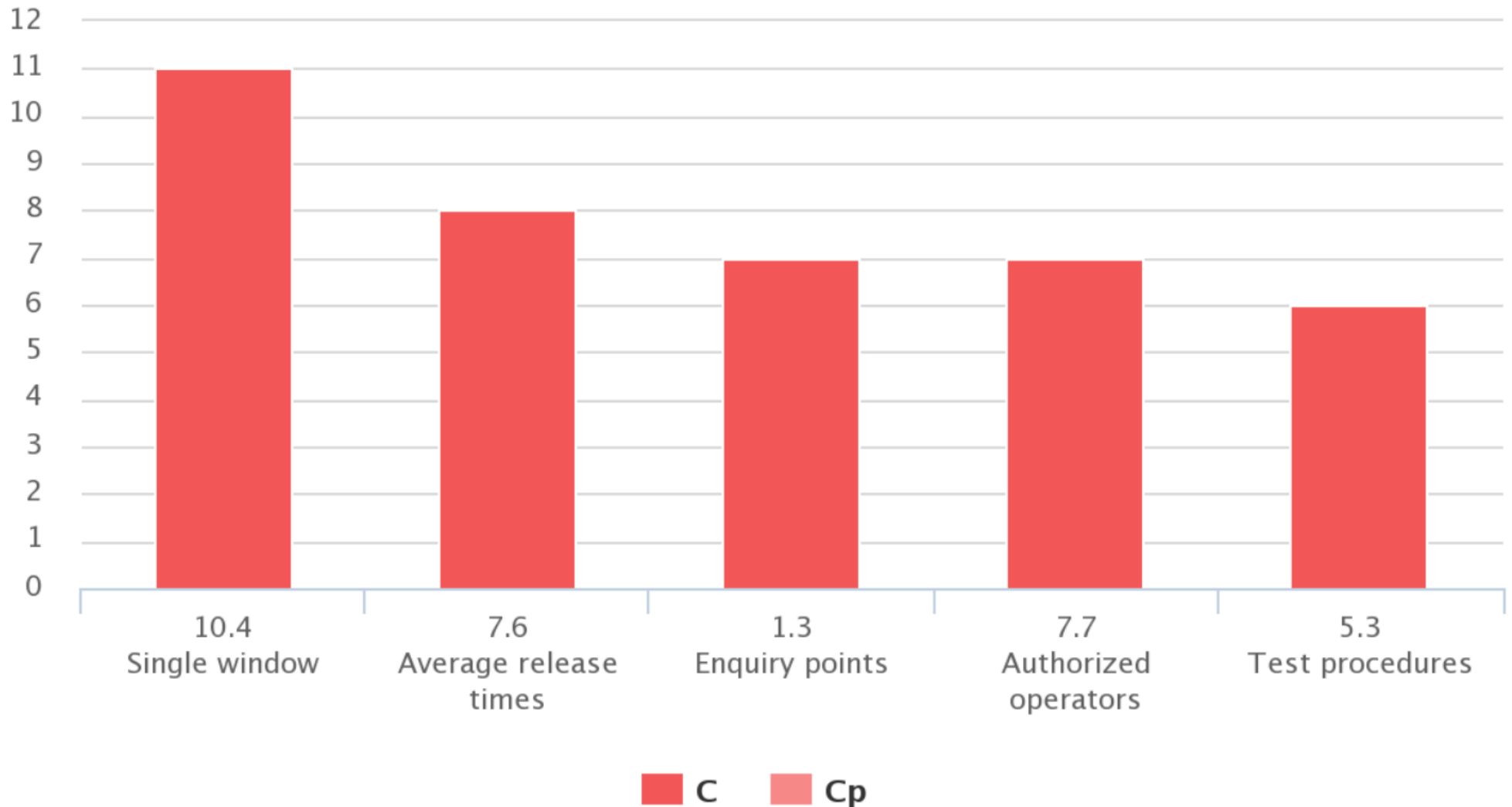

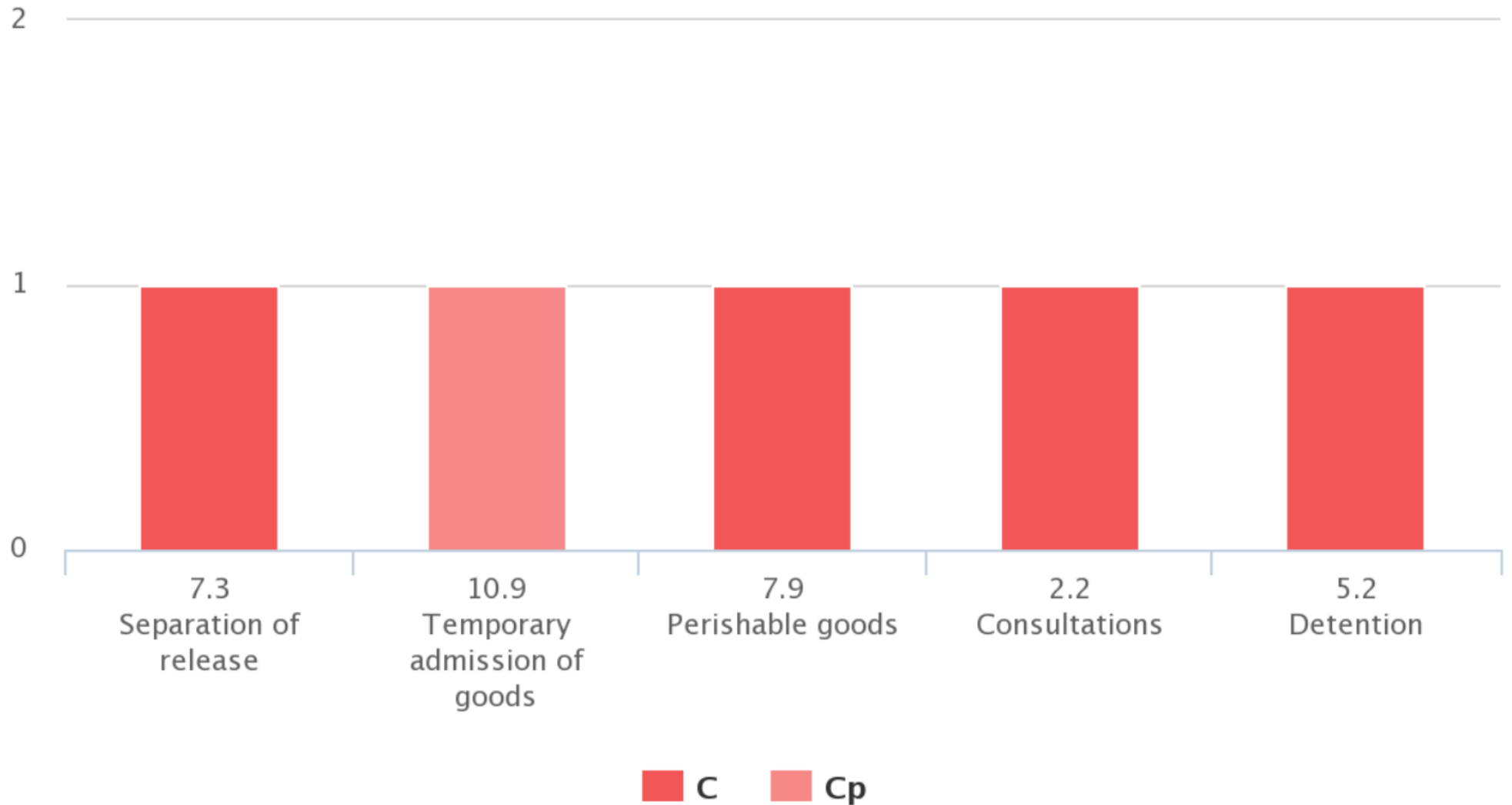
