



Developing Members: Status of category A, B, C notifications




LDCs: Status of A, B, C notifications




Share of Categories A, B, C by grouping

Based on % of all notifiable items




Share of Categories A, B, C

Based on % of all notifiable article items - Global




The 5 most notified measures in Category A


No. of measures fully or partially notified



The 5 least notified measures in Category A


No. of measures fully or partially notified






The 5 most notified measures in Category B


No. of measures fully or partially notified



The 5 most notified measures in Category C






