IMPORT RESTRICTIONS OF THE FEDERAL REPUBLIC OF GERMANY

Request by the United States for Consultations under Article XXII

In accordance with the procedures adopted by the CONTRACTING PARTIES on 10 November 1958 (BISD, 7th Supplement, page 24) the Government of the United States has informed the Executive Secretary that a request has been addressed to the Federal Republic of Germany to engage in consultations under paragraph 1 of Article XXII concerning the latter's import restrictions on the items listed below.

<u>Tariff No.</u>	<u>Commodity description</u>
0701	Potatoes other than for seed and for the production of starch and flakes under customs control; tomatoes, cauliflower, lettuce, endives, beans and cucumbers, chilled or fresh
0705	Dried peas and beans for seed
0806	Fresh apples and pears for dessert
1203*	Seeds of white clover, seeds of ray grasses, timothy grass and other grasses
1210*	Alfalfa dried and ground
1806	Ice-cream and preparations used for the production of ice-cream, cont. cocoa
1902	Preparations of flour, starch or malt extract, used as infant food or for dietetic or culinary purposes, whether or not containing less than 50 per cent of cocoa
1903	Macaroni, spaghetti and similar products
2001	Vegetable preparations with vinegar, in airtight containers, except olives

<u>Tariff No.</u>	<u>Commodity description</u>
2002	Vegetable preparations without vinegar, in containers of less than 5 kgs., except tomatoes, mushrooms, olives, capers, artichokes and asparagus without tips (asparagus spears and tips bound in GATT)
2004	Fruit and plants preserved in sugar, except fruit peels
2005	Jams and marmalades containing sugar or syrup, except quince jelly and marmalade prepared from bitter oranges; apple sauce
2006	Strawberries and figs prepared or preserved otherwise, also with sugar or alcohol, in containers less than 5 kgs., also apples, pears, and apple tangerine mixtures
2007	Juice of apples and pears without sugar (all juices bound except mixtures)
2107	Ice-cream and ice-cream powder
2205	Champagne in any size container and red and white wine in containers up to 2 litres; wine for the production of champagne, red and white wine in containers of more than 2 litres and red and white dessert wine
2210*	Vinegar, for human consumption
2303	Extracted beet root chips and other residues from sugar production
3501*	Casein, not hardened, for the production of human and animal food
