## DANISH IMPORT RESTRICTIONS

### Liberalization Effective 1 July 1965

The Danish Government has advised that as from 1 July 1965 the Danish liberalization of imports from countries within the Danish free-list area has been further extended to include the items listed below.<sup>1</sup>

Commodity Description

#### Food and feeding stuffs

ex 02.04	Meat and edible meat offals of rabbits, fresh, chilled or frozen (rest of item)
ex 02.06	Meat and edible meat offals of rabbits, salted, in brine, dried or smoked
ex 07.01	The following vegetables, fresh or chilled: artichokes, beans and other leguminous vegetables <u>except</u> peas; champignons (psalliota) and other edible mushrooms; dill, pumpkins, cress and water-cress, chervil, parsnip, parsley, parsley-root, chives; rhubarbs, radishes and other edible roots <u>except</u> carrots, celeriac, beetroot and horse-radish.
ex 07.02	The following vegetables (whether or not cooked) preserved by freezing: gherkins, cucumbers, champignons (psalliota) and carrots
ex 07.03	The following vegetables, provisionally preserved in brine, in sulphur water or in other preservative solutions but not specially prepared for immediate consumption: artichokes, beans and other leguminous vegetables <u>except</u> peas; champignons (psalliota) and other edible mushrooms; dill, pumpkins, cress and water-cress, chervil, parsnip, parsley, parsley-root, chives, rhubarbs, radishes and other edible roots <u>except</u> carrots, celeriac, beetroot and horse-radish
ex 07.06	Jerusalem artichokes, fresh or dried, whole or sliced.
ex 08.08	The following berries, fresh: blackberries and gooseberries.

ex 12.10	Mangolds, swedes and other fodder root products (rest of item)
ex 17.04	Liquorice confectionery <u>except</u> liquorice allsorts
ex 20.01	Gherkins and cucumbers and mixtures containing any of these vegetables prepared or preserved by vinegar or acetic acid, with or without added sugar, salt; spices or mustard (rest of item)
ex 20.02	The following vegetables prepared or preserved otherwise than by vinegar or acetic acid: gherkins, cucumbers, champignons (psalliota) and carrots
<u>Raw materials</u>	
ex 25.16	Granite (including so-called black granite, e.g. diabase and diorite), in the form of blocks and sheets whether or not roughly worked by splitting, cutting or sawing, but not further worked (rest of item)
<u>Manufactured goods</u>	
40.10	Transmission, conveyor or elevator belts or belting, of vulcanized rubber (rest of item)
ex 40.11	Rubber tyres and tubes for bicycles without motor and for bicycles with an auxiliary motor (rest of item)
ex 48.11	Wallpaper (rest of item)
ex 84.15	Refrigerators with a volume of not more than 200 litres and the following parts thereof; boxes and cabinets, doors, inside and outside door pans (rest of item)
ex 84.40	Washing machines for domestic use or for laundries, and parts of such machines (rest of item)
ex 90.26	Gas meters (rest of item)
ex 90.29	Parts of gas meters (rest of item)
