GENERALIZED SYSTEM OF PREFERENCES

Notification by Australia

Addendum

In a communication dated 30 September 1982, the delegation of Australia notified the following changes in the GSP scheme of Australia for the information of contracting parties.

IMPROVED TREATMENT

Australia has introduced improved tariff treatment for the following imports from Developing Countries.

Restoration of Eligibility for Preference

Israel has been restored to eligibility for the preference on automotive filters (ex CCCN:84.18) with effect from 17 June 1982.

Taiwan Province has been restored to eligibility for the preference on certain bench and pedestal drilling machines (ex CCCN: 84.45) with effect from 19 August 1981.

DC QUOTAS

On 1 June 1982 a developing country quota of 900 tonnes was introduced for canned leg and shoulder ham falling within CCCN 16.02. Goods from developing countries imported within the quota enter duty free; outside the quota they are dutiable at the MFN rate of 15%.

Other variations to developing country quotas may be found in Australian Customs Notice 82/129 of 1 July 1982 (see Annex¹).

TEXTILES, CLOTHING AND FOOTWEAR

As previously notified, most textiles, clothing and footwear (TCF) products are now eligible for DC preference. Some beneficiaries are excluded from preference on particular products where they have exceeded a specified share of non-handicraft imports. These exclusions are in accordance with the provisions of the Australian Government's seven year program for the TCF industries.

The list of countries which will be ineligible for DC preferential rates on various TCF products during 1983 was published in June 1982. If imports from an excluded beneficiary fall below the cut-off point in a succeeding assessment period, it will be restored to preference on that product during the following calendar year.

For goods subject to global tariff quotas, the eligibility criterion excludes from DC preference those countries which have supplied over 15% of total non-handicraft imports within a quota group. For goods not subject to global tariff quota, the eligibility criteria exclude developing countries which have supplied over 10% of total non-handicraft imports of products where a ten percentage-point margin of preference is given and 5% where the margin is five percentage points.

AUSTRALIAN CUSTOMS NOTICE

No. 82/129

DEVELOPING COUNTRY QUOTA ARRANGEMENTS

QUOTA PERIOD 1 JULY 1982 - 30 JUNE 1983

Importers are invited to apply for quota to import certain goods from Developing Countries at special quota rates of duty during the quota period 1 July 1982 to 30 June 1983. Quota categories and annual quota levels now notified after consultations with the Department of Trade and Resources are set out in Attachment A.

2. This notice provides information concerning:-

(a) the DC quota categories that will apply for the next quota period and the annual quota levels (refer Attachment A)

- excluding canned ham (See ACN 82/100)

(b) procedure for making an application for quota allocations for the period and the closing dates for applications (refer paragraphs 6 to 10)

(c) method of allocation (refer paragraph 4)

(d) validity of the Ministerial Determination which will be issued (refer paragraph 16)

(e) note regarding 1981-82 quota imports (refer paragraphs 10 and 11)

Specified Previous Import Performance Period (PIP)

3. As advised in BCN 81/142 the specified period for determining previous import performance (PIP) for the 1982-83 allocation will be 1 July 1980 to 30 June 1981.

Note: Special Provisions Categories 849 and 850 - see paragraph 21.

Method of Allocation

4. A three tiered method of allocation is used for the allocation of quota. The principles to be adopted at each level are:-

- (i) First level - Quota holders with import performance in a specified period (paragraph 3) will have automatic eligibility for a quota allocation equivalent to the amount imported under quota, pro-rated where necessary.
 - (ii) Second level - Any balance remaining after allocations under level 1 will be allocated to applicants in proportion to their total imports from eligible DC sources (whether at DC Quota, DC Non Quota or GT Rates of duty) in a specified period.
 - (iii) Third level - Any balance remaining after requests by applicants under levels 1 and 2 above have been satisfied will be available for allocation to new importers.
5. Applicants are required to state the MAXIMUM quota allocation they require for the entire period at the first and second levels.

Applications

6. Applications are to be submitted in the form of a cover sheet as indicated in Attachment E to this Notice, supported in DUPLICATE where appropriate by schedules of imports in the format of attachments F and/or G; or a list of goods on firm order.

Closing Date for Applications

8. The closing date for applications is 30 July 1982. Applications received after that date will not be considered for the initial quota issue unless the available quota has not been completely allocated to applicants who complied with the closing date.

Information Required with Applications

9. Attachment D to this Notice explains in detail the nature of the information to be submitted with each application and what supporting documentation is required. It is IMPORTANT that applicants follow the instructions for preparation of returns.

Note regarding 1980-81 Quota Imports

10. In the majority of categories, level 1 import performance based on an importers quota utilisation in the previous import performance period 1 July 1980 to 30 June 1981 was established in the course of the 1981-82 quota issue. Further submission of information on quota imports in this period is only required in the following circumstances:-

- (i) applicant did not apply for level 1 quota in 1981-82.
- (ii) additional information now submitted was not supplied with 1981-82 application.

11. In the following categories:-

- 841 - sugar confectionery (including citrus fruit) preserved by sugar
- 843 - twine, cordage, ropes, cables etc - cotton/man-made fibre
- 844 - twine, cordage, ropes cables etc - other
- 845 - tarpaulins, awnings
- 846 - other made up textile articles
- 857 - ships and boats not exceeding 150 tons.

Complete previous import performance (PIP) must be resubmitted to reflect the structural changes announced by the Government. The relevant changes are fully documented in Attachment B to this Notice, and the tariff items/statistical keys that will be accepted as previous import performance are listed in Attachment C.

Goods Qualifying for Inclusion as Previous Import Performance (PIP)

- 12. A full list of tariff items/statistical keys valid for each category during the specified previous import performance period is at Attachment C. Only goods falling to one of the listed combinations of tariff items/statistical keys are eligible for inclusion as previous import performance.
- 13. In categories 846, 849, 850, 854, 863, it may be necessary to furnish INVOICES with each entry being submitted as a claim for previous import performance to establish that the goods are appropriate to the particular category. (Check Attachment C for full details on tariff items where invoices must be produced).
- 14. Incorrect tariff items/statistical keys on entries will be accepted only on receipt of evidence that an amending entry has been submitted to the Department at the original port of importation. Submissions to change entry details will not be accepted in the Quota Control Branch.

General Information

Eligible Countries, Territories and Provinces

15. Countries, Territories and Provinces which have been declared as Developing Countries are listed on pages 2101 - 2104 of the Working Tariff. It should be noted that some countries listed do not qualify as developing countries for all of the commodity groups listed in Attachment A.

Validity of Ministerial Determinations

16. Ministerial Determinations issued will be valid from 1 July 1982 to 30 June 1983. Importers who enter goods at the general tariff rates (GT) of duty between 1 July and prior to receipt of their determinations may apply for refunds at ports of entry for home consumption after receipt of their quota allocation.

Transferability of Quotas

17. Quotas are TRANSFERABLE between importers and a list of quota holders will be published in the Commonwealth of Australia Gazette to facilitate transfers. All requests for transfers must be returned to the Quota Control Branch, Department of Industry & Commerce, Canberra for completion of the transfer.
18. It should be noted that with the exception of categories 846 A/B and 862 A/B there is no facility within the arrangements whereby a transfer can be made from one DC quota category to another.

Categories 846 A/B and 862 A/B

19. Quota holders will be permitted to "swing" any amount of their allocation between category 846 A and category 846 B or between category 862 A and category 862 B.

Note: Importers should clearly state which of the above categories application is being made for.

Surrender of Quota

20. It is a prerequisite to issuing quota that applicants for quota are to state the maximum quota they require at each level (see paragraph 5). Should the statement be overestimated and the quota holder is unable to use the full allocation then the remaining quota should be surrendered to the Quota Control Branch not less than four months before the end of the period.

Special Provisions - Electric Motors (categories 849 and 850)

21. It has been decided that for the 1982-83 quota year all quotas for electric motors will be issued based on previous import performance in the period 1 July 1979 to 30 June 1980. Applicants for quota in categories 849 and 850 need not resubmit a schedule of their imports with their application (unless additional information is being submitted) as the PIP was established in the course of the 1981-82 quota issue.
