Notification by Canada

Addendum

In a communication dated 11 February 1980, the delegation of Canada has provided the following information on improvements to its GSP scheme for the information of contracting parties.

The improvements to the Canadian General Preferential Tariff (GPT) stem from the reapplication, effective 1 January 1980, of the GPT formula to reduced MFN rates on a list of items for which applied rates were reduced, on a temporary basis, in the 1973 budget but for which the GPT formula reduction of one third off the MFN rate did not apply. This formula reduction is now operable for these tariff items as the temporary MFN reductions have been made permanent in the context of implementing the Tokyo Round tariff agreements.
