GENERALIZED SYSTEM OF PREFERENCES

Notification by Austria

Addendum

The following communication dated 13 April 1978 has been received from the Permanent Mission of Austria.

---

I have the honour to transmit to you as a notification the contents of a recently published decree of the Federal Minister of Finance relating to the amendments of the rules of origin of the Austrian GSP (Annex E to the Austrian Tariff Preference Act) as well as an explanatory note.

In the Austrian Federal Gazette No. 137/1978, issued 16 March 1978, a decree of the Federal Minister of Finance dated 28 February 1978 is published which contains the amendments of the rules of origin of the Austrian scheme of generalized preferences in favour of developing countries. These amendments take into account the changes in the Austrian GSP scheme which entered into force at the beginning of 1978, based primarily upon the changes of the Nomenclature of the Customs Co-operation Council (CCCN) at that date. The amendments can be summarized as follows:

1. changes in Lists A and B of the rules of origin;
2. deletion of some items from, and addition of certain items to these Lists;
3. adoption of a new general rule<sup>1</sup> concerning determination of origin of sets in the sense of the general rule 3 of the CCCN; and
4. a transitional rule concerning recognition of certificates of origin (Form A) as well as of declarations of origin (Form APR) issued still on the basis of the former Nomenclature.

ad 1. and 2. In an Annex to this Notification, consolidated Lists A and B of the Austrian GSP scheme are reproduced, in which new items as well as amended items are marked by underlined CCCN heading numbers.

ad 3. The new general rule concerning determination of sets reads as follows:

"Sets in the sense of the general rule 3 of the CCC Nomenclature shall be regarded as originating when all component articles are originating products. Nevertheless, when a set is composed of originating and non-originating articles, the set as a whole shall be regarded as originating provided that the value of the non-originating articles does not exceed 15 per cent of the total value of the set."

ad 4. Certificates of origin (Form A) and declarations of origin (Form APR) duly established on the basis of the CCCN as in force until December 1977, will be accepted by the Austrian customs authorities if they were issued before 1 January 1979.
