On 1 April 1982, Japan put into force the two-year advanced implementation of Tokyo Round m.f.n. concessions across-the-board (cf. COM.TD/109). At the same time these GSP rates which had been higher than reduced m.f.n. rates were reduced to the level of m.f.n. duties.
