Notifications by Contracting Parties

Addendum

1. Fourteen notifications of restrictions on imports from Hungary were circulated in document L/4836 dated 1 October 1979.

2. The following notifications have been received from Finland, New Zealand, Nigeria, Norway and Japan.

3. Contracting parties which have not yet submitted notifications are invited to do so without delay.

FINLAND

Finland does not apply any discriminatory prohibitions or quantitative restrictions on imports from Hungary.

NEW ZEALAND

New Zealand applies no discriminatory prohibitions or restrictions on imports from Hungary.

NIGERIA

Nigeria maintains no discriminatory or restrictive prohibitions on imports from Hungary.

NORWAY

1. As set out in L/4155/Adds. 1 and 3, Norway and Hungary agree on yearly protocols for the exchange of goods between the two countries. In these protocols the quotas for goods subject to import licensing in Norway - mainly textiles - are stipulated. The quotas as set out in document L/4155/Add.1 have not been altered, with the exception of basket work (ex 46.03) and leadshot cartridges (ex 93.07), which now are subject to liberal licensing. A list of the goods subject to quotas and the actual imports for 1977 and 1978 are shown at Annex 1.

2. The Norwegian system of global import quotas on various textile items introduced 1 January 1979 (ref. document L/4692/Add.1) is also applied to imports from Hungary.

The total imports from Hungary of textile goods in 1977 and 1978 are set out at Annex 2. The figures for the first half of 1979 also include imports under the global quota.
