## RESTRICTIONS ON IMPORTS FROM HUNGARY

### Notifications by Contracting Parties

#### Addendum

1. Fourteen notifications of restrictions on imports from Hungary were circulated in document L/4836, dated 1 October 1979.
2. Five additional notifications were circulated in document L/4836/Add.1, dated 12 October 1979.
3. The following notifications have been received from Austria, Chile, the European Communities, Togo and Yugoslavia.
4. Contracting parties which have not yet submitted notifications are invited to do so without delay.

#### AUSTRIA

Since 1 January 1975 Austria does not apply any discriminatory prohibitions and quantitative restrictions to imports from Hungary.

#### CHILE

Chile's foreign trade policy is oriented toward opening up the economy to international trade without any restrictions or discrimination in regard to products or countries of origin or destination. Consequently, Chile has not applied and is not applying any discriminatory prohibitions or restrictions on imports from Hungary.

#### EUROPEAN COMMUNITIES

The first part of this document (List A) reports various measures taken since the last notification and covered by paragraph 4(a) of the Protocol. The second part (List B) comprises the list of products referred to by paragraph 4(c) of the Protocol of Accession.
